
We have the honour to inform you that the Government of Montenegro and the Government of Barbados have established diplomatic relations as of today, 19 February 2020.

We would be grateful if Your Excellency could have this letter and the Joint Communiqué circulated as a document of the United Nations.



**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
MONTENEGRO
AND
BARBADOS**

The Government of Montenegro and the Government of Barbados,
Guided by the principles enshrined in the Charter of the United Nations,
International Law and the Vienna Convention on Diplomatic Relations dated on
18 April 1961, and being desirous of developing and strengthening relations of
friendship and mutually beneficial cooperation between the two states,


Have decided to establish diplomatic relations at the Ambassadorial level, as of
the date of the signing of this Joint Communiqué.

The Government of Montenegro and the Government of Barbados express their
mutual confidence that establishing diplomatic relations corresponds to the
wishes of both States and will help sustain international peace and security, and
further strengthening of multilateralism.


In witness thereof, the undersigned representatives, duly authorized by their
respective Governments, have signed this Joint Communiqué in the Montenegrin
and English languages, both texts being equally authentic.

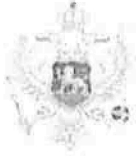

Vlada Crne Gore i Vlada Barbadosa,

Vođene načelima sadržanim u Povelji Ujedinjenih nacija, međunarodnom pravu i Bečkoj konvenciji o diplomatskim odnosima od 18. aprila 1961. godine, i sa željom da razvijaju i unapređuju prijateljske odnose i uzajamno korisnu saradnju između dvije zemlje,


Odlučile su da uspostave diplomatske odnose na nivou ambasadora, od datuma potpisivanja ovog Protokola.


