Organization of the session

A. Work of the session

3. On 5 April 2019, in accordance with Council decision 2005/213, the Commission, immediately following the closure of its fifty-second session, held the first meeting of its fifty-third session for the sole purpose of electing the new officers of the Commission.

4. Pursuant to Council resolution 2020/4 of 4 June 2020 and taking into account the prevailing conditions relating to the coronavirus disease (COVID-19) pandemic on the working arrangements and the available technological and procedural solutions in the interim period, the Commission did not hold additional formal meetings of its fifty-third session.

5. The Commission conducted the remaining business of its fifty-third session through correspondence and informal consultations and considered proposals through a silence procedure pursuant to Council decisions 2020/205 of 3 April, 2020/206 of 22 May and 2020/219 of 24 June $2020.^2$

B. Election of officers

6. At its 1st meeting, on 5 April 2019, the Commission elected Christian Braun (Luxembourg) as Chair and Yuliana Angelova (Bulgaria) as Vice-Chair of the fifty-third session.

7. On ____ July 2020, the Commission elected, pursuant to Council decisions 2020/206 of 22 May and 2020/219 of 24 June 2020, Mariame Fofana (Burkina Faso), Junya Nakano (Japan) and Roshelle Henry (Jamaica) as Vice-Chairs of the fifty-third session and designated the Vice-Chair, Junya Nakano (Japan), to serve concurrently as Rapporteur for the session.³
