## I. INTRODUCTION

1. The Secretary-General has the honour to place before the General Committee, for its consideration, the following observations and proposals in connexion with the report to be made to the General Assembly by the General Committee regarding the organization of the twenty-ninth regular session, the adoption of the agenda and the allocation of items.

## II. ORGANIZATION OF THE SESSION

### Schedule of meetings

2. It is suggested that both plenary and committee meetings should begin at 10.30 a.m. and 3 p.m.; thus, two and a half hours would be available in the morning and three in the afternoon. In this connexion, the General Committee may wish to stress the need for punctuality in opening meetings and to draw the General Assembly's attention to rules 67 and 108 of the rules of procedure (A/520/Rev.12), whereby the President of the General Assembly may declare a meeting open and permit the debate to proceed when at least one third of the members are present, and the Chairman of a Main Committee may declare a meeting open and permit the debate to proceed when at least one quarter of the members are present.

3. It is proposed that a five-day working week should be established, on the understanding that meetings on Saturdays, as well as night meetings, may be scheduled should this prove necessary.

### General debate

4. The General Committee may wish to draw the General Assembly's attention to the following conclusions of the Special Committee on the Rationalization of the Procedures and Organization of the General Assembly which were approved by the Assembly at its twenty-sixth session:

(a) The length of the general debate should not normally exceed two and a half weeks (A/520/Rev.12, annex V, para. 45);

(b) The list of speakers wishing to take part in the general debate should be closed at the end of the third day after the opening of the debate (ibid., para. 46);

(c) Speakers should, as far as possible, avoid putting down their names to speak on a given item and at the same time indicating an alternative meeting if they are unable to keep to their original schedule (ibid., para. 70);

(d) Representatives should speak in the order of their inscription on the list of speakers, on the understanding that those prevented from doing so should normally be moved to the end of the list, unless they have arranged to change places with other representatives (ibid., para. 71).

5. Taking into consideration the conclusions set forth in subparagraphs (a) and (b) of paragraph 4 above, the Secretary-General wishes to suggest that:

(a) The general debate should begin on Monday, 23 September and in view of the increased number of inscriptions on the list of speakers, end on Thursday, 10 October 1974;

(b) The list of speakers wishing to take part in the general debate should be closed on Wednesday, 25 September, at 6 p.m.

#### Right of reply

6. The General Committee may also wish to draw the General Assembly's attention to the recommendation of the Special Committee, which was approved by the Assembly, whereby statements made in the exercise of the right of reply should be delivered, as a general rule, at the end of meetings (*ibid.*, para. 78). Furthermore, the General Committee may wish to recommend, as it did at previous sessions, that delegations should exercise their right of reply at the end of the day whenever two meetings have been scheduled for that day.

7. Following the precedents established by the General Assembly at the five previous sessions, the General Committee may wish to recommend to the Assembly that statements in the exercise of the right of reply should be limited to 10 minutes.

#### Closing date of the session

8. In accordance with the provisions of rule 2 of the rules of procedure and in the light of the recommendation of the Special Committee that the General Assembly should meet for a period of 13 weeks (A/520/Rev.12, annex V, para. 4), the Secretary-General wishes to suggest that the closing date of the twenty-ninth session should be Tuesday, 17 December 1974.

#### Records of the Main Committees

9. The Secretary-General wishes to draw the General Committee's attention to the fact that under rule 58 of the rules of procedure the First Committee shall be provided with verbatim records. That rule also stipulates that no organ of the General Assembly shall have both verbatim and summary records. As previously, the General Committee may therefore wish to recommend that the verbatim records should be the official records of the First Committee and the summary records should remain the official records of all other Main Committees. In this connexion, the General Committee should also make a recommendation to the General Assembly as to whether the option that has traditionally been approved for the Special Political Committee to obtain, on specific request, transcriptions of the debates of some of its

meetings, or portions thereof, should be maintained for the twenty-ninth session. Furthermore, the General Committee may wish to draw the General Assembly's attention to paragraph 10 (e) of its resolution 2538 (XXIV) of 11 December 1969 which reads as follows:

"Speeches or statements by representatives, by the Secretary-General or his representative, or by persons presenting reports on behalf of committees or other bodies, may be reproduced in extenso in summary records or as official documents only if they serve as bases for discussion, provided that the relevant decision is taken by the body concerned after a statement of the financial implications has been submitted in accordance with regulation 13.1 of the Financial Regulations of the United Nations."

#### Seating arrangements

10. In accordance with the established practice, the Secretary-General has caused lots to be drawn for the purpose of choosing the Member to occupy the first desk on the Assembly floor from which the alphabetical seating order will begin. The name drawn was Iraq. Consequently, the delegation of that country will sit at the first desk at the right of the President and the other countries will follow in the English alphabetical order. The same order will be observed in the Main Committees.

#### Use of the General Assembly Hall by the Main Committees

11. In addition to the General Assembly Hall, only five conference rooms (Conference Rooms 1 to 4 and the Trusteeship Council Chamber) can accommodate the membership of the Organization, making it possible to hold no more than six meetings simultaneously. All the Main Committees should, therefore, make full use of the General Assembly Hall when no plenary meeting is being held.

#### Mechanical means of voting

12. The Secretary-General wishes to suggest that the Main Committees make full use, on a rotating basis, of the mechanical means of voting available in both the General Assembly Hall and Conference Room 3.

#### Interpretation facilities

13. The existing interpretation facilities consist of six channels (one for the "floor", i.e. the language used by the speaker, and five for the interpretation booths). As a result of the adoption of resolution 3190 (XXVIII) of 18 December 1973, by which the General Assembly decided to include Arabic among the official and the working languages of the Assembly and its Main Committees, seven channels will be needed (one for the "floor" and six for the interpretation booths). The Secretariat has made every effort to carry out the necessary

alteration work in time for the twenty-ninth session of the General Assembly so that the new facilities might be available in the General Assembly Hall, in the Trusteeship Council Chamber and in conference rooms 1, 2, 3 and 4. Installation work is now proceeding in the General Assembly Hall and it is anticipated that the work will be completed by the opening of the session and that the Hall will be equipped with the seven channels. Owing to the non-delivery of material and the relatively short time available, it has not been possible to complete the full conversion of the remaining five rooms. It has been possible, however, to complete the booth facilities in those rooms so that Arabic may be heard on the "floor" channel. Therefore, whenever a working language is used by a representative, his speech will be interpreted into the other five working languages and heard in all the languages on the existing six channels. Should a representative use a language other than the working languages, the original speech would be carried on the loud speaker system and the interpretation into all the working languages would be heard on the existing six channels.

#### Financial implications of draft resolutions

14. The Secretary-General would like to draw the attention of the General Committee to rule 153 of the rules of procedure which reads as follows:

"No resolution involving expenditure shall be recommended by a committee for approval by the General Assembly unless it is accompanied by an estimate of expenditures prepared by the Secretary-General. No resolution in respect of which expenditures are anticipated by the Secretary-General shall be voted by the General Assembly until the Administrative and Budgetary Committee (Fifth Committee) has had an opportunity of stating the effect of the proposal upon the budget estimates of the United Nations."

In this connexion the General Committee may wish to recommend that the General Assembly should draw the attention of the Main Committees to the need for allowing sufficient time for the preparation of the estimate of expenditures by the Secretariat and for its consideration by the Advisory Committee on Administrative and Budgetary Questions and by the Fifth Committee.

#### Reports of the Main Committees

15. The General Committee may also wish to recommend that the General Assembly should draw the attention of the Main Committees to Assembly resolution 2292 (XXII), which was reaffirmed by the Special Committee (*ibid.*, para. 43), whereby the reports of the Main Committees should be as concise as possible and, save in exceptional cases, should not contain a summary of the debates.

III. ADOPTION OF THE AGENDA

16. All proposals for the inclusion of items in the agenda of the twenty-ninth session have been communicated to Member States in the following documents:

- (a) Provisional agenda of the twenty-ninth session (A/9700);
- (b) Supplementary list of items (A/9710);
- (c) Request for the inclusion of an additional item (A/9741 and Add.1 to 3).

The items proposed for inclusion are listed in the draft agenda, which appears in paragraph 19 below.

17. In connexion with item 12 of the draft agenda (Report of the Economic and Social Council), the Secretary-General wishes to draw the attention of the General Committee to a number of reports which the General Assembly specifically requested or which the Economic and Social Council decided to transmit to the Assembly. These reports, which will be considered under item 12, deal with the following questions:

Furthermore, in accordance with a decision taken at the 2203rd plenary meeting, on 17 December 1973, the General Assembly will be called upon to consider the draft resolution entitled "Measures to improve the organization of the work of the Council", recommended by the Economic and Social Council in its resolution 1622 (LI) of 30 July 1971, and the amendments submitted thereto during the consideration of the draft resolution by the Second Committee (A/C.2/289). Also in connexion with item 12, it should be noted that the General Assembly, at its 2206th plenary meeting, on 18 December 1973, requested the Secretary-General to submit to the Economic and Social Council at its fifty-sixth session a report on the organization of the Department of Economic and Social Affairs and asked that the report, together with the views and recommendations of the Council relating thereto, be submitted for consideration by the Assembly at its twenty-ninth session. The report of the Secretary-General was submitted to the Economic and Social Council (E/5459). By decision 22 (LVI) of 17 May 1974, the Council decided to postpone consideration of the matter to its fifty-eighth session to held in 1975.

18. In connexion with item 85 (Financing of the United Nations Emergency Force), the General Committee, taking into account resolution 350 (1974) of 31 May 1974 by which the Security Council decided to set up the United Nations Disengagement Observer Force, may wish to recommend that this item be reworded to read as follows:

"Financing of the United Nations Emergency Force and of the United Nations Disengagement Observer Force: report of the Secretary-General."

IV. ALLOCATION OF ITEMS

23. With regard to item 23 (Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples), the General Committee may wish to consider referring to the Fourth Committee, as was done at previous sessions, all the chapters of the report of the Special Committee (A/9623 and Add.1 to 7) relating to specific Territories. This would again enable the General Assembly to deal in plenary meetings with the question of the implementation of the Declaration as a whole.

24. With regard to item 36 (General and complete disarmament), the Secretary-General wishes to draw the attention of the General Committee to the fact that some portions of the annual report of the International Atomic Energy Agency (A/9722), which is to be considered directly in plenary meeting under item 15, deal with the subject-matter of this item. The General Committee may therefore wish to recommend that the relevant paragraphs of the report should be drawn to the attention of the First Committee in connexion with its consideration of item 36.

25. In connexion with item 74 (Programme budget for the biennium 1974-1975), the General Committee may wish to recommend, in accordance with the decision taken by the General Assembly at its 2192nd plenary meeting, on 6 December 1973, 8/ that the views of the Second Committee on the report of the Secretary-General relating to the separate preparation and submission of the programme and budget of the United Nations Industrial Development Organization and to the administrative autonomy for that organization should be available to the Fifth Committee before its consideration of that matter.

26. In connexion with item 87 (Report of the Special Committee on the Question of Defining Aggression), the Secretary-General draws the attention of the General Committee to the fact that at its 1974 session the Special Committee adopted by consensus a draft definition of aggression and decided to recommend it for adoption by the General Assembly at its present session. 9/ In that respect, the Secretary-General wishes to recall that at its twelfth session the General Assembly decided, under resolution 1186 (XII) of 11 December 1957, to defer consideration of the question of the draft Code of Offences against the Peace and Security of Mankind 10/ until such time as the Assembly took up again the question of defining aggression and, under resolution 1187 (XII) of the same date, to defer consideration of the question of an international criminal jurisdiction 11/ until such time as the Assembly took up again the question of defining aggression and the question of a draft Code of Offences against the Peace and Security of Mankind. The Secretary-General also wishes to recall that at the twenty-third session, further to the adoption by the General Assembly of resolution 2330 (XXII) of 18 December 1967 which established the Special Committee on the Question of Defining Aggression, the General Committee examined the question of the inclusion in the agenda, in the light of resolutions 1186 (XII) and 1187 (XII), of the two items referred to above. The General Committee decided that it was not desirable at that stage, prior to the completion of the General Assembly's consideration of the question of defining aggression, for the two items in question to be included in the Assembly's agenda and that those items should be taken up only at a later stage when further

progress had been made in arriving at a generally agreed definition of aggression. 12/ At its 1676th plenary meeting, on 27 September 1968, the General Assembly took note of that decision. Now that a draft definition of aggression has been submitted to the General Assembly, the General Committee may wish to consider whether, as envisaged in resolutions 1186 (XII) and 1187(XII) and in the decision taken at the twenty-third session, the Assembly should take up again the question of a draft Code of Offences against the Peace and Security of Mankind and the question of an international criminal jurisdiction.

27. Furthermore, the Secretary-General wishes to draw the attention of the General Committee to the following recommendation of the Special Committee on the Rationalization of the Procedures and Organization of the General Assembly, which was approved by the Assembly at its twenty-sixth session:

"The Special Committee, reaffirming the major role which must be played by the Special Political Committee and recognizing further that the agenda of that Committee is relatively light, recommends that the General Assembly should consider transferring to the Special Political Committee one or two items usually considered by other Committees with a view to ensuring a better division of work among the Main Committees /A/520/Rev.12, annex V, para. 34/."

Since the agenda of the Special Political Committee continues to be relatively light, the General Committee may wish to consider recommending to the General Assembly the transfer of one or more items to that Committee.

28. Subject to the recommendations of the General Committee regarding the adoption of the draft agenda and the considerations set forth in paragraphs 22 to 27 above, the Secretary-General suggests to the Committee the following allocation of agenda items: 13/
