ORGANIZATION OF WORK

Note by the Chairman

1. The Chairman at the 626th meeting made suggestions regarding the procedure to be followed for the discussion of draft resolutions submitted under items 12 and 30. In the light of the comments and suggestions made by members of the Committee, the Chairman is proposing the following:

(a) Allocation of Time

One meeting would be devoted to each resolution and, if the discussion of the draft resolution concerned cannot be completed at that meeting, it would be possible either (i) to postpone its consideration to a later meeting which might not be fully utilized for the draft resolution to which that meeting had been assigned, or (ii) to have a meeting in addition to those provided in our time-table (see paragraph 2, below).

(b) Grouping of resolutions

It was proposed that the draft resolutions contained in documents A/C.2/L.429, L.436 and L.437 be discussed at three consecutive meetings. Delegations should feel free to offer their comments on these resolutions separately or together.

(c) Amendments

Amendments should be submitted as far as possible in advance of the discussion of the draft resolution and the Chairman intends to ask the sponsors of amendments to present them at the beginning of the meeting devoted to the resolution concerned.

(d) Voting

The voting should take place after completion of the discussion of a draft resolution or of a group of draft resolutions.

2. Taking account of the various suggestions made by members of the Committee, the Chairman proposes the following time-table:<sup>1/</sup>
