#### 1. Opening of the Meeting

The Meeting will be inaugurated by a dignitary from the Government of Thailand, with the Executive Secretary of ESCAP and a dignitary of the Government of Japan welcoming the delegation. Keynote addresses will be delivered by prominent speakers from the region.

#### 2. Election of officers

A chairperson, two vice-chairpersons and a rapporteur will be elected.

#### 3. Adoption of the agenda

The provisional agenda will be considered and adopted by the Meeting.

4. Review of progress made and challenges faced in the implementation of the Biwako Millennium Framework for Action towards an Inclusive, Barrier-free and Rights-based Society for Persons with Disabilities in Asia and the Pacific, 2003-2012

The Meeting will consider the achievements and challenges regarding the implementation of the Biwako Millennium Framework for Action. The Meeting will have before it the following documents:

## 5. Rights-based development for all: the Biwako Millennium Framework for Action and its convergence with the Convention on the Rights of Persons with Disabilities and the Millennium Development Goals

The Meeting will consider the comparison between the Biwako Millennium Framework for Action with the two international instruments: the International Convention on the Rights of Persons with Disabilities and the Millennium Development Goals. The Meeting will have before it the following documents:
