Status of implementation of the Intergovernmental Agreement on the Asian Highway Network (E/ESCAP/AHWG(5)/1)

Annotation

The meeting will be informed of the obligations of the Parties to the Agreement and the current status of implementation with respect to: (a) accession, signature and ratifications; (b) conformity to classification and design standards; (c) Asian Highway route signs; and (d) status of road safety on the Asian Highway. Member States may wish to update the Working Group on: (a) progress towards accession, ratification, acceptance or approval of the Agreement; (b) progress in and plans for upgrading of Asian Highway routes; (c) their plans for and progress in placing Asian Highway route signs; and (d) progress in and plans for improving road safety on the Asian Highway.

Policies and issues relating to the development of the Asian Highway (E/ESCAP/AHWG(5)/3)

Annotation

The Working Group will be informed of the work of member States and the secretariat in promoting and developing the Asian Highway, improving road safety and road transport, promoting intermodal linkages through the development of dry ports and considering important issues and policies on sustainable and inclusive development relevant to the further development of the Asian Highway. The Working Group may consider policies and approaches for developing the Asian Highway, promoting investment in the Asian Highway, improving road safety and promoting dry ports and other interfaces along Asian Highway routes in support of more sustainable and inclusive development in the region.

The meeting may raise any other matter not covered under the items mentioned above.

8. Adoption of the report

The meeting will adopt major conclusions and recommendations of the fifth meeting of the Working Group on the Asian Highway.
