

Annotation

The meeting will review the progress made in the Asia-Pacific region towards the implementation of the Programme of Action of the International Conference on Population and Development, the key actions for its further implementation and the recommendations of the Asian and Pacific Ministerial Declaration on Population and Development.

As a basis for its deliberations, the meeting will have before it a note by the secretariat that provides a summary of major demographic trends in the Asia-Pacific region, challenges and lessons learned regarding the implementation of the review documents, and the results of the national reports that have been conducted in preparation for the review (ESCAP/APPC/2018/1).

Meeting participants may wish to share their experiences, lessons learned and gaps in implementing the Programme of Action, the key actions for its further implementation and the recommendations of the Asian and Pacific Ministerial Declaration on Population and Development. The review and presentations should be conducted in the context of the achievement of the 2030 Agenda for Sustainable Development.

The deliberations under this agenda item are expected to result in an enhanced understanding of good practices, regional priorities and challenges associated with the implementation of the Programme of Action, the key actions for its further implementation and the recommendations of the Asian and Pacific Ministerial Declaration on Population and Development.

3. Thematic discussion on emerging issues and gaps in the implementation of the Programme of Action of the International Conference on Population and Development, the key actions for its further implementation and the recommendations of the Asian and Pacific Ministerial Declaration on Population and Development

The meeting will review emerging issues and identify areas for further attention to provide recommendations to accelerate the implementation of the Programme of Action, the key actions for its further implementation and the recommendations of the of Asian and Pacific Ministerial Declaration on Population and Development through moderated panel discussions followed by an open discussion with members and associate members.

(a) Population dynamics and inequality in Asia and the Pacific

Annotation

The meeting will review progress in the Asia-Pacific region regarding linkages between population dynamics and inequalities and how these linkages affect and are affected by megatrends in the region, such as population ageing, international migration and urbanization.

As a basis for its deliberations, the meeting will have before it a note by the secretariat that provides an overview of key dimensions of inequality in the region and how these interact with and are driven and reinforced by key demographic megatrends (ESCAP/APPC/2018/2). Recommendations for consideration by the meeting are also highlighted in the note.

(b) Advancing gender equality and universal access to sexual and reproductive health and reproductive rights

Advancing gender equality and universal access to sexual and reproductive health and reproductive rights (ESCAP/APPC/2018/3)

Annotation

The meeting will review progress with regard to advancing sexual and reproductive health and reproductive rights, with a particular focus on the gender dimensions.

As a basis for its deliberations, the meeting will have before it a note by the secretariat outlining key trends in health and well-being, with a focus on women, including sexual and reproductive health and reproductive rights in the Asia-Pacific region (ESCAP/APPC/2018/3). Recommendations for consideration by the meeting are also highlighted in the note.

(c) Population dynamics, vulnerable groups and resilience to climate change and disasters

Population dynamics, vulnerable groups and resilience to climate change and disasters (ESCAP/APPC/2018/4)

Annotation

The meeting will review progress with regard to addressing the nexus of population and sustainable development with a focus on the environmental perspective.

As a basis for its deliberations, the meeting will have before it a note by the secretariat focusing on the nexus of population and sustainable development with an emphasis on the interrelationships between population, environment and sustainable development (ESCAP/APPC/2018/4). In particular, there will be a discussion of the relation between population dynamics, and climate change and natural disasters. A gender and healthrelated perspective will inform the note, which will contain recommendations for consideration by member States.
