The session will begin with a panel discussion, followed by a plenary debate.

Report of the Regional Preparatory Meeting for the Ministerial Conference on Civil Registration and Vital Statistics in Asia and the Pacific (E/ESCAP/MCCRVS/3)

Annotation

The senior officials will review the draft ministerial declaration to "Get every one in the picture" in Asia and the Pacific. The ministerial declaration is intended to be a pioneering instrument expressing the commitment of ministers to fulfil a shared vision that, by 2024, all people in Asia and the Pacific will benefit from universal and responsive civil registration and vital statistics systems that facilitate the realization of their rights and support good governance, health and development. In order to achieve that shared vision, the ministerial declaration will proclaim the "Asian and Pacific Civil Registration and Vital Statistics Decade, 2015-2024".

The ministerial declaration emerged from deliberations of the Regional Steering Group for Civil Registration and Vital Statistics in Asia and the Pacific, which comprises high-level representatives of Governments and development partners from across the region and the civil registration, health and statistics sectors. The preliminary draft of the ministerial declaration was reviewed by government experts at the Regional Preparatory Meeting for the Ministerial Conference on Civil Registration and Vital Statistics in Asia and the Pacific (Bangkok, 28-29 August 2014). The present draft ministerial declaration under consideration incorporates certain revisions agreed at the Meeting.

It is expected that, under this agenda item, the draft ministerial declaration will be endorsed by the senior officials for later submission to the ministers and possible adoption.

4. Implementation of the regional action framework on civil registration and vital statistics in Asia and the Pacific

Annotation

Under this agenda item, the senior officials are invited to make concise statements to share their country's perspectives and priorities for the implementation of the regional action framework on civil registration and vital statistics in Asia and the Pacific. Statements should focus on plans for setting targets, approaches to carrying out the implementation steps that are set out in the regional action framework, and the need for and likely results of support from international development partners.

The senior officials may also wish to share their views on the long-term regional governance structure that is outlined in the regional action framework, and make specific recommendations on the draft revised terms of reference for the Regional Steering Group for Civil Registration and Vital Statistics in Asia and the Pacific. The terms of reference will be considered by the Committee on Statistics at its fourth session with a view to possible endorsement by the Commission at its seventy-first session.

The landmark regional action framework has been designed to accelerate and focus the efforts of Governments and development partners to improve civil registration and vital statistics in Asia and the Pacific. The regional action framework contains key principles, regional goals, national targets individually set by Governments, action areas and implementation steps. The regional action framework also outlines a regional governance structure for its implementation.

The regional action framework was developed by the Regional Steering Group for Civil Registration and Vital Statistics in Asia and the Pacific. The zero draft of the regional action framework was distributed to Governments and development partners for consultations between April and June 2014, and the preliminary draft was developed based on the feedback received. The preliminary draft of the regional action framework was reviewed by government experts at the Regional Preparatory Meeting for the Ministerial Conference on Civil Registration and Vital Statistics in Asia and the Pacific. The Meeting noted that the regional action framework was of a technical nature and had already been the subject, since April 2014, of extensive consultations with member States, and therefore recommended it to be submitted to the Conference for consideration and possible endorsement without further revision.

Annotation

Under this agenda item, ministers and heads of delegations will be invited to deliver short statements to highlight policy priorities for the "Asian and Pacific Civil Registration and Vital Statistics Decade, 2015-2024", and their expectations as regards regional collaboration to improve civil registration and vital statistics. Ministers and heads of delegations may also wish to share their countries' achievements and challenges in the area of civil registration and vital statistics.

As part of their countries' commitments to implementing the regional action framework, ministers and heads of delegations are also invited to announce their national targets to be achieved by the conclusion of the Decade in 2024.

A joint statement will be delivered on behalf of the regional partnership of international organizations supporting countries in their implementation of the regional action framework. Representatives of development partners may also be afforded the opportunity to make brief statements on specific issues related to the improvement of civil registration and vital statistics.

A consolidated statement will be delivered by a representative of civil society, conveying the recommendations of civil society organizations for the attention of the Conference. These recommendations will be based on the outcome of the Civil Society Forum on Civil Registration and Vital Statistics in Asia and the Pacific, which will be held in Bangkok on 26 and 27 August 2014.
