Transformation for sustainable development in Asia and the Pacific: review of emerging regional trends and agenda-setting (E/ESCAP/CED(4)/1)

Annotation

In the final draft of the outcome document for the United Nations Sustainable Development Summit, to be held in New York from 25 to 27 September 2015, the interlinkages within and the integrated nature of sustainable development is recognized. On the basis of this integrated perspective, in the proposed sustainable development agenda, the political

commitment to address the persistent challenges related to sustainable development for all, in particular in developing countries, is reaffirmed. Also emphasized is the strategic role of the regional commissions in promoting regional cooperation for effective implementation of the proposed sustainable development goals by promoting a balanced integration of the economic, social and environmental dimensions of sustainable development, forging a regional voice on the global agenda, facilitating multi-stakeholder partnerships and supporting South-South cooperation. In this context, a regional roadmap could be facilitated by regional commissions. Such a road map could address the means of implementation, the strengthening of institutional frameworks and the capacity for integration of the abovementioned three dimensions, as well as the establishment of a platform for policy dialogue and the exchange of best practices. Supported by a research agenda, such a road map could provide important guidance to member States in the implementation of the proposed agenda.

In support of the regional implementation of the sustainable development goals, in document E/ESCAP/CED(4)/1, the secretariat provides an overview of emerging and persistent trends and issues in areas of critical importance to the Asian and Pacific region, in particular in relation to environmental sustainability, climate change mitigation and adaptation, energy security, water resource management and sustainable urban development. Forward-looking strategies are also presented in response to the current and projected challenges in the regional implementation of the proposed sustainable development agenda. In the context of the secretariat's continued commitment to supporting dialogue among member States, the document also provides an outline of priority actions on regional agenda-setting vis-à-vis the proposed agenda.

Annotation

During the session, the secretariat will present the key outcomes of the first session of the Asia-Pacific Forum on Sustainable Development, held in Pattaya, Thailand from 19 to 21 May 2014, and the second session of the Asia-Pacific Forum on Sustainable Development, held in Bangkok on 21 and 22 May 2015.

The secretariat will provide information on the key outcomes from the sixth Asia-Pacific Urban Forum, which will be held back-to-back with the High-level Regional Preparatory Meeting to Habitat III for Asia-Pacific in Indonesia from 19 to 22 October 2015.

The secretariat will also present key conclusions and recommendations of the 2014 policy dialogue on energy for sustainable development in Asia and the Pacific, which was held in Bangkok from 26 to 28 November 2014, and the joint statement of the Executive Secretaries of the United Nations Regional Commissions released at the Fifth International Forum on Energy for Sustainable Development, held in Hammamet, Tunisia from 4 to 7 November 2014.

The Committee may wish to review the documents and provide its guidance.
