Seventy-fifth session First Committee

Allocation of agenda items to the First Committee

Note by the Secretariat

1. At the 2nd plenary meeting of its seventy-fifth session, held on 18 September 2020, the General Assembly took decisions pertaining to the allocation of agenda items (see A/75/252), including to the First Committee (see annex).
