The meeting was reconvened at 3.20 p.m.

Election, in accordance with articles 28 to 32 of the International Covenant on Civil and Political Rights, of nine members of the Human Rights Committee to replace those members whose terms would expire on 31 December 2020 (*continued*) (CCPR/SP/93 and CCPR/SP/93/Add.1)

Election, in accordance with articles 28 to 34 of the International Covenant on Civil and Political Rights, to fill a vacancy in the Human Rights Committee for the remainder of a term expiring on 31 December 2020 (*continued*) (CCPR/SP/93 and CCPR/SP/93/Add.1)

1. The Chair recalled that, at the morning meeting, seven candidates had been elected to replace members of the Human Rights Committee whose terms were due to expire on 31 December 2020 and one candidate had been elected to replace a member of the Committee who had resigned with effect from 31 December 2019. In accordance with rule 15 of the rules of procedure, she invited the Meeting to elect one more member of the Human Rights Committee in a second ballot restricted to those candidates who had obtained the largest number of votes in the first ballot without having obtained the required majority, to a number not exceeding twice the number of places remaining to be filled.

2. A vote was taken by secret ballot.
