### **Appointments to fill vacancies in subsidiary organs and other appointments: appointment of members of the International Civil Service Commission**

#### **Report of the Fifth Committee**

*Rapporteur:* Mr. Tsu Tang Terrence **Teo** (Singapore)

1. At its 2nd plenary meeting, on 18 September 2020, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-fifth session the item entitled “Appointments to fill vacancies in subsidiary organs and other appointments: appointment of members of the International Civil Service Commission” and to allocate it to the Fifth Committee.
2. At its 5th meeting, on 6 November 2020, the Fifth Committee had before it the following documents:
  - (a) Note by the Secretary-General concerning the vacancies in the membership of the International Civil Service Commission that would occur as a result of the expiration of the terms of office of five of its members on 31 December 2020 ([A/75/104](#));
  - (b) Note by the Secretary-General containing the names of five persons nominated by their respective Governments for appointment or reappointment to the International Civil Service Commission to fill the following vacancies: two members from the African States, two members from the Asia-Pacific States and one member from the Eastern European States, for a four-year term of office beginning on 1 January 2021 ([A/C.5/75/7](#)).
3. At the same meeting, the Committee decided, by acclamation, to recommend to the General Assembly that it appoint or reappoint Larbi Djacta (Algeria), Igor Golubovskiy (Russian Federation), Pan-Suk Kim (Republic of Korea), Wang Xiaochu (China) and El Hassane Zahid (Morocco) as members of the International Civil Service Commission for a four-year term of office beginning on 1 January 2021 (see para. 5).
4. Also at the same meeting, the Chair drew the attention of the Committee to General Assembly decision 73/407 of 15 November 2018, by which the Assembly designated Larbi Djacta (Algeria) as Chair of the International Civil Service

Commission for a four-year term of office beginning on 1 January 2019, and noted that, with the reappointment of Mr. Djacta for a four-year term of office beginning on 1 January 2021, it was the understanding of the Committee that he would continue to serve as Chair of the Commission until 31 December 2022.

### **Recommendation of the Fifth Committee**

5. The Fifth Committee recommends that the General Assembly appoint the following persons as members of the International Civil Service Commission for a four-year term of office beginning on 1 January 2021:

Larbi Djacta (Algeria)  
Igor Golubovskiy (Russian Federation)  
Pan-Suk Kim (Republic of Korea)  
Wang Xiaochu (China)  
El Hassane Zahid (Morocco)
