

## Promotion and protection of human rights

### Report of the Third Committee\*

Rapporteur: Ms. Myriam Oehri (Liechtenstein)

- 1. At its 2nd plenary meeting, on 18 September 2020, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-fifth session the item entitled:
  - "Promotion and protection of human rights:
  - "(a) Implementation of human rights instruments;
  - "(b) Human rights questions, including alternative approaches for improving the effective enjoyment of human rights and fundamental freedoms;
  - "(c) Human rights situations and reports of special rapporteurs and representatives;
  - "(d) Comprehensive implementation of and follow-up to the Vienna Declaration and Programme of Action"

and to allocate it to the Third Committee.

- 2. An account of the Committee's consideration of the sub-items is contained in the addenda to the present report. Attention is also drawn to the general debate held by the Committee at its 1st to 6th meetings, from 5 to 8 October. 1
- 3. The Committee, pursuant to the organization of work adopted at its 1st meeting, held on 5 October, and taking into account the prevailing conditions relating to the coronavirus disease (COVID-19) on the working arrangements for its seventy-fifth session and the available technological and procedural solutions in the interim period, convened 20 virtual informal meetings to hear introductory statements and hold interactive dialogues on the item and its sub-items 72 (a), entitled "Implementation
