

The Russian representative office of the Russian and Turkish Joint Commission reviewing issues related to violations of the ceasefire regime has reported 38 incidents of gunfire (33 incidents according to Syrian data) in the following Governorates: 22 in Idlib, 7 in Hama, 5 in Aleppo and 4 in Ladhiqiyah.

The Turkish representative office has reported 12 incidents of gunfire. None have been confirmed by the Russian representative office.

Provision of humanitarian aid to the population of the Syrian Arab Republic

The Centre for Reconciliation of Opposing Sides and Refugee Migration Monitoring has not carried out any humanitarian operations over the past 24 hours.
