The meeting was called to order at 4 p.m.

Agenda item 4: Election of the members of the Committee on the Rights of Persons with Disabilities (*continued*) (CRPD/CSP/2020/CRP.1 and CRPD/CSP/2020/CRP.1/Add.1)

1. **The President** invited the Conference to continue its election, by secret ballot, of nine candidates to replace members of the Committee on the Rights of Persons with Disabilities whose terms were due to expire on 31 December 2020. As four vacancies remained to be filled, a second round of voting would be held, restricted to the eight candidates who had received the largest number of votes while not obtaining the required majority.

2. *At the invitation of the President, Mr. Falzeta Zanini (Brazil), Ms. Hettiwelige (Sri Lanka), Ms. Lombeh (Liberia), Ms. Sass (Hungary), Ms. Staunton (Ireland) and Ms. Wang (Singapore) acted as tellers.*

3. *A vote was taken by secret ballot.*
