## **Extensions of country programmes**

Summary

The present note contains information on the extensions of UNFPA country programmes. First-time extensions of country programmes up to one year are approved by the Executive Director, and presented to the Executive Board for information. All other requests for extensions of country programmes are submitted to the Executive Board for approval.

The Executive Board may wish to take note of the first one-year extensions of the country programmes for Bangladesh, Guinea Bissau, Maldives and Tanzania, as presented in table 1, and may wish to approve the second one-year extensions for Guatemala and Venezuela, and the fourth, six-month extension for the Syrian Arab Republic, as presented in table 2.
