**Identical letters dated 8 March 2021 from the Permanent
Representative of Lebanon to the United Nations addressed to the
Secretary-General and the President of the Security Council**

On instructions from the Lebanese Government, I should like to inform you that following investigations into the allegations made by Israel that Lebanon violated Security Council resolution [1701 \(2006\)](#), it was determined that the United Nations Interim Force in Lebanon (UNIFIL) had been unable to confirm the vast majority of the allegations and that the Lebanese Army had been unable to confirm any of the allegations (see annex).* Accordingly, those allegations are an attempt to make it appear that Lebanon has violated the provisions of resolution [1701 \(2006\)](#) and to cover up the land, sea and air violations committed by Israel and its repeated attacks against the sovereignty of Lebanon.

I should be grateful if you would have the present letter and its annex issued as a document of the General Assembly, under agenda item 37, and of the Security Council.
