مذكرة شفوية مؤرخة 15 أيار/مايو 2020 موجهة إلى رئيس اللجنة من البعثة الدائمة  
لألمانيا لدى الأمم المتحدة

تقدم البعثة الدائمة لألمانيا لدى الأمم المتحدة تحياتها إلى رئيس لجنة مجلس الأمن المنشأة عملاً بالقرار 1540 (2004)، وبالإشارة إلى قرارات مجلس الأمن 1540 (2004) و 1673 (2006) و 1810 (2008) و 1977 (2011) و 2055 (2012) و 2325 (2016)، يشرفها أن تقدم معلومات عن تنفيذها على الصعيد الوطني للأحكام المنبثقة عن القرارات المذكورة أعلاه (انظر المرفق).

وقد أودعت ألمانيا، منذ آخر مذكرة قدمتها، بروتوكول عام 2005 الملحق باتفاقية قمع الأعمال غير المشروعة الموجهة ضد سلامة الملاحة البحرية، وبروتوكول عام 2005 الملحق لبروتوكول قمع الأعمال غير المشروعة الموجهة ضد سلامة المنشآت الثابتة الموجودة على الجرف القاري، واتفاقية قمع الأفعال غير المشروعة المتعلقة بالطيران المدني الدولي لعام 2010.

وجرى تنقيح قانون الحماية من الإشعاع في عام 2018، استناداً إلى الأمر التوجيهي الصادر عن المجلس الأوروبي (الجماعة الأوروبية للطاقة الذرية) رقم 59/2013. وترد جميع التغييرات في المصفوفة المرفقة<sup>(1)</sup>، التي تشكل تقرير التنفيذ الوطني المنقح لألمانيا. وتتضمن المصفوفة أموراً منها التغييرات ذات الصلة في تشريعات الاتحاد الأوروبي، مثل اللائحة (الاتحاد الأوروبي) رقم 2013/952 (القانون الجمركي للاتحاد) والأمر التوجيهي (الاتحاد الأوروبي) 2015/849 للبرلمان الأوروبي والمجلس بشأن منع استخدام النظام المالي لأغراض غسل الأموال أو تمويل الإرهاب والقانونين الألمانيين الناقلين لهما والصادرين في 24 حزيران/يونيه 2017 و 12 كانون الأول/ديسمبر 2019.

## Implementation matrix

The information in the matrices originates primarily from national reports and is complemented by official government information, including that made available to intergovernmental organizations. The matrices are prepared under the direction of the Security Council Committee established pursuant to resolution 1540 (2004).

The Committee intends to use the matrices as a reference tool for facilitating technical assistance and to enable the Committee to continue to enhance its dialogue with States on their implementation of resolution 1540 (2004).

The matrices are not a tool for measuring compliance of States with their non-proliferation obligations but for facilitating the implementation of resolutions 1540 (2004), 1673 (2006), 1810 (2008), 1977 (2011), 2055 (2012) and 2325 (2016). They do not reflect or prejudice any ongoing discussions outside the Committee, in the Security Council or any of its organs of a State's compliance with its non-proliferation or any other obligations. Information on voluntary commitments is for reporting purpose only and does not constitute in any way a legal obligation arising from resolution 1540 (2004) or its successive resolutions.

Matrix entries are only indicators of fact and not indicators of the degree of compliance under resolution 1540 (2004) and its successor resolutions.

An "X" in any data field signifies only that the Committee considers that a State has taken the steps required and/or has provided specific references to the applicable legal basis or executive behaviour as evidence of such steps. An "X" against any data field does not necessarily signify that a State has met in full its obligations for that data field.

A "?" in any data field signifies that the references to legislative or other measures may not be directly relevant or are incomplete.

A "N/A" (not applicable) in any data field signifies that the data field is not applicable to a State that, through legally binding instruments, specified that it did not possess related materials or facilities.

A blank in any data field signifies that there is insufficient information available to enter an "X" or "?" against a particular data field
