APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS

CONFIRMATION OF THE APPOINTMENT OF THREE MEMBERS OF THE INVESTMENTS COMMITTEE

## Note by the Secretary-General

1. In accordance with the provisions of article 20 of the regulations of the United Nations Joint Staff Pension Fund, the Secretary-General, after consultation with the United Nations Joint Staff Pension Board and the Advisory Committee on Administrative and Budgetary Questions, submits for confirmation by the General Assembly the following appointments as members of the United Nations Investments Committee.

## For three-year terms, from 1 January 1983

Messrs. Aloysio de Andrade Faria (reappointment), Braj Kumar Nehru (reappointment) and Stanislaw Raczkowski (reappointment).

- 2. Mr. Faria was first appointed to the Committee in 1976, Mr. Nehru has served on the Committee since 1962 and has been Chairman since 1977, and Mr. Raczkowski has served since 1977. The Secretary-General very much appreciates their willingness to continue to carry on this important international public service.
- 3. The advice of the Investments Committee has been invaluable to the Secretary-General and to his staff in carrying out their responsibilities for the investment of the assets of the United Nations Joint Staff Pension Fund. As the Secretary-General has stated to the United Nations Joint Staff Pension Board and the Advisory Committee, he draws in addition upon such specialized expertise as may be advisable, having in mind the investments of the Fund.

- 4. In order to provide for continuity in the membership of the Investments Committee, the terms of the members have been staggered. If the General Assembly confirms the proposed appointments, the United Nations Investments Committee would consist of the following members:
  - Mr. David Montagu, Mr. Yves Oltramare and Mr. Emmanuel Noi Omaboe, whose terms of office expire on 31 December 1983.
  - Mr. Jean Guyot, Mr. George Johnston and Mr. Michiya Matsukawa, whose terms of office expire on 31 December 1984.
  - Mr. Aloysio de Andrade Faria, Mr. B. K. Nehru and Mr. Stanislaw Raczkowski, whose terms of office will expire on 31 December 1985.
- 5. The curricula vitae for the appointees being submitted for confirmation are attached for the information of the General Assembly.
