Desirous to promote and strengthen friendship and cooperation between the two countries on the basis of equality, mutual respect for each other's sovereignty, independence and territorial integrity as well as non-interference in the internal affairs of each other,

Guided by the principles and purpose of the Charter of the United Nations, as well as the Vienna Convention on Diplomatic Relations of 1961 and the Vienna Convention on Consular Relations of 1963;

Have agreed to establish diplomatic relations, as of the date of signature of this Joint Communique;

In witness whereof, the undersigned Permanent Representatives, duly authorized by their respective Governments, have signed this Joint Communique.
