**AGREEMENT ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE REPUBLIC OF UGANDA
AND THE REPUBLIC OF SAN MARINO**

The Republic of Uganda and the Republic of San Marino,

Desirous of strengthening the existing friendly relations between their Governments and peoples, and promoting and intensifying their cooperation in the political, economic, social and cultural fields;

Guided by the principles and purposes of the United Nations Charter and other norms of international law, particularly those pertaining to the promotion of international peace and security, the respect for State sovereignty, equality among States, territorial integrity, and non-interference in the internal affairs of States,

Have decided to establish diplomatic relations at the ambassadorial level, also non resident, on the basis of the Vienna Convention on Diplomatic Relations of 18 April 1961.

This Agreement shall come into force upon the date of the notification by the Republic of San Marino after completion of its internal procedure necessary for its entry into force.

Done at New York on October 23rd, 2020, in duplicate, in the English and Italian languages, all texts being equally authentic.

**ACCORDO SULLO STABILIMENTO DELLE RELAZIONI DIPLOMATICHE

La Repubblica dell'Uganda e la Repubblica di San Marino,

Desiderose di rafforzare gli amichevoli rapporti esistenti tra i rispettivi Governi e popoli, e di promuovere ed intensificare la loro cooperazione in campo politico, economico, sociale e culturale,

Guidate dai principi e dagli scopi sanciti dalla Carta delle Nazioni Unite e da altre norme di diritto internazionale, con particolare riferimento alla promozione della pace internazionale e della sicurezza, al rispetto della sovranità nazionale, all'uguaglianza tra gli Stati, all'integrità territoriale ed alla non ingerenza nelle questioni interne dello Stato,

Hanno deciso di stabilire relazioni diplomatiche a livello di Ambasciatori, anche non residenti, sulla base della Convenzione di Vienna sulle Relazioni Diplomatiche del 18 aprile 1961.

Il presente Accordo entrerà in vigore alla data della notifica da parte della Repubblica di San Marino del completamento della procedura interna, necessaria per la sua entrata in vigore.

Fatto a New York, il 23 ottobre 2020, in duplice copia, nelle lingue inglese e italiana, tutti i testi facenti ugualmente fede.
