Attached is a Joint Communiqué we have signed in Catalan and English on behalf of our respective Governments to this effect.


We kindly request that Your Excellency circulate the text of this letter as well as the Joint Communiqué as a UN document.

**JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
THE PRINCIPALITY OF ANDORRA  
AND  
BARBADOS**

The Principality of Andorra and Barbados,

Desirous of promoting mutual understanding and strengthening the friendship and cooperation between the two countries;

Guided by the principles and purposes enshrined in the Charter of the United Nations and the principles of International law, particularly respect for and promotion of international peace and security, State sovereignty, equality among States, independence, international treaties, territorial integrity, and non-interference in the internal affairs of other States;

Have decided to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, the Vienna Convention on Consular Relations of 24 April 1963, and based on the principles enshrined in the Charter of the United Nations, as of the date of signing of this Joint Communiqué;

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communiqué, in duplicate, in the Catalan and English languages, all texts being equally authentic.

El Principat d'Andorra i Barbados,

Desitjosos de promoure la comprensió mútua i d'enfortir l'amistat i la cooperació entre ambdós països;

Guiats pels principis i els objectius de la Carta de les Nacions Unides i del dret internacional, especialment pel respecte i per la promoció de la pau i la seguretat internacionals, la sobirania dels Estats, la igualtat entre Estats, la independència, els tractats internacionals, la integritat territorial i la no-ingerència en els afers interns dels Estats

Han decidit establir relacions diplomàtiques, segons les disposicions de la Convenció de Viena sobre relacions diplomàtiques del 18 d'abril del 1961, de la Convenció de Viena sobre relacions consulars del 24 d'abril del 1963, i els principis de la Carta de les Nacions Unides, a partir de la data de signatura d'aquest Protocol

A aquest efecte, els representants sotassinats, degudament autoritzats pels Estats respectius, signen aquest Comunicat conjunt a Nova York, el 21 de juny del 2021, en dos exemplars, en les llengües catalana i anglesa. Tots els textos són igualment fefaents.
