**JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN  
THE REPUBLIC OF SLOVENIA AND THE REPUBLIC OF KIRIBATI**

The Government of the Republic Slovenia of and the Government the Republic of Kiribati,

Desiring to promote and strengthen ties of friendship and co-operation between their countries on the basis of equality, mutual respect for each other's sovereignty, independence and territorial integrity as well as non-interference in the internal affairs of each other,

Guided by the principles and purposes of the Charter of the United Nations, as well as the Vienna Convention on Diplomatic Relations of 1961 and Vienna Convention on Consular Relations of 1963,

Have decided to establish diplomatic relations at the ambassadorial level, as of the date of signing of this Joint Communiqué.
