**JOINT COMMUNIQUÉ**  
**ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS**  
**BETWEEN**  
**THE GOVERNMENT OF NEPAL AND THE GOVERNMENT OF THE REPUBLIC OF**  
**SIERRA LEONE**

The Government of Nepal and the Government of the Republic of Sierra Leone;

Desirous to promote mutual understanding and strengthen friendship and cooperation between two countries,

Guided by the principles of the United Nations Charter and international law, particularly the respect and promotion of international peace and security, equality among States, due respect for national sovereignty and territorial integrity, independence and international treaties, and non-interference in internal affairs of States,

Have decided to establish diplomatic relations at Ambassadorial level with effect from the date of signature of the present Joint Communiqué under the terms of the Vienna Convention on Diplomatic Relations of 18 April 1961, the Vienna Convention on Consular Relations of 24 April 1963, and based on the principles enshrined in the Charter of the United Nations.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed the Joint Communiqué in two originals, in English and Nepali, both texts being authentic.

सन् १९६१ अप्रिल १८ मा भियानामा सम्पन्न कूटनीतिक सम्बन्ध सम्बन्धी महासन्धिको प्रावधान, सन् १९६३ अप्रिल २४ मा भियानामा सम्पन्न कन्सुलर सम्बन्ध सम्बन्धी महासन्धिको प्रावधान, संयुक्त राष्ट्रसंघको बडापत्रमा उल्लिखित सिद्धान्तहरूमा आधारित भएर प्रस्तुत संयुक्त विज्ञप्तिमा हस्ताक्षर भएको मिति देखि राजदूतस्तरमा कूटनीतिक सम्बन्ध स्थापना गर्ने निर्णय गरेका छन्।

यस कुराको प्रमाण स्वरूप प्रस्तुत विज्ञप्तिमा आ-आफ्ना सरकारहरूबाट कानूनतः अधिकार पाएका देहायका प्रतिनिधिहरूले नेपाली र अंग्रेजी भाषाका दुई दुई सङ्कल प्रतिहरूमा हस्ताक्षर गरेका छन्, दुई वटै प्रतिहरू समान रूपले प्रमाणिक हुनेछन्।
