INTRODUCTION

On the same day that they signed the United Nations Charter, the delegates to the San Francisco Conference signed the "Interim Arrangements," providing for the establishment of a Preparatory Commission to meet in London for the purpose of convoking the General Assembly, preparing a provisional agenda, and formulating recommendations concerning transfer of League of Nations assets, relationships with specialized agencies, organization of the Secretariat, location of the permanent headquarters, and other matters.

After its first meeting at San Francisco on June 27, 1945, the Commission left to a fourteen-member Executive Committee the task of preparing a detailed report for its consideration. The Executive Committee met in London on August 16, and, after three months of work, produced the report (Doc. FC/EX/113/Rev.1) which served as the basis for discussions in the subsequent full Commission meetings, beginning on November 24, 1945. The final report of the Preparatory Commission to the United Nations General Assembly (Doc. FC/20) was adopted and the body adjourned on December 23, 1945. In accordance with a provision in the "Interim Arrangements," the Preparatory Commission ceased to exist on February 2, 1946, when the Secretary-General was installed in office.

The attached index is intended to cover all of the formal documents issued by or for the Preparatory Commission, including the printed summary records of meetings. It does not, however, include the separately indexed documents of the Executive Committee.

It may be pointed out that, in addition to the documents of the Preparatory Commission and the Executive Committee, the United Nations Archives has certain other records of the Preparatory Commission which are also available for consultation. These include:

- A. Verbatim minutes of meetings of the Preparatory Commission, its committees, and the Executive Committee.
- B. Drafts of documents.
- C. Administrative correspondence and memoranda (fragmentary; other similar records are in the Central Registry).
- D. Committee working papers (mostly attendance records and duplicate copies of verbatim minutes).
