Introduction

1. At its 3rd plenary meeting, on 17 September 1999, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-fourth session the item entitled:

“Macroeconomic policy questions:

- “(a) High-level international intergovernmental consideration of financing for development;
- “(b) Financing for development, including net transfer of resources between developing and developed countries;
- “(c) Trade and development;
- “(d) Science and technology for development;
- “(e) External debt crisis and development”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 8th to 10th, 15th, 28th, 29th, 33rd, 37th and 39th to 41st meetings, on 8, 11 and 19 October and on 1, 8, 11, 12 and 15 November 1999.
