# Administrative and financial implications of draft resolution A/37/L.13/Rev.1

#### Report of the Fifth Committee

Rapporteur: Mr. M. Adel EL SAFTY (Egypt)

- 1. At its 52nd and 53rd meetings on 2 December 1982, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/37/58/Rev.1) on the administrative and financial implications of draft resolution A/37/L.13/Rev.1 as well as the related report of the Advisory Committee on Administrative and Budgetary Questions (A/37/7/Add.10).
- 2. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary records (A/C.5/37/SR.52 and 53).

#### DECISION OF THE FIFTH COMMITTEE

3. The Fifth Committee decided, by a recorded vote of 92 to 3, with 19 abstentions, to inform the General Assembly that, should it adopt draft resolution A/37/L.13/Rev.1, an additional appropriation of \$2,728,500 would be required under section 2C of the programme budget for 1982-1983. Provision of \$428,400 would also have to be made under section 31 (Staff assessment), to be offset by an increase in the same amount under income section 1 (Income from staff assessment). Conference-servicing costs would arise, which are estimated, on a full-coat basis, at \$1,596,100. The actual additional appropriations that might be required in this respect would be considered in the context of the consolidated statement of total conference-servicing requirements to be submitted to the General Assembly at a later stage during the current session.
