# JOINT COMMUNIQUÉ ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF LEBANON

### AND

#### THE REPUBLIC OF ZIMBABWE

The Government of the Republic of Lebanon and the Government of the Republic of Zimbabwe, desirous of developing and strengthening diplomatic relations between both countries and seeking to promote economic and cultural links;

Recognizing, in particular, the principles of sovereign equality and territorial integrity, both countries have decided to formalize diplomatic relations at the level of Ambassador, in accordance with the provisions of the Vienna Convention on Diplomatic Relations, dated 18 April 1961 and on the basis of the principles enshrined in the Charter of the United Nations;

IN WITNESS WHEREOF, the undersigned Representatives, duly authorized by their respective governments, have signed this Joint Communiqué in the English language.
