**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE FEDERAL DEMOCRATIC REPUBLIC OF NEPAL
AND
THE REPUBLIC OF TRINIDAD AND TOBAGO**

The Government of the Federal Democratic Republic of Nepal and the Government of the Republic of Trinidad and Tobago;

Desirous of developing bonds of friendship and cooperation in the areas of mutual interests between their countries and peoples;

Reaffirming their commitment to the principles and purposes of the Charter of the United Nations and of international law, including the sovereign equality of States, territorial integrity, and non-interference in the internal affairs of States;

Convinced that the establishment of diplomatic relations corresponds to the interests of both States and will further strengthen international peace and security;

Have decided to establish diplomatic relations between them, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of signature of this Joint Communiqué.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in two original copies, in English and Nepali, both texts being equally authentic.
