Note by the Secretary-General

Roger PINTO, born 26 May 1910 in Paris, awarded licence and diploma of higher studies (English, 1929-1930); B.A. (St. John's College, USA); admitted to the <u>Faculties of Law</u> (1938); awarded certificate of the <u>Centre des hautes études</u> <u>administratives</u> (1948); adviser to the French delegation to the Economic and Social Council (1950); French representative on the Committee on International Criminal Jurisdiction of the United Nations General Assembly (1951); member of the group of jurists responsible for drafting the Constitution of Eritrea; United Nations Legal Adviser in Eritrea (1952); Professor at the Faculty of Law, Paris (1955); Legal Adviser to the French delegation to the Suez Canal Users' Association (1956); French representative on the Sixth Committee of the United Nations General Assembly (1956/57).

UNESCO expert at the Rome and Prague conferences (1958); Counsel for Cambodia before the International Court of Justice (cases involving the Temple of Preah-Vihear, 1959-1962); Member and Rapporteur of the ICRC Committee of Experts on humanitarian aid for the victims of domestic conflicts (1962).

1975-1979, Counsel for the Greek Government in the dispute with Turkey; prepared and argued the cases relating to the continental shelf in the Aegean Sea before the International Court of Justice.

Rapporteur at the All-India Conference of Lawyers under the chairmanship of H.E. Mrs. Indira Gandhi (1980). Professor Pinto, who holds a certificate from the <u>Centre des hautes études administratives</u>, has taken an interest in legal questions pertaining to international civil servants in his lectures on the law of international organizations and his jurisprudence columns in the <u>Journal du droit</u> international.

Currently Professor of International Law at Paris Universities I and II.
