### I. Introduction

- 1. By its resolution 75/325, the General Assembly decided to establish, at its seventy-sixth and seventy-seventh sessions, an ad hoc working group on the revitalization of the work of the General Assembly, open to all Member States:
- (a) To identify further ways to enhance the role, authority, effectiveness and efficiency of the Assembly, inter alia, by building on progress achieved in past sessions as well as on previous resolutions, including evaluating the status of their implementation, with the primary focus on:
  - (i) During the seventy-sixth session: role and authority of the General Assembly, and working methods;
  - (ii) During the seventy-seventh session: strengthening the accountability, transparency and institutional memory of the Office of the President of the General Assembly and selection and appointment of the Secretary-General and other executive heads.
- 2. The General Assembly further decided that the Ad Hoc Working Group should continue its review of the inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted at the seventy-fifth session (A/75/973) and, as a result, continue to update the inventory to be attached to the reports to be submitted at the seventy-sixth and seventy-seventh sessions of the Assembly, including the separate indication of relevant provisions that were not implemented, with reasons therefor. The present report is submitted pursuant to the provisions of that resolution.
- 3. During the seventy-sixth session of the General Assembly, the President of the General Assembly appointed the Permanent Representative of Australia to the United Nations, Mitchell Fifield, and the Permanent Representative of El Salvador to the United Nations, Egriselda González López, as Co-Chairs of the Ad Hoc Working Group.

# II. Proceedings

- 4. The Working Group held a total of four formal meetings, on 9 March, 12 April and 11 May 2022.
- 5. The programme of work consisted of a general discussion and two thematic meetings on the following themes:
  - (a) The role and authority of the General Assembly;
  - (b) The working methods of the Assembly.
- 6. In addition, one meeting was held on 14 June 2022 as part of the interactive dialogue between permanent missions and the Secretariat. All formal meetings and the dialogue between permanent missions and the Secretariat were webcast.

#### A. General discussion

7. The first meeting of the Working Group was convened by its Co-Chairs on 9 March 2022. Following introductory remarks by the President of the General Assembly, interventions were made by 29 delegations, including on behalf of five groups of States. The Working Group also had before it a tentative timetable for the thematic discussions and a draft updated inventory chart of all revitalization

mandates, which was uploaded on the dedicated web page accessible from the website of the General Assembly (www.un.org/en/ga/revitalization/).

- 8. In his opening remarks, the President reiterated the need for the General Assembly, as the chief policy and deliberative organ of the United Nations, to discuss both issues and solutions that have an impact on humanity in the face of the ongoing complex global challenges, including climate change, the coronavirus disease (COVID-19) pandemic and the dire consequences of war. Revitalization was also key to the ongoing thematic consultations on "Our Common Agenda", as a bold and compelling vision of the United Nations for a more inclusive and sustainable future. A revitalized Assembly would bring about a more effective and responsive United Nations. In closing, the President encouraged delegations to develop concrete proposals for the effective implementation of the revitalization mandates.
- 9. Subsequently, the Co-Chairs recalled that, in accordance with resolution 75/325 and in the absence of a negotiated text at the seventy-sixth session, the work would focus on the implementation of previous decisions and discuss future actions to improve the work and functions of the General Assembly, including during the two thematic debates: (a) on the role and authority of the Assembly; and (b) on its working methods. The Co-Chairs noted that the revitalization was a long-term process, with each resolution delivering iterative progress across each of the four thematic pillars. In the end, revitalizing the Assembly was about building a multilateral system that would be relevant, flexible, agile and responsive to emerging challenges.
- 10. During the discussion, delegations noted the importance of the revitalization process as a critical component of the comprehensive reform of the United Nations. Referring to the simultaneous consultations process on the recommendations of the Secretary-General in his report entitled "Our Common Agenda" (A/75/982), speakers agreed on the need for effective multilateralism to be more interconnected, inclusive and effective in order to address current challenges. One group of States reiterated the importance of preserving the intergovernmental, inclusive and democratic nature of the United Nations and the need to ensure the proper implementation of the Charter of the United Nations with respect to the functional relationship between its principal organs, while also fully respecting their respective mandates. An invigorated General Assembly would significantly contribute to strengthening the wider United Nations system, improving global governance and reinvigorating multilateralism, many speakers said.
- 11. Overall, a broad range of issues were raised, including greater support for multilingualism as a core value of the Organization, the selection and appointment of the Secretary-General and other executive heads, the gender and geographical balance of the Secretariat, support for the Office of the President of the General Assembly, accessibility, lessons learned after the COVID-19 pandemic and training for delegates, among other things.
- 12. Many speakers welcomed the start of the new biennial cycle of the Ad Hoc Working Group, referring to resolution 75/325 as an ambitious and action-oriented outcome containing practical and concrete steps aimed at improving the efficiency and effectiveness of the General Assembly. Delegations also welcomed the road map contained in the letter of the Co-Chairs dated 25 January 2022, and supported their suggestion to enhance the capacities of delegations to draft, discuss and negotiate action-oriented outcomes as well as to mainstream gender equality in the meetings and outcomes of the Assembly. Delegations noted with appreciation the commitment of the President of the General Assembly towards achieving gender parity among invited speakers and panellists for high-level and other meetings of the Assembly.

### B. Thematic debate on the role and authority of the General Assembly

- 13. The Co-Chairs convened the thematic meeting on the role and authority of the General Assembly on 12 April 2022. A briefing was provided by the Director of the Outreach Division of the Department of Global Communications on the efforts of the Department to enhance the visibility of the work of the Assembly, including through multimedia content and outreach to diverse audiences in multiple languages and on multiple platforms. In 2020, in the face of the health crisis caused by COVID-19, the Department launched the "Verified" initiative, aimed at equipping people with accurate public health information, cementing confidence in the COVID-19 vaccine, countering misinformation and building solidarity and equity for a fair and effective recovery. In 2021, the Verified initiative produced 9,000 pieces of content in 60 languages, reaching more than 1 billion people across the world. The Assembly featured prominently in the messages the Department delivered, which were shared by way of social media, United Nations News, a dedicated multilingual website and press releases. With regard to its efforts to support the Office of the President of the General Assembly, the Department continued to provide a spokesperson, arrange media interviews, monitor media coverage of the President's activities and facilitate connections with civil society, academia and celebrities.
- 14. In an interactive segment, five delegations and Co-Chairs asked questions about the efforts of the Department to reduce misinformation; its work in the field; self-evaluation; engaging with public, including through the Model United Nations; and providing information on the work of the Organization in an accessible and understandable format. In the field, the Department continued to work with its 60 United Nations information centres and with the communications officers of resident coordinators to connect with local communities. There were ongoing efforts to educate the organizers of the Model United Nations Conferences about consensus-based multilateralism and the structure of the Organization, including by publishing a book and holding training workshops with the organizers. With regard to self-evaluation, under the new global communications strategy, each campaign had its own performance indicators, which were analysed and acted upon.
- 15. In a subsequent debate, 21 delegation made statements, including on behalf of four groups, focusing on the role and authority of the General Assembly. Delegations welcomed the efforts by the Department of Global Communications in countering false and deliberately misleading information online, particularly in the context of the COVID-19 pandemic, and in increasing the visibility of the Assembly through many platforms while maintaining multilingualism. Speakers recognized that the complexity of the global challenges had amplified the need to strengthen the central role and authority of the Assembly, and to reinvigorate multilateralism, by enhancing its intergovernmental, inclusive and democratic nature. Delegations reiterated the need for greater synergy and coherence in the work of the various principal organs, including by rationalizing agendas in consultation with the sponsoring States. Considering the importance of implementing the 2030 Agenda for Sustainable Development, delegations reiterated the importance of achieving tangible progress in the alignment of the agendas of the Assembly, its Main Committees and the Economic and Social Council.
- 16. With regard to rationalizing side events and high-level activities during the high-level week, many delegations wished to ensure the implementation of paragraph 19 (b) of resolution 75/325, in which the General Assembly encouraged the limitation of the number of side events held in parallel with or in the margins of the general debate, as well as other high-level sessions, including by exploring further improvements and the possibility of setting up a non-binding guideline to achieve this. Delegations set out concrete proposals for reducing the overall number of events,

including that all delegations would proactively raise the issue with their capitals to build understanding of the current volume of events and the impact it had on the primacy of the general debate, manage expectations ahead of September and encourage a focus on collaboration. They further suggested that the President would benefit from articulating the theme for the upcoming high-level week immediately following her or his appointment in June. That would enable delegations to undertake early consultations across regional, thematic and other groups to identify similar topics and areas for collaboration, with a view to combining events.

- 17. One group reiterated the importance of the Security Council reporting to the General Assembly, as well as the need for more analytical annual reports and special subject-oriented reports on issues of current international concern. Another group stated that the best way to enhance the role and authority of the Assembly was to improve its efficiency and effectiveness by focusing on current priorities, and suggested reducing the length and number of resolutions and other outcome documents and focusing on their operational aspects. The group urged that concrete steps be taken, collectively, towards more effective mandate delivery, while making better use of the resources available. Other speakers recalled examples of the biennialization or technical rollovers of resolutions during the pandemic and suggested that this approach be mainstreamed through revitalization.
- 18. Many delegations emphasized the importance of multilingualism as a fundamental value of the United Nations and called for the parity of all official languages in all activities of the Organization, including on its websites. One group called for integrating multilingualism into the workflow by creating multilingual content, rather than using computer-assisted translation to produce multilingual content from English. Another group stressed the need to consider multilingualism as one of the criteria for selecting panellists for and inviting speakers to the meetings of the General Assembly. Some delegations emphasized the importance of including other stakeholders in the work of the Assembly and its Main Committees, as well as improving such participation. One speaker proposed decreasing the carbon footprint of diplomacy and considering the impact of the Assembly on climate change.

### C. Thematic debate on the working methods of the General Assembly

- 19. The Co-Chairs convened the thematic debate on the working methods of the General Assembly on 11 May 2022. In their opening remarks, the Co-Chairs invited the Working Group to reflect on the working methods of the Assembly and its Main Committees, as revitalization of the work of the Assembly was, at its core, a process aimed at improving the equity, efficiency and effectiveness of the Assembly, and the current resolution contained mandates which, if implemented with the support of the membership, could most directly meet these objectives. The Co-Chairs also announced that while paragraphs 25 to 50 of resolution 75/325 provided a series of mandates, the debate would focus on the mandates addressed to the Main Committees and the Presidency of the General Assembly, while the interactive dialogue between the permanent missions and the Secretariat, on 14 June, would address the issues aimed at improving the Secretariat's cooperation with the permanent missions, including the briefing requested in paragraph 28 of the resolution.
- 20. Subsequently, the representatives of the Bureaux of the Main Committees and the Chef de Cabinet of the Office of the President of the General Assembly, on behalf of the President in his capacity as Chair of the General Committee, reflected on experiences in their respective Committees. The briefings by the Bureaux of the Main Committees have been published as part of the present report in accordance with paragraph 31 of resolution 75/325 (see annex II).

- 21. The Chef de Cabinet reported that, as was the case during the seventy-fifth session, the General Committee had kept its traditional role in the current session, dealing essentially with the agenda of the General Assembly and the assignment of items to the Main Committees. The President of the General Assembly first met with the General Committee-elect informally before the start of the session to give the President an opportunity to engage with the incoming members on the upcoming session. Since the start of the session, the President had thus far convened the General Committee for two meetings: one formal, on 15 September 2021, to adopt the agenda for the session; and one informal, on 14 December 2021, to summarize the work of the Assembly during the main part of the seventy-sixth session by acknowledging the work of the Main Committees and the key achievements of the Assembly plenary from September to December 2021. The President also briefed the General Committee on the work of the Assembly during the resumed part of the seventy-sixth session on his mandates for high-level events and negotiation processes, as well as initiatives to hold thematic debates on issues of importance to the international community, in order to implement the priorities of his "Presidency of Hope".
- 22. Following the briefing, the Office of the President circulated a draft timeline of the high-level events, upcoming elections and mandated events during the remaining part of the seventy-sixth session. In looking to revitalize the role of the General Committee, the Chef de Cabinet reported one innovation at the current session to appoint five Vice-Presidents to assist with leading consultations on "Our Common Agenda". That appointment was welcomed by Member States. During the remainder of the seventy-sixth session, the President had intended to continue to explore ways for the General Committee to support revitalization efforts. However, the Chef de Cabinet recalled that efforts to rationalize the agenda, biennialize and triennialize items and reduce overlaps and duplication, regarding which the Ad Hoc Working Group had called on the General Committee to play an active role, must come from Member States. It would be a collective effort, but ultimately, it was the proponents of agenda items and annual resolutions who had to make that decision. Moreover, the General Committee could benefit from greater engagement from its membership, including at the level of the permanent representatives. Finally, the Chef de Cabinet reiterated his call to Member States, on behalf of the President of the General Assembly, to continue to build on recent improvements to the methods of work and to the larger process of revitalizing the Assembly in order to transform the entire United Nations and ensure a better world.
- 23. During the debate, many delegations welcomed the briefings on the working methods and lessons learned by the Bureaux of the Main Committees and the Chef de Cabinet. One group of States reiterated the need to focus on agreed priorities as set out in the 2030 Agenda, and on the declaration on the commemoration of the seventyfifth anniversary of the United Nations (resolution 75/1) that the Organization was attempting to achieve "Our Common Agenda". The group called for working towards a modern United Nations that delivered on its core mandate, that opened up to its citizens and other external stakeholders and that promoted gender equality and gender balance. The same group referred to the overburdened agenda of the General Assembly and its Main Committees, recalled that during the pandemic delegations had to rationalize the number of meetings, resolutions and informal consultations, and thus proposed to retain the valuable best practices of the past two years when returning to normal. Another group reiterated the exceptional nature of the working methods in the context of the pandemic, as well as the importance of maintaining strict compliance with and adherence to the existing rules of procedure of the Assembly, while welcoming the fact that the Assembly had managed to adapt its working methods to ensure continuous functioning, including through the use of virtual platforms. Overall, delegations reiterated their preference for in-person

meetings and intergovernmental negotiations, if the precautionary measures to mitigate the spread of COVID-19 were respected.

24. Many speakers reiterated the need to address the periodicity of the agenda items and resolutions, in consultation with Member States. Delegations reiterated proposals concerning the streamlining of the agenda, including moving away from annual resolutions; covering any new initiatives dealing with an emerging or new challenge by default with a one-off resolution; including sunset clauses in all recurring existing and new resolutions; and consolidating agenda items and clustering topics at longer intervals. Some delegations also suggested extending certain innovations required by the COVID-19 pandemic to improve operations into the future, such as holding virtual and hybrid meetings, which would cut down on the cost of travel and reduce the environmental impact. Delegations looked forward to hearing the briefing from the Secretariat on 14 June 2022 on lessons learned from the COVID-19 pandemic, including the use of information and communications technologies, with a view to ensuring better preparedness in exceptional circumstances, in accordance with paragraph 27 (b) of resolution 75/325.

### III. Conclusion

25. In accordance with its mandate, the Working Group endeavoured to identify key issues of concern and possible consensus, to examine the current status of implementation of those issues, and either to take action or to indicate possible further action to be taken. On 25 August 2022, the Co-Chairs circulated a letter that contained their recommendations for the seventy-seventh session based on the discussions held at the current session.

# Updated inventory chart of General Assembly resolutions on the revitalization of the work of the General Assembly, issued pursuant to resolution 75/325

### Explanatory note by the Co-Chairs of the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly (seventy-sixth session)

- 1. In accordance with paragraph 6 of General Assembly resolution 75/325, in which the Assembly decided that the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly should continue its review of the inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted to the Assembly at its seventy-fifth session (A/75/973) and, as a result, continue to update the inventory to be attached to the reports of the Ad Hoc Working Group at the seventy-sixth and seventy-seventh sessions, the Co-Chairs, assisted by the Secretariat, have prepared the updated inventory chart for consideration by Member States.
- 2. The present inventory chart has been updated to reflect the progress achieved since the adoption of resolution 75/325.
- 3. The Co-Chairs, assisted by the Secretariat, obtained updated information, where possible, from relevant entities responsible for implementation.
- 4. The updated inventory chart retains the following two-part structure, which was also utilized in the report submitted at the seventy-third session:
- (a) The first part contains unimplemented provisions, in order to focus on their follow-up;
- (b) The second part contains implemented provisions, both those that required one-time action and those to be implemented on an ongoing basis, in order to keep track of previous achievements and provide the means to compare with and learn from past experience.
- 5. The inventory chart does not have a definite character and may be amended at any time by Member States through the Ad Hoc Working Group. Furthermore, it is not intended to, and does not, have any legal effect. It should serve only as a tool to facilitate discussions on the follow-up to the implementation of the previous related resolutions.

### **Annex II**

# Written updates on progress achieved thus far in the efforts aimed at improving the working methods of the Main Committees of the General Assembly pursuant to resolution 75/325

1. In accordance with paragraph 31 of General Assembly resolution 75/325, in which the Assembly requested "each Main Committee to submit to the Ad Hoc Working Group during the seventy-sixth session a written update on progress achieved so far in the efforts aimed at improving the working methods of the Committees, taking into account recommendations of the Ad Hoc Working Group as appropriate", and the letter by the Co-Chairs in that connection dated 17 August 2022, the written updates submitted by the Chairs of the Main Committees and the Secretary of the Third Committee through the Co-Chairs of the Working Group are reproduced in the present annex.

### I. Update submitted by the Chair of the First Committee (seventy-sixth session)

- 2. Despite the continuing restrictions resulting from the COVID-19 pandemic, the First Committee was able to craft a programme of work during the seventy-sixth session that included all three traditional segments that is, a general debate, thematic discussions and an action phase and achieve its goals of contributing meaningfully to the General Assembly in the field of disarmament and international security. A total of 16 agenda items and 36 sub-items were allocated to the Committee, which held 18 in-person meetings (3 more meetings than in the seventy-fifth session) and 3 virtual meetings.
- 3. The Committee continued to adopt temporary measures in response to the pandemic, such as time limits for statements being strictly observed (microphones were automatically silenced once the time limit was achieved); a compendium of statements on specific thematic clusters reflecting positions of delegations that could not be delivered in person; and statements in explanation of vote and in the exercise of right of reply being shortened substantially.
- 4. In response to feedback from States requesting a return to the Committee's established working methods, the traditional thematic discussions suspended in 2020 resumed in 2021. Given the time constraints, the Committee agreed that statements be presented in-person, in written form or as pre-recorded statements. During the current session, given the limited number of in-person meetings available for the work of the Committee, statements were made on combined thematic clusters rather than the seven individual clusters. Owing to the limitations on conference room availability, the Secretariat arranged for virtual conference rooms for informal consultations.
- 5. In finalizing arrangements for the current session, the Bureau considered an options paper prepared by the Secretariat on possible best- and worst-case scenarios depending on the fluidity of the pandemic. By the end of August, it was clear that States preferred to build on rather than return to the experience at the seventy-fifth session, as most delegates had been vaccinated. States also expressed a preference for more meetings, one conference room for the action phase of the First Committee, and to have more than one representative in the room. Between 30 August and 30 September 2021 (the date of the organizational meeting of the Committee), the Bureau met five times on options for the Committee's programme of work, finally deciding on 22 September to include the thematic discussions in its programme of work and to give priority to social distancing in its decision on conference rooms.
- 6. Over the years, significant efforts have been made to rationalize the work of the Disarmament and International Security Committee (First Committee), concentrating on


rearranging its agenda and improving its organization of work. Past decisions of the General Assembly in this regard include resolutions 42/42N of 30 November 1987, 48/87 of 16 December 1993, 49/85 of 15 December 1994, 57/300 of 20 December 2002, 58/41 of 8 December 2003, 58/126 of 19 December 2003, 58/316 of 1 July 2004 and 59/95 of 3 December 2004 and decision 52/416 B of 8 September 1998.

- 7. In the years just prior to the High-level Plenary Meeting of the sixtieth session of the General Assembly (2005 World Summit), several major initiatives were undertaken by the Assembly and the First Committee to specifically address their respective working methods. The general perception at the time was that the Assembly, the chief deliberative, representative and policy-making organ of the United Nations, was underperforming, its agenda was opaque, its working methods were antiquated and its public image was staid. For the First Committee, the concern was that the vacuum in multilateral arms control, disarmament and non-proliferation would have been filled by the Security Council and ad hoc arrangements and thus it was imperative for the United Nations to have an effective and relevant Assembly and First Committee, with minimal overlap between the Charter bodies.
- 8. In asking the Secretary-General, in its resolution 58/126, to submit an agenda of the Assembly organized around the priorities of the Organization, the General Assembly acknowledged that it would be advantageous for the Assembly to have a shorter agenda to ensure the fullest discussion of all issues so that its decisions might have greater impact. With respect to the First Committee, the decision was taken to biennialize and triennialize some of the items on its agenda and to merge items. At the same time, Member States were encouraged to reduce the number of draft resolutions they submitted annually and to avoid the introduction of "routine" draft resolutions. It was also suggested in the Committee that "routine" or "procedural" draft resolutions could be adopted as decisions of the First Committee proposed by the Chair in consultation with Member States. These early attempts to streamline the agenda of the First Committee later encountered political resistance from Member States, leading to a burgeoning agenda of the Committee.
- 9. There has certainly been better advance planning and preparation of the work of the First Committee with the full Bureau elected three months in advance of the next session of the General Assembly in accordance with resolution 58/126. Since the forty-ninth session of the Assembly, the election of the Chair of the First Committee proceeded by rotation between regional groups. A practice emerged that the regional group from which the Rapporteur came would chair the Committee the following year. However, this practice has not been consistent. Indeed, there has been a trend since the sixty-fifth session that the regional group from which the Chair came assumed the post of Rapporteur the following year.
- 10. Over the years, the working methods of the First Committee continue to be influenced by decisions taken by the wider General Assembly plenary (for example, decision 68/505 of 1 October 2013 on the pattern for the rotation of the Chairs of the Main Committees of the General Assembly and resolution 68/307 and the annex thereto on guidelines on the election of the chairs and rapporteurs of the Main Committees of the General Assembly) and the recommendations of the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly. In accordance with decision 52/416 B of 8 September 1998, the work of the First Committee does not exceed five weeks, and in view of resolutions 58/316 and 59/95, the Committee's current programme of work is divided into three distinct stages: general debate; thematic discussions; and consideration of and action on proposals. At its forty-eighth session, in an attempt to restructure and reorganize the annual agenda of the First Committee, the General Assembly had decided already to adopt a thematic approach by clustering items presented by Member States into the following 10 broad topic areas for more detailed and focused discussion: nuclear weapons; other weapons of mass destruction;

conventional weapons; regional disarmament and security; confidence-building measures, including transparency in armaments; outer space (disarmament aspects); disarmament machinery; other disarmament measures; international security; and related matters of disarmament and international security (see resolution 48/87). A decade later, at the fifty-ninth session, the Chair of the Committee reported to the President of the Assembly, in a letter dated 5 November 2004, the initiative of the Committee to order the items and sub-items allocated to it in seven clusters: nuclear weapons; other weapons of mass destruction; outer space (disarmament aspects); conventional weapons; regional disarmament and security; other disarmament measures and international security; and disarmament machinery.

- 11. In more recent years, the discussions on the working methods of the Committee have been focused and specific. Member States called for an early warning as to the drafts for which programme budget implications would be issued. They also asked that oral statements be distributed at least a day in advance and for closer communication and coordination among the respective Secretariat offices involved in the programme budget implication process. The discussions on financial implications, however, can run into political rather technical difficulties, with some delegations expressing the view that programme budget implications should not influence substantive proposals and that while the Committee should bear in mind the availability of funds, this should not determine disarmament and international security programmes and mandates.
- 12. On the subject of panel discussions (introduced in 2004) and briefings, while some delegations viewed them as important and informative, many others thought that they were not as effective nor as interactive as intended. This was attributed to repetitive topics and panellists presenting standard reports on the work of their respective organizations. Some considered that the composition of panels could be more balanced and diversified and include former heads of United Nations system organizations and experts from civil society, including academia. Further, the themes of panels should be relevant, interesting, up-to-date and diverse.
- 13. With respect to time management, it was agreed that non-adherence to time limits was detrimental to managing the work of the Committee. Calls were made for the firm enforcement of time limits. It was suggested that general statements be discontinued during the action phase or reserved exclusively for the introduction or revisions of draft proposals. Support was also expressed for the biennial, triennial or even quadrennial consideration of proposals that contained only technical updates. In view of the time management discussions, a buzzer system has been in use for more than five years to alert States that their time limit had been reached. The introduction of the e-deleGATE portal, including e-speakers and e-sponsorship, has been a welcome development.

### II. Update submitted by the Chair of the Special Political and Decolonization Committee (Fourth Committee) (seventy-sixth session)

- 14. The written input on the working methods of the Special Political and Decolonization Committee (Fourth Committee) is presented to the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly, further to the briefing on 11 May 2022 and pursuant to Assembly resolution 75/325.
- 15. The written input consists of three parts: a summary of the methods of work of the Fourth Committee before the COVID-19 pandemic; the innovative arrangements implemented during the seventy-fifth and seventy-sixth sessions, owing to the restrictions of the COVID-19 pandemic; and a summary of the informal meeting of the Committee on its working methods held on 22 April 2022.

### A. Summary of methods of work before the COVID-19 pandemic

16. As background, until 1993, when the General Assembly had seven Main Committees, the Special Political Committee was listed in United Nations documents and publications chronologically between the First and Second Committee. After the merger of the Special Political and the Fourth Committee pursuant to Assembly resolution 47/233 of 17 August 1993, the Committee was named the "Special Political and Decolonization Committee (Fourth Committee)" and took the chronological place of the Special Political Committee, following the First Committee. Therefore, in some publications such as the Journal, the order of the Committees is: First, Fourth, Second, Third, Fifth, Sixth.

### 1. Organization of work

- 17. Meetings of the Fourth Committee were held exclusively in-person, mainly in Conference Room 4.
- 18. Traditionally, the session started with six meetings, at which the Committee considered the five decolonialization items and heard statements by representatives of Non-Self-Governing Territories and petitioners (e.g. during the seventieth and seventy-first sessions). The meeting number for this topic was raised to seven meetings in 2017 and 2018 (at the seventy-second and seventy-third sessions) and eight meetings in 2019 (at the seventy-fourth session).
- 19. Other yearly topics of the Fourth Committee included "International cooperation in the peaceful uses of outer space" (three to four meetings), "Questions relating to information" (three meetings), "Effects of atomic radiation" (one meeting), "Comprehensive review of the whole question of peacekeeping operations in all their aspects" (four meetings), "Comprehensive review of special political missions" (one meeting), "United Nations Relief and Works Agency for Palestine Refugees in the Near East" (two meetings), "Report of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Palestinian People and Other Arabs of the Occupied Territories" (three meetings) and a final meeting for taking action on

the last two topics as well as to discuss "Revitalization of the work of the General Assembly" and "Programme planning".

- 20. Moreover, the Special Political and Decolonization Committee had one biennial item, "Assistance in mine action" (one meeting), and one triennial item, "University for Peace" (one meeting).
- 21. At the sixty-eighth session, as mandated by the General Assembly in its resolution 67/123, the agenda item entitled "Comprehensive review of special political missions" was added to the agenda of the Committee. No new item has been added to the agenda of the Fourth Committee since then.
- 22. Outside the main part of the session of the General Assembly, the Committee usually holds two formal meetings during the resumed session, one to take action on related substantive proposals based on the report of the Special Committee on Peacekeeping Operations and one on the election of the incoming Bureau, as well as one informal meeting with an interactive dialogue with high-level representatives of the Secretariat regarding special political missions.

### 2. General debates and action on draft proposals

- 23. Before the pandemic, the Committee considered its agenda items in the following pattern with certain exceptions: a general debate per agenda item followed by action on proposals under the respective item.
- 24. Exceptions were the decolonization items, which the Committee considered in a clustered manner, meaning with a joint general debate followed by joint action on all draft proposals submitted under these items. The Committee also heard the representatives of non-self-governing territories and petitioners during this period.
- 25. Further, the Committee held separate general debates on the agenda items concerning the United Nations Relief and Works Agency for Palestine Refugees in the Near East and Israeli practices, but took action on the draft proposals submitted under both items usually at the same meeting.
- 26. Draft proposals had different origins. Some draft resolutions were submitted as Chair's texts, others by Member States individually or by a group. Some proposals were contained in the annual reports of subsidiary bodies, such as the Special Committee on Peacekeeping Operations, the Committee on Information or the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples.
- 27. There was an established pattern by which the Committee adopted proposals on some issues by consensus and others by vote.

### 3. Introductory statements and interactive dialogues

- 28. Another exception to the pattern of general debate followed by action on proposals was the Committee's practice of having introductory statements by officials of subsidiary bodies and interactive dialogues with high-level representatives of the Secretariat and heads of agencies before beginning the general debates on certain agenda items, in accordance with the relevant provisions of General Assembly resolution 58/316.
- 29. These agenda items include "Questions relating to information", "Comprehensive review of the whole question of peacekeeping operations in all their aspects", "Comprehensive review of special political missions", "Effects of atomic radiation" and the agenda items "United Nations Relief and Works Agency for Palestine Refugees in the Near East" and "Report of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Palestinian People and Other Arabs of the Occupied Territories", which had a question-and-answer period.

### 4. Alternating meetings between First and Fourth Committees

30. In accordance with General Assembly resolution 51/241, the First and Fourth Committees alternated on a weekly basis in holding their meetings either in the morning or in the afternoon. The secretariats of the two Committees coordinated in preparing the draft programme of work for each session. The Committee was believed to benefit from this practice, given that it allowed active coverage of the two Committees by smaller delegations. However, owing to the expanding workload of the Committee, some overlap of meetings between the two Committees had become unavoidable.

### 5. Joint panel discussion, First and Fourth Committees

31. In keeping with efforts towards closer coordination and cooperation among Main Committees in identifying and addressing cross-cutting issues, while respecting the division of responsibilities, the First and Fourth Committees had held, biennially, a joint panel discussion since the seventieth session on possible challenges to space security and sustainability (at the seventieth, seventy-second and seventy-fourth sessions).

### 6. Time management

- 32. Regarding the time limitations for interventions before the COVID-19 pandemic, the Committee was guided and conducted its work regarding explanations of vote and rights of reply in accordance with General Assembly decision 34/401 (document A/520/Rev.19, annex V). Time limits regarding points of order followed the decision by the General Committee taken at its first meeting at the respective session (i.e. for the seventy-fifth session, on 20 September 2019). For time limits for speakers, the Committee referred to paragraph 4 of resolution 49/221 B, in which the Assembly requested the Chairs of the relevant organs and subsidiary bodies of the Assembly to propose to Member States, at the beginning of each session, the adoption of time limits for speakers. Hence, the time limits were as follows:
- (a) Statements in the joint general debate on various agenda items: 15 minutes for statements on behalf of groups and 10 minutes for national statements;
  - (b) Statements in explanations of vote: 10 minutes;
- (c) The first intervention in the exercise of the right of reply for any delegation on any item at a given meeting was 10 minutes, and the second intervention 5 minutes;
  - (d) Points of order: 5 minutes;
- (e) Statements by petitioners were restricted to four minutes (microphones being automatically cut off after the time limit had expired).

### 7. Hearing of petitioners

33. The Fourth Committee had the aforementioned practice to hear representatives of NSGTs and petitioners in-person under the decolonialization item with the number of petitioners steadily growing (compare 16 in 2002 to 130 petitioners in 2019).

### 8. Composition of the Bureau

- 34. The election of the Chair of the Committee was conducted pursuant to the pattern for the rotation of the Chairs of the Main Committees of the General Assembly as contained in the annex to Assembly resolutions 68/307 and 72/313.
- 35. Following an initiative in the seventy-fourth session, but only realized at its seventy-fifth session, and in order to establish a predictable and transparent procedure

for the election of the Rapporteur, the Committee adopted the following oral draft decision:

"The Committee decides, in accordance with paragraph 4 of the annex to General Assembly resolution 68/307, that the Rapporteur of the Fourth Committee shall be elected from the regional group that held the chairmanship of the Committee at the previous session, and requests that the regional group concerned nominate a candidate for the post of Rapporteur of the Committee accordingly" (see A/C.4/75/SR.1).

36. It has been proven useful to have a meeting between the outgoing and the incoming Bureaux shortly after the election of the new Bureau, following the provisions of resolution 71/323 and subsequent resolutions.

#### 9. Webcast

37. Finally, as decided by the General Assembly in resolution 66/246, all formal meetings of the Fourth Committee were webcast, serving public transparency and establishing a useful reference source.

### B. Innovative arrangements implemented owing to the restrictions of the coronavirus disease pandemic

38. Following is a description of the innovative organizational arrangements of the seventy-fifth and the current sessions to facilitate the Committee's work, which were exceptionally adopted, without setting a precedent, and implemented to respond to the challenges by the COVID-19 pandemic.

### 1. Organization of work

- 39. The agenda allocation for the Fourth Committee remained unchanged compared to the years before the pandemic. However, to follow applicable social distancing rules, the General Assembly and the six Main Committees could only hold in-person meetings in the General Assembly Hall and the combined conference rooms 1, 2 and 3. Moreover, the United Nations Secretariat provided platforms for virtual informal meetings.
- 40. Following the example of the previous session, the organization of work of the Fourth Committee during this session was the result of extensive consultations and coordination between the incoming Chair, Bureau members-designate, Member States, observers and the Committee secretariat, which were needed in view of the restrictions imposed by the COVID-19 pandemic.
- 41. The balance between in-person meetings, the joint general debate and an informal as well as a virtual meeting for introductory statements in view of the limited conference room availability for in-person meetings during the main part of the session was struck by the Bureau on the basis of experience at the previous session.
- 42. At the seventy-fifth session, owing to the impact of the COVID-19 pandemic, the Committee had held for the first time, on an exceptional basis and without setting a precedent, a joint general debate on all its agenda items, and held some meetings as virtual or hybrid meetings. The Committee followed this approach at the current session as well, on an exceptional basis and without setting a precedent in view of the ongoing impact of the COVID-19 pandemic (see details below).

### 2. Joint meeting of incoming/outgoing Bureaux

43. The Bureau has observed the practice of a joint meeting between the incoming and outgoing Bureaux for a proper turnover following the provisions of resolution 71/323 and subsequent resolutions. Owing to the ongoing impact of the COVID-19 pandemic, it had been held in a virtual format.

### 3. Joint general debate and action on draft proposals

- 44. Owing to the limited number of meetings allocated to it during the pandemic, the Committee held a consolidated joint general debate on all substantive agenda items before it, during the course of which it heard 131 statements (including 12 by groups), of which 34 were made by women delegates. In addition, 25 written statements were submitted to the Committee secretariat, which were uploaded to the Fourth Committee's space on e-deleGATE and posted on the Committee's public website.
- 45. As during the seventy-fifth session, action on draft proposals submitted under all agenda items was taken in a consolidated manner at the end of the session on a rolling basis in accordance with the numbering of agenda items, over the course of two meetings, held on 9 and 11 November 2021. The Committee adopted 38 draft proposals, 12 of which were adopted by a vote. A checklist of draft proposals contained in the Committee's reports to the plenary and the record of the plenary's action on 9 December 2021 is contained in document A/C.4/76/INF/3/Rev.1.
- 46. The Committee resumed its consideration of agenda item 56, "Comprehensive review of the whole question of peacekeeping operations on all their aspects", adopting a resolution in its 17th meeting, held on 20 April 2022.

### 4. Introductory statements and interactive dialogues

47. The Committee continued to hear introductory statements from officers of its subsidiary bodies and senior Secretariat officials and engaged in an interactive dialogue with the latter in a combination of in-person formal and virtual informal meetings. The innovative working arrangement of virtual meetings from the previous session was continued by holding a hybrid meeting (on 15 October 2021) and a fully virtual format on the Zoom platform (on 18 October 2021), prior to the start of the joint general debate.

### 5. Time limits

- 48. In view of its heavy agenda and the reduction in the number of meetings due to the COVID-19 pandemic, the Committee had approved the following time limits, on an exceptional basis, for its seventy-fifth session for the sake of effective time management and for the seventy-sixth session, also on an exceptional basis, as the impact of the COVID-19 pandemic was ongoing. One innovation necessitated by the COVID-19 pandemic was that strict compliance with time limits for statements had been enforced for Member States and that a time limit for the introduction of draft proposals had been agreed at the organizational meeting of the Committee, as follows:
- (a) Statements in the joint general debate: 10 minutes for national statements and 15 minutes for statements on behalf of groups;
  - (b) Statements in explanations of vote: 5 minutes;
- (c) The first intervention in the exercise of the right of reply for any delegation at a given meeting was 5 minutes, and the second intervention 3 minutes;
  - (d) Points of order: 3 minutes;
- (e) Statements in introduction of draft proposals by main sponsors: 3 minutes (this was new, as there was previously no time limit);
- (f) Statements by petitioners were restricted to 4 minutes, as before the COVID-19 pandemic (microphones being automatically cut off after the time limit had expired).

### 6. Petitioners

- 49. During the seventy-fifth session, no non-self-governing territories representatives and petitioners could be heard under the decolonialization items owing to the restrictions on in-person meetings. At the seventy-sixth session, although the COVID-19 pandemic was ongoing, the Committee was able to return to its annual interaction with the representatives and petitioners of the non-self-governing territories on its agenda under the decolonization cluster. Owing to logistical and technical challenges, this interaction was innovatively adjusted to the risk-mitigation and social distancing requirements in place.
- 50. Accordingly, and as petitioners were not allowed access to the General Assembly Hall nor its gallery, the petitioners hearings were held in conference rooms 1, 2 and 3. Another conference room served as a temporary "holding area" in which petitioners could wait for their turn to be escorted into conference room 2, where they addressed the Committee from a seat at the back of the room. Petitioners were asked to vacate their seats after addressing the Committee. The seats were then sanitized before the next batch of petitioners were escorted to these seats from conference room 4 by secretariat staff.
- 51. The Committee heard a total of 70 petitioners and four representatives of 5 non-self-governing territories under the decolonization items during its seventy-sixth session.

### 7. Delegation size

52. As part of the COVID-19 risk mitigating measures, only four representatives per delegation were allowed to take a seat in the General Assembly Hall, and two in conference rooms 1, 2 and 3. Observers were requested to limit their delegation to one representative only. Delegates were requested to proceed to their national seats immediately upon entering the Hall, or conference rooms 1, 2 and 3. Seating charts for both venues were drafted to ensure adequate physical distancing and transmitted to delegations via e-deleGATE in order to assist delegations in advance. Once seated, delegates were requested to remain in their seats for the duration of the meeting. All statements were delivered by delegations from their national seats.

### 8. Electronic functionalities

- 53. The Fourth Committee successfully utilized a number of virtual platforms during its seventy-fifth and seventy-sixth sessions, including Microsoft Teams (for Bureau meetings), Cisco WebEx (for informal consultations on draft proposals by main sponsors) and Zoom (for informal meetings of the Committee during the seventy-sixth session) in order to conduct its work. The Committee held one hybrid informal meeting and one virtual informal meeting.
- 54. The Committee also continued to successfully utilize the electronic functionalities offered via the e-deleGATE platform, as well as eStatements, to post the full versions of their statements delivered during the session.

### 9. Webcast

55. Finally, the Committee continued, as decided by the General Assembly in its resolution 66/246, to webcast its formal meetings during the seventy-fifth and seventy-sixth sessions, which was particularly useful for those delegations who were unable to attend the in-person meetings.

### C. Informal meeting on its working methods

- 56. The Special Political and Decolonization Committee continued to examine ways to revitalize its work, as requested by relevant General Assembly resolutions, including resolution 75/325. In that regard, the Bureau decided to convene, for the first time, an informal meeting dedicated to the discussion of its working methods on 22 April 2022.
- 57. While the objective of the meeting was not to take any decision, it proved to be a good way to commence the process of discussing and revitalizing the working methods of the Fourth Committee with a transparent and interactive discussion.
- 58. Delegations were encouraged to take the opportunity to reflect on any best practices and lessons learned with a view to improving the working methods of the Fourth Committee. The Member States conveyed their views on many of the working methods exceptionally adopted at its seventy-sixth session, as the session took place in the contest of the ongoing challenges of the COVID-19 pandemic.
- 59. While the Committee must still continue its consideration on these working methods, it is important to take this opportunity to share the feedback on some of these aspects while underlining that the following working methods still require further consideration by the Committee:
  - (a) Ensuring strict compliance with the time limits for statements;
- (b) Maintaining the important in-person meetings but taking advantage of possibilities for virtual participation for certain meetings, including virtual briefings by senior United Nations officials in the interactive dialogues of the Committee;
- (c) Avoiding simultaneous formal and informal meetings between different committees and commissions, following the alternating pattern of the First and Fourth Committees;
  - (d) Publication of the list of speakers before meetings.
- 60. There was no common position on the assessment of the joint general debate for several agenda items. While some delegations welcomed this modality, others expressed their preference for the previous pattern of work of the Fourth Committee. The importance of holding debates on specific items, such as decolonization, was highlighted.
- 61. A concern was expressed with respect to restricting the time available for statements made in the exercise of the right of reply, and a preference was expressed to maintain the time limitations in line with the rules of procedure of the General Assembly.
- 62. Other recommendations by delegations were as follows:
- (a) To have a repository of the working methods of the Committee and information about the subsidiary bodies related to its work;
- (b) To achieve earlier availability and enhance accessibility of relevant reports and other documents of subsidiary bodies that report to the Committee through online platforms;
- (c) To ensure effective multilingual communication equally in all the official languages of the United Nations in the meetings of the Committee.
- 63. Furthermore, reference was made to the importance of a balanced approach in the consideration of concrete proposals for the further biennialization, triennialization, clustering and elimination of items on the agenda of the General Assembly. Member States rights to present new agenda items and resolutions were also mentioned.

64. Overall, the informal meeting dedicated to the discussion of its working methods was welcomed by delegations as a way to address the evolution of the practice of the Committee and to ensure that delegations have the opportunity to reflect on how to improve its important work. The Chair highlighted the relevance of taking full advantage of the agenda item on "Revitalization of the work of the General Assembly" in future sessions of the Committee.

### III. Update submitted by the Chair of the Second Committee (seventy-sixth session)

- 65. I welcome this opportunity to update the ad hoc working group on the progress made in relation to the working methods of the Second Committee. The review of the Committee's working methods is indeed an ongoing process, building on General Assembly decisions 75/548 B and 74/537 B, adopted in July 2021 and August 2020 respectively, as an outcome of discussions of the Committee during the resumed seventy-fifth and seventy-fourth sessions.
- 66. I would like to underscore the key role of the Second Committee in facilitating political guidance and commitments by the General Assembly on questions related to the dimensions of sustainable development; macroeconomic policy and economic growth; financing for development and different means of implementation; global partnerships; and operational activities for development. Deliberations held and agreements reached in the Committee are essential to supporting the implementation of the Sustainable Development Goals and other landmark agreements under the United Nations umbrella. It is therefore crucial to maintain a well-functioning Second Committee to ensure that we deliver on our promises and to achieve our common ambitions.

### Decisions 75/548 B and 74/537 B

- 67. Through the adoption of decisions 75/548 B and 74/537 B, the Assembly agreed on a number of measures to revitalize the work of the Committee. These included:
  - (a) Adoption of a theme for the Committee's general debate;
- (b) Wider use of joint consideration of items in the Committee's general discussions;
  - (c) Restriction of Committee-organized side events to a maximum of three;
- (d) Request to focus reports of the Secretary-General, inter alia, on the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda and their interlinkages and to include actionable recommendations.
- 68. With regard to draft resolutions, the Assembly:
- (a) Invited proposers of draft resolutions to share the proposed drafts early in an editable format with tracked changes, and with references to the sources of new language;
- (b) Agreed on some streamlining, renaming and adjustments in periodicity of draft resolutions and on a time limit for the introduction of draft resolutions in plenary.
- 69. For the most part, these measures were implemented during the seventy-sixth session, building also on the experiences of the seventy-fifth session. At the same time, owing to the continued restrictions on in-person meetings due to the COVID-19 pandemic, the Committee agreed on a number of special measures that were implemented during the seventy-sixth session. It was agreed that those measures would not set a precedent for future sessions.

- 70. The special measures included:
- (a) Limiting in-person meetings: during the session, the Committee held 10 in-person meetings, which included an organizational meeting, 4 meetings to hear the general debate of the Committee, a joint meeting with the Economic and Social Council and 4 meetings for the adoption of draft resolutions;
- (b) The meetings for general discussions of agenda items were held as informal virtual meetings on a remote simultaneous interpretation platform;
- (c) In addition to the usual joint consideration of the agenda items on macroeconomic policy and financing for development, there were joint general discussions of the agenda items on "Information and communications technologies for sustainable development" and "Globalization and interdependence"; "Eradication of poverty and other development issues", and "Agriculture development, food security and nutrition" and their sub-items; and finally, "Groups of countries in special situations" and its sub-items, with the item entitled "Towards global partnerships". As a result, all general discussions were concluded in 11 meetings, compared to 15 in 2019;
- (d) The time limits for statements in the general debate and for general discussions of individual items were shortened by one minute and pre-recorded video statements were permitted;
- (e) Only one side event (a virtual event on the theme "Energy transition for sustainable development and climate action) was organized by the Committee on 19 October;
- (f) The dialogue with the Executive Secretaries of the regional commissions was held as an informal virtual meeting on 18 October;
- (g) With regard to the texts of draft resolutions, it was exceptionally agreed that changes introduced should be limited and should comprise one cross-cutting preambular paragraph on recognizing the impact of COVID-19 on economic and development aspects; no more than one preambular paragraph for substantive COVID-19 related aspects; and up to two operative paragraphs, including but not limited to COVID-19 related aspects of the resolution, identifying action-oriented solutions and ways forward to deal with the challenges related to the theme of the resolution. Technical or factual updates critical to the resolution were also introduced;
- (h) All substantive negotiations were limited only to the new paragraphs tabled by the proponents of the draft proposals;
- (i) Informal consultations on draft resolutions were limited as a rule to three rounds per draft and were organized in a consolidated calendar on a virtual platform, avoiding parallel negotiations and negotiations outside of United Nations working hours to the extent possible;
  - (i) Introduction of draft resolutions was limited to written form;
- (k) Member States were strongly encouraged by the Bureau, and respected the request, not to introduce new draft resolutions, given the constraints.
- 71. Building on the incremental improvements in the Committee's working methods since the seventieth session and General Assembly decisions 74/537 and 75/548 B, other measures that were applied included:
- (a) The holding of an informal virtual pre-session briefing on the substantive and organizational preparations for the session;
- (b) Early identification of, and Bureau briefings to, facilitators/co-facilitators of draft resolutions;

- (c) Continuation of the practice introduced during the seventy-third session of establishing a comprehensive calendar of informal consultations by facilitators/co-facilitators on all draft resolutions, available on the e-deleGATE platform and continually updated in real time;
- (d) Strict implementation of time limits during in-person and virtual meetings and clear communication and implementation of submission deadlines;
- (e) Full use of the e-deleGATE platform, including its e-Speakers, e-Sponsorship and e-Submission modules, to make available updated information on a daily basis.
- 72. In addition, as Chair, I conducted outreach to groups and individual delegations in advance of and during the session. The Bureau introduced useful practices, such as the circulation of agreed minutes of Bureau meetings and common cover messages, and the sharing of procedural notes for the Chair. The practice of electing the Rapporteur of the Committee from the delegation that provided the Chair of the previous session has provided important continuity to the work of the Bureau. At the seventy-sixth session, on a pilot basis, the Secretariat prepared one-page informal summaries of the reports of the Secretary-General, a practice which was welcomed by some delegations.
- 73. These measures, taken together with the hard work, commitment and constructive engagement of Second Committee delegates, resulted in the Committee concluding its work one day ahead of the mandated recess date, namely on 23 November 2021.
- 74. While applauding our commendable collective achievement, it is worth noting that there remain challenges for the Committee to address.
- 75. Many delegations noted that negotiations on draft texts remain at times challenging, in part owing to their large number. In this regard, it is worth highlighting the importance of efforts to ensure that the Committee's traditional practice of adopting the vast majority of proposals before it by consensus is preserved.
- 76. Regarding further discussions on working methods, through the adoption of General Assembly decision 76/546, it was decided that the Second Committee Bureau would convene up to two informal meetings to discuss the Committee's working methods in early 2022, and the Assembly requested the Bureau of the Second Committee to update the conference room paper on Second Committee working methods following those discussions. The informal meeting was held on 7 April, following which the Bureau finalized the conference paper circulated to delegations in A/C.2/76/CRP.4.<sup>1</sup>
- 77. Moving forward, I believe there are many opportunities ahead for the next Bureau of the Committee when it meets again in the fall. After having encountered many restrictions that prevented us from considering draft resolutions in full, I hope that at the seventy-seventh session those restrictions will no longer be needed. As an encouraging sign, delegations have recently been able to negotiate, in full, outcome documents for the various Economic and Social Council subsidiary bodies and the upcoming High-level Political Forum. Let us thus work towards a fresh start for the Committee at the seventy-seventh session, at which we can discuss all resolutions in their entirety and update them with most recent political guidance, in line with the mandate of the main committees of the General Assembly. The Assembly must make its voice heard as the world experiences overlapping crises that undermine progress towards the Sustainable Development Goals. The Committee must provide evidence-based, innovative policy recommendations on the major issues on its agenda, reflecting the challenges we face today.

### IV. Update submitted by the Secretary of the Third Committee

- 78. The Third Committee held a total of 45 meetings, 16 in-person meetings and 29 virtual informal meetings to hold interactive dialogues with special mandate holders and other experts and concluded one day ahead of schedule. The number of meetings was similar to that in 2020 (44) but significantly below the pre-pandemic average of 54 meetings since the sixty-seventh session, mainly owing to the holding of a single general debate instead of the general discussions of individual items or clusters. A total of 230 informal consultations were held, a number similar to the pre-pandemic average of 235 since the sixty-seventh session.
- 79. For the second year, the Bureau, in consultation with the membership, proposed revised modalities for the work of the Committee during the session, taking into account the health and safety guidelines implemented at Headquarters. The lessons learned from these temporary and extraordinary measures could be considered in further rationalizing the work of the Committee.
- 80. A single general debate of the Committee was held through six formal meetings, with in-person, virtual or pre-recorded video statements, in lieu of separate general discussions on each agenda item or cluster of items. There was an option to submit longer versions of the statements in writing.
- 81. Statements made during the general discussion were limited to six minutes for individual delegations and eight minutes for delegations speaking on behalf of a group of States. Previously, groups had as much as 12 minutes in the general discussions of items prior to 2020, and, considering the increasing number of group statements in the Committee, the time limits for groups during these discussions could continue to be rationalized with a view to further improving time management.
- 82. The interactive dialogues with special mandate holders and other experts and United Nations officials took place through virtual informal meetings using the Zoom platform with remote simultaneous interpretation. The modalities of these dialogues remained consistent with the practice of the Committee. The Committee heard and interacted with a total of 65 special rapporteurs, independent experts and chairs of working groups of the Human Rights Council, as well as introductions of reports by and dialogues with Secretariat officials. A total of 1,184 statements were made in the interactive dialogues that ensued, which is the highest number ever in the Committee and significantly more than the average of 504 statements since the sixty-seventh session. The increase in participation can, at least partly, be attributed to the virtual format of the meetings. In 2008, the Committee heard approximately 25 special rapporteurs and other special mandate holders reporting to it. That number has more than doubled, while the number of meetings allocated to the Committee remains unchanged, posing a challenge to the ever tightening eight-week schedule.
- 83. Each special procedure mandate holder was given a total of one hour for their presentation and interactive dialogue with the Committee. Owing to the large number of requests for the floor during the dialogues, the default time was three minutes per intervention; however, this was reduced to one minute if necessary. While the variable time limit lacks predictability, it is the only solution to ensure that all those requesting the floor can speak. The shorter time limits could also promote greater interactivity with direct comments or questions instead of prepared statements.
- 84. For the first time, two combined briefings by special rapporteurs and other experts were held, in consultation with the presenters and ensuring thematic coherence. These combined briefings with a single interactive dialogue enhanced the quality of the discussions and increased the efficiency of the Committee's work.

Prepared statements should continue to be discouraged in the interactive dialogues in favour of questions and unscripted comments directed at the presenters.

- 85. The Committee adopted 63 proposals, comprising 62 draft resolutions and one draft decision on its programme of work for the seventy-seventh session of the General Assembly. A total of 18 draft resolutions were adopted by recorded votes, which was one less than the previous year. Only two amendments were considered, with both rejected. Three draft resolutions resulted in the issuance of programme budget implications statements. Action on draft proposals occurred through in-person formal meetings.
- 86. Generally, the number of resolutions adopted by the Committee in recent years has varied, reaching a high of 71 resolutions at the sixty-eighth session and a low of 50 resolutions at the seventieth and seventy-fifth sessions. Increasing the periodicity of reports and draft resolutions was one of the key recommendations of the Bureau at the seventy-fourth and seventy-fifth sessions. The Bureau also continued to strongly discourage the introduction of draft proposals unless it was in respect of a new draft resolution and encouraged main sponsors to make only a single short statement prior to action on the draft. None of the 62 draft resolutions were formally introduced.
- 87. In terms of its agenda, 15 items (including 14 sub-items) were allocated to the Committee; all items are considered annually. The submission of some reports and draft resolutions have been progressively biennialized over the past few years, and the Bureau recommends that the Committee proceed further in this direction. At the seventy-fourth session, the consideration of the draft resolution on the "Rights of the child" was biennialized. Since the sixty-eighth session, two sub-items have been biennialized or triennialized.
- 88. Some agenda items are traditionally clustered for example the human rights sub-items (a) to (d) and other items are considered jointly. Despite the clustering or joint consideration of items, delegations may still make separate statements under each item or sub-item if so desired.
- 89. The intense and tight programme requires strict adherence to the agreed resolution deadlines and to the speaking time limits, with automatic microphone cut-offs.
- 90. As regards the e-deleGATE portal, the Committee continued to utilize the e-sponsor, e-submissions, e-speakers and e-list of participants modules. The online calendar in e-deleGATE also proved beneficial.
- 91. The conference room paper describing the methods of work, originally prepared by the Bureau of the Committee at the sixty-fifth session, has been updated since the seventy-third session and constitutes a reference paper providing detailed information on the working methods of the Committee. The Bureau, at the current session, updated the content of the document which has been shared with the membership (document A/C.3/76/CRP.3).<sup>2</sup> Since the seventy-fifth session, the conference room paper has contained an annex highlighting key recommendations relating to working methods and best practices.
- 92. The Third Committee will continue to examine ways to revitalize its work, as requested by relevant General Assembly resolutions. The Bureau, during the resumed part of the session, meets to consider ways to improve the working methods of the Committee, including through the recommendations agreed upon in the conference room paper on lessons learned and best practices.

### V. Update submitted by the Chair of the Fifth Committee (seventy-sixth session)

### A. General ongoing efforts

93. The Fifth Committee continued efforts to identify best practices and lessons learned, and to consider innovative and practical ideas from delegations.

### B. Measures to ensure business continuity

- 94. Based on the practice of the last two sessions, several measures were utilized at the main and first part of the seventy-sixth resumed session given the continued limitations affecting the work of the Committee due to the COVID-19 situation:
- (a) Official formal meetings were limited and were held in person for the general debates on organizational matters, for the introduction of a limited number of items and for taking action on draft resolutions and decisions;
- (b) The introduction of the remaining items, the related statements of the Secretariat and the Advisory Committee on Administrative and Budgetary Questions, and those of the delegations, were all carried out through electronic circulation and publication on the Fifth Committee's website;
- (c) Informal consultations were held virtually, with efforts by the Bureau to enable and support conditions for the holding of physical meetings during the final phase of the negotiations;
- (d) The Committee managed its programme of work in a flexible manner to find the right sequence to handle complex items in order to conclude the negotiations as early as possible and to provide the Secretariat with sufficient time to prepare the necessary documentation for action.
- 95. These measures helped to ensure business continuity under challenging circumstances, eventually resulting in the adoption of the required time-bound outcomes, including the resolutions on the regular budget, programme planning, scales of assessment and other important decisions in good time.
- 96. For the second resumed session, the Fifth Committee generally reverted to the full in-person engagements. The Committee continued to consider the knowledge, insight and experience gained, which can be utilized, where appropriate, to carry out the work of the Committee. This experience, and the related lessons learned, includes the use of a virtual format in some cases for informal-informal consultations, the extensive use of online platforms, a reduction in the volume of printed documentation, electronic circulation of statements and advance circulation of compiled draft resolutions.

### C. Collaboration between the Main Committees

97. The collaboration between the Main Committees of the General Assembly is of great importance for the efficient and effective work of the Fifth Committee. Timely decisions on draft resolutions with programme budget implications allow the Fifth Committee to properly consider the items in question. In this regard, it is important for the plenary and Main Committees to fully comply with rule 153 of the rules of procedure and paragraph 13 (d) of decision 34/401, under which a minimum period of 48 hours is required before action is taken on a proposal so as to allow the Secretary-General to prepare the programme budget implications of proposals before the Assembly. During the seventy-sixth main session, collaboration was also important in dealing with the programme planning items, which are allocated to all Main Committees, as well as the plenary of the General Assembly. This collaboration

and cooperation, under the leadership of the President of the seventy-sixth session of the General Assembly, has been critical in the work of the Fifth Committee.

### D. Consensus-based decision-making

98. As recognized, the work of the Fifth Committee has critical importance for the effective functioning of the Organization, as decisions taken in this Committee provide the United Nations with the administrative and budgetary framework to deliver on the ground. Therefore, it is of vital importance to preserve the consensus-based decision-making practice for taking decisions in the Fifth Committee. In carrying out its work, the Committee continued to place emphasis on ensuring inclusive negotiations, a more efficient use of time allocated for work, and collegiality and team spirit to create the necessary framework for building consensus.

### E. Volume and periodicity of reports

99. Given the large number of agenda items allocated to the Fifth Committee and the related high volume of reports, some of which are deferred from previous sessions, the agenda of the Committee often becomes packed, which sometimes, owing to the limited time available for sessions and specificities of the negotiations in the Committee, does not allow for a proper consideration of all issues contained in the programme of work. Hence, in order to ensure that adequate time is provided to each item, the biennalization of some items without direct and immediate budgetary and administrative implications could be considered as a way forward to reduce the overload in the programme of work of the Fifth Committee's sessions.

### F. Timeliness of documentation and supplementary information

100. Another specific aspect underlying the work of the Fifth Committee is that almost all agenda items involve two or more reports, given the need for each report with administrative and budget implications to be accompanied by a report of the Advisory Committee on Administrative and Budgetary Questions. Consequently, timely provision of these reports in all United Nations official languages and of the supplementary information from the Secretariat is highly important for the work of the Fifth Committee, and for that purpose coordinated efforts with the Secretariat, the Advisory Committee on Administrative and Budgetary Questions and other entities are required. Work must continue towards streamlining the written procedures for questions and responses and to use the time allocated for work more efficiently within the established working hours. Pursuant to General Assembly resolution 74/262, the Fifth Committee has before it the written responses provided by the Secretariat to the Advisory Committee on Administrative and Budgetary Questions. This continues to be used towards eliminating duplication and minimizing the volume of questions raised in the Fifth Committee.

### G. Statistics

101. During its main session, the Committee considered 197 reports, requested a total of 1,764 questions to be answered in writing and recommended 16 draft resolutions and 15 draft decisions that were subsequently adopted by the General Assembly. During the first resumed session, in March, 72 reports were considered, 239 questions were requested to be answered in writing and 4 draft resolutions and 1 draft decision were recommended and subsequently adopted by the General Assembly.

102. The European Union, Group of 77 and China, Canada, Australia and New Zealand and the delegations of the United States and the United Kingdom have provided their views on the issue of improving the working methods of the Committee, which are contained in the enclosure below.

### **Enclosure**

### Comments provided by several delegations on the issue of improving the working methods of the Fifth Committee

### Canada, Australia and New Zealand

- 1. Outside United Nations standard working hours (10 a.m.-6 p.m.), coordinators are trialling virtual meetings, and there is broad agreement that this is a sensible way forward to avoid unreasonable demands on delegates, including United Nations "sleepovers".
- 2. Several delegations, including Canada, Australia and New Zealand, have made proposals to the Committee Chair on limiting negotiating hours from 9 a.m. to 9 p.m. unless absolutely necessary in the final days of a session.
- 3. United Nations Headquarters in New York appears ill-equipped and ill-resourced to provide hybrid meetings, and this must be looked at in the context of ongoing surges in COVID-19 cases among delegations and for pandemic future-proofing as well as for changing ways of working. We understand that the renovations of the United Nations Office at Geneva include meeting rooms with hybrid facilities as standard.
- 4. The biennialization of some items without direct and immediate budgetary and administrative implications may be sensible in some cases to reduce overloaded agendas, but in others it may just postpone a circular discussion rather than help resolve the contentious issues. In addition, we would not want to work at odds with the annual budget and the benefits of shorter feedback cycles.
- 5. Cross-regional working groups on long outstanding items, meeting between Committee sessions, should be encouraged to help break deadlocks ahead of the items being formally negotiated.
- 6. Strong leadership by the Chair, including Chair's texts reflecting broadest possible agreement, when necessary, can greatly assist in bringing matters to a close in a timely manner and have been much appreciated.
- 7. There is a Fifth Committee manual under development which includes a chapter on working methods to clarify and improve procedures.
- 8. Canada, Australia and New Zealand would welcome a dedicated Fifth Committee session to discuss proposals for improving working methods with all delegations.

### **European Union**

- 9. The member States of the European Union appreciate the efforts by the Chair of the Fifth Committee to take stock and describe the current working methods of the Committee during the seventy-sixth session. We share many of the observations and recognize the effort of many to improve the working methods on an ongoing basis. Further to selected remarks within the present enclosure, the member States of the European Union would like to make additional observations to complement the scope of the Chair's letter (see comments at the end of the enclosure). We would like to express our strong commitment to supporting the current and future Chairs of the Committee in their attempts to further improve the working methods of the Committee.
- 10. The member States of the European Union have a strong inclination to point out that the main issues with Committee working methods are unrelated to the effects of the COVID-19 pandemic. In particular, the extension of working hours to weekends and nights and the decision-making processes under severe time pressure were already prevalent before the COVID-19 pandemic. We would like to point out that these factors

severely hamper the transparency and inclusivity of the Committee. Late-hour engagements, weekend meetings or short-notice proposals essentially exclude many delegations from the negotiation process. They also put un unnecessary burden on the families of delegates and cause reputational damage by putting the soundness of decisions into question. To name an example, closing a main session on 24 December at 4 a.m. in the morning shows the inefficiencies and consequences of these issues.

- 11. The member States of the European Union would like to point out that we attach great value to the principle of consensus-based decision-making in the Fifth Committee. We feel that, in order to achieve consensual results in the future, the Committee should make every effort not to re-open decisions or mandates set out by other UN bodies. The Fifth Committee is tasked with a unique responsibility to provide adequate resources for all established mandates. The member States would like to point out that in our view it is a regrettable trend by which we observe more and more decisions being voted upon, because individual delegations challenge broad consensual agreements out of national considerations.
- 12. The member States of the European Union remain steadfast supporters of the annual budget reform. For this reform to achieve its full potential, we must further strengthen the principle of delegation of authority within the Organization and commit to a higher degree of independence and managerial authority by the Secretary-General. The format and length of budget documents warrant a specific and focused debate, which has been ongoing for several years. The member States of the European Union are convinced that adding ever more detailed information into the reports will not lead to a smoother budget process, but rather the opposite. As this discussion will be part of the review of the annual budget, which will be taken up by the Committee in the next main session, we will only make some cursory remarks on this issue at the end of the present enclosure.
- The member States of the European Union continue to make a great effort to reduce the overall number of questions during our deliberations. The most effective way to achieve this is by a detailed study of the reports of the Secretary-General and the Advisory Committee on Administrative and Budgetary Questions and use of the supplementary information from the Advisory Committee. We also emphasize the great importance of oral question and answer sessions and argue that every effort should be made to settle as many open questions as possible during such sessions. For this to become possible, both Secretariat and Member States must show further commitment and preparation. It would also be necessary to increase the exchange between the Fifth Committee and the Advisory Committee in order to reduce misunderstandings and waste of time. This is evident, as a significant number of the questions raised by Fifth Committee delegates relate to recommendations made by the Advisory Committee. It therefore could be more efficient – and we would like to explore this possibility – to have question and answer sessions with the Chair or Vice-Chairs of the Advisory Committee present, as is currently the case when we consider recommendations by the Board of Auditors or the Joint Inspection Unit on specific agenda items.

#### General considerations in addition to the comments above

- 14. The member States of the European Union welcome meetings on organizational matters related to the work of the Fifth Committee held in the past and call for additional informal meetings on the revitalization of the General Assembly to discuss the improvement of working methods.
- 15. We would encourage the Bureau of the Fifth Committee to produce an informal paper on the working methods of the Committee to be updated annually (as per good

practice identified in other Committees), which could describe current practices and suggestions put forward by delegations to improve working methods.

- 16. Further, in that informal paper, we would like to see a comparison of the number of resolutions and decisions adopted compared with previous sessions and the number of votes called for during a session, with an assessment of their outcome.
- 17. We also encourage every incoming Bureau to continue to meet with the outgoing Bureau to consult on and review issues relating to the efficient functioning of the Committee.
- 18. We welcome the publication of the list of speakers before the beginning of any formal meeting.

### Digital working methods

- 19. We welcome the usage of e-deleGATE, as an important repository of information, together with the website of the secretariat of the Fifth Committee, and we recommend having regular evaluations of that platform in order to improve it and keep it in line with technological advancement and changes in our working methods.
- 20. We welcome the recognition of lessons learned from the digital transition during the COVID-19 pandemic in the Chair's letter. We strongly encourage the Committee to capitalize on the digital tools available, when appropriate, to improve the working methods of the Committee. More specifically, we wish to maintain the important inperson meetings but take advantage of possibilities for virtual participation for certain meetings, including virtual briefings by senior United Nations officials in the interactive dialogues of the Committee.
- 21. The member States of the European Union therefore wish to formalize the consensual understanding that the default format for meetings outside of regular business hours should be virtual, unless specific circumstances lead the facilitator to request otherwise, to avoid unnecessary detrimental impact on the work-life balance of delegates.
- 22. We also encourage the Bureau to provide in the above-mentioned informal paper the lessons learned from the COVID-19 pandemic in terms of working arrangements to prepare for future contingencies.

### Volume of work, timeliness, calendar

- 23. Further to the comments made in the text, the member States of the European Union encourage a much-needed reflection on how to improve the Committee's working hours. We need to use the time within the regular programme of work more efficiently, and the Committee should avoid an excessive amount of meetings in pre-mornings, over lunch and after-hours, as well as weekends and at night.
- 24. We therefore also encourage a review of the calendar of the main session and the second resumed session, which are recurrently extended every session.
- 25. We would also like to further explore the possibility of organizing joint briefings by the Secretariat on thematic clusters to allow for more time efficiency and avoid repetition (for example payments to troop- and police-contributing countries, management of liquidity, financial situation and status of assessed contributions).
- 26. We encourage simultaneous distribution of reports of the Secretary-General in all official languages. We also call for a more efficient introduction of reports by introducing more reports in the same slot, including using a virtual format when appropriate.
- 27. The discussion on the volume and periodicity of reports suggests the biennalization of some items, without direct and immediate budgetary and

- administrative implications. We think this proposal is worth considering in a specific meeting to better understand which items could indeed be biennialized or triennialized.
- 28. We encourage reaffirming time limits on statements (in a national capacity and on behalf of a group) and their strict implementation, and we encourage starting and ending plenary meetings on time for better planning.
- 29. Further to the comments made above on the presentation and length of reports by the Secretary-General, we would like to consider providing stronger (non-binding) guidance on page or word limits for reports of the Secretary-General.
- 30. We recognize the challenges posed to ensuring multilingualism in our informal discussions, especially in virtual meetings and after hours, and encourage further efforts in that regard.
- 31. We welcome the Chair's encouragement towards a timelier provision of reports of the Advisory Committee on Administrative and Budgetary Questions in accordance with rule 153 and emphasize a general need to address the late submission of documentation, which remains a perennial problem for the Committee that has a negative impact on its ability to conclude deliberations in a timely manner and limits the possibility to properly debate issues at hand. We encourage the Bureau to organize discussions regarding the problem and aiming at addressing its causes.
- 32. In addition to the comments made above, we emphasize the need to reduce the number of questions submitted by the Committee for written answers and encourage further progress in that regard. Numbers from the current session should be highlighted and statistics tracked over time.
- 33. We also recommend considering early, more comprehensive and easier access (via e-deleGATE) of the Committee to the questions asked by the Advisory Committee on Administrative and Budgetary Questions and answers given to the Advisory Committee by the Secretariat, with a view to limiting redundancy in the process and using in full the assistance of the Advisory Committee as the advisory body to the Fifth Committee.

### **Informal consultations**

- 34. Informal consultations could start with an informal exchange on the relevant report of the Secretary-General and a clear identification by the Secretariat of where the challenges lie, before delegations move to questions and answers (limiting the number of questions submitted in writing and allowing for substantive negotiations to begin earlier).
- 35. We encourage the recognition of the important work of facilitators to lead text-based informal consultations on draft resolutions, their timely appointment as early as possible at the beginning of the session, and the provision of training opportunities and guidelines on how the facilitator role can be played in an active way with the aim of leading the negotiation process to a successful outcome.
- 36. We also encourage reviewing the processes of informal consultations (for example language readings page by page, standardization of skeletal documents) on the basis of best practices.
- 37. The member States of the European Union would also like to encourage maximum adherence, by all groups and delegations, to deadlines set by the facilitator vis-à-vis the Committee and the Secretariat.

### Relationship with other entities

- 38. We reiterate the importance of achieving greater coherence and coordination in the work of the Fifth Committee with other Main Committees, including on the anticipation of programme budget implications.
- 39. We also encourage an increased engagement between the Fifth Committee and the Advisory Committee on Administrative and Budgetary Questions. A broad number of the questions raised by the Fifth Committee relates to recommendations made by the Advisory Committee, so it would be helpful to re-introduce the practice of holding question and answer sessions with, or in the presence of, the Advisory Committee, as stated in the comments above.
- 40. Simultaneous formal and informal meetings between different Committees, subsidiary organs and other relevant entities, especially those that address issues close to the purview of the Fifth Committee, such as the Committee for Programme and Coordination, should be avoided.

### **United Kingdom**

- 41. Circulating Rev.1 documents ahead of sessions has meant that we use Committee time more effectively for discussions on substance.
- 42. Regular engagement between the Fifth Committee and the Chair of the Advisory Committee on Administrative and Budgetary Questions on ensuring the timeliness of reports.
- 43. Encouraging the Advisory Committee on Administrative and Budgetary Questions to streamline/reduce the number of written questions they ask.

### **United States**

44. The Committee would have benefited from an interactive meeting/discussion on the working methods.

### Group of 77 and China

- 45. While the Group recognizes the importance to gain more efficiency in the way to conduct the labours of the Committee, setting a limit in the number of pages for the reports to be considered or even limiting the number of supplementary information requested from the Secretariat should be avoided. Those kind of fixed rules might prove to be counterproductive for the technical analyses conducted by Fifth Committee experts, which quite often require additional data to gain more clarity about the process under examination.
- 46. We would like to note the importance of allocating the programmes at an early stage without recommendations from the Committee for Programme and Coordination, whenever that is the case, to the relevant Main Committees responsible for the mandates that gave rise to those programmes. This proves to be indispensable for the proper consideration of the agenda item entitled "Programme planning" by the Fifth Committee, and thus, the discussions on the proposed programme budget.
- 47. The Group emphasizes the need for an uninterrupted consideration of the proposals related to the peacekeeping operation budgets during the second resumed session of the Committee. We should avoid, by all means, protracting these discussions and jeopardizing the mission-by-mission approach, which ensures a more realistic examination of the budget to be allocated to each mission, instead of proposing overall budgetary reductions, which could be misleading and inaccurate.

### VI. Update submitted by the Chair of the Sixth Committee (seventy-sixth session)

- 48. The input provides an overview of the ways in which the Sixth Committee, during the seventy-sixth session has carried out its functions, taking into account, as appropriate, the relevant parts of General Assembly resolutions on the revitalization of the work of the General Assembly, especially resolution 75/325, and best practices and lessons learned from the recent developments with a view to further improving working methods.
- 49. In leading the work of the Committee, the Chair and Bureau members proceeded from the understanding that the consideration of working methods is essential for effective, efficient and transparent conduct of the work of the Main Committees of the General Assembly in accordance with their mandate and purpose and have, therefore, assigned priority to continuing the Committee's attention to enhancement of its working methods, working with the secretariat, in consultation with Member States, building on earlier efforts and in accordance with relevant Assembly resolutions on the revitalization of the Assembly.
- 50. The past two years posed particularly complex challenges to the Sixth Committee, as they did to other United Nations bodies, owing to the unprecedented effects of the global COVID-19 pandemic. The Bureau, with support from the Secretariat, undertook appropriate measures on the understanding that they will not constitute a precedent for future sessions in order to enhance business continuity and adapt to the special circumstances, while acting in accordance with guidelines by the United Nations medical service and the leadership of the President of the General Assembly. Luckily, this session was marked by a positive trend and fewer restrictions.
- 51. Despite these challenges, during the main part of the seventy-sixth session, the Committee continued to be disciplined in undertaking the items allocated to it by the General Assembly and completing its programme of work by the target date of 19 November 2021 fixed by the General Committee for the completion of the work of the Sixth Committee, while working within the conference management and Secretariat resources made available to the Committee.
- 52. The Bureau of the Committee started coordinating early, before the beginning of the seventy-sixth session, bearing in mind the prevailing special circumstances, and benefitted from a joint meeting with the Bureau of the Committee at the previous session.
- 53. In keeping with this annual practice of holding joint meetings between the outgoing and the incoming Bureaux of the Committee, I, as the Chair of the Committee, convened on 5 August 2022 a meeting of the Bureau of the Committee for the seventy-sixth session with the Bureau-elect of the Committee for the seventy-seventh session, chaired by Pedro Comissário Afonso. The meeting was an excellent opportunity to share experiences and liaise with the incoming Bureau. In it, the outgoing Bureau presented a quick overview of the ways in which the Committee has carried out its functions and the best practices and lessons learned that they thought may be of interest to the incoming Bureau. I assured the Chair-elect that I would remain at his disposal for any further questions or inquiries.
- 54. The programme of work was adopted on 6 October 2021 on the basis of the draft that had been adopted by the Committee during the seventy-fifth session.
- 55. The Committee held 29 meetings in person for the debate on agenda items and introduction of, and taking of action on, draft resolutions and draft decisions.
- 56. In view of the limited conference services available to the Committee, the working groups meetings and informal consultations were accommodated within the

- overall meetings allocated to the Committee and, on an exceptional basis, were held online with remote simultaneous interpretation (for working group meetings) and without interpretation (for informal consultations).
- 57. The Committee adopted 19 draft resolutions and 10 draft decisions. The Committee was successful in adhering to its tradition of adopting resolutions by consensus. During the seventy-sixth session, all resolutions were adopted without a vote.
- 58. The Sixth Committee undertook the consideration of its working methods under the agenda item entitled "Revitalization of the General Assembly". It held the debate on the item before the end of the session, on 10 November 2021, to provide opportunity for enhanced deliberation. Accordingly, the Committee adopted a draft programme of work for the upcoming seventy-seventh session.
- 59. With respect to the improvement of working methods, the Bureau has once again considered the paper entitled "Lessons learned on the working methods of the Sixth Committee", which is an updated version of the paper that was originally prepared during the sixty-eighth session and has since contained proposals and recommendations to improve the Committee's working methods, including 21 recommendations "for the Bureau to consider" and 19 recommendations "for the Secretariat to consider".
- 60. The following are highlights from the Committee's practice during this session in accordance with this paper and some observations thereupon.
- 61. The Bureau attempted to avoid overlap with other forums or the General Assembly plenary meetings related to legal matters such as the considerations of the reports of the International Residual Mechanism for Criminal Tribunals, the International Court of Justice and that of the International Criminal Court, so as not to overburden the legal experts covering the Sixth Committee, especially those from small delegations who have limited resources.
- 62. The Bureau continued a number of innovative practices that were introduced during the previous sessions, especially the seventy-fifth session. These include imposing a deadline for inscriptions on the list of speakers. This is practiced in the other Main Committees and allows for the distribution of the list of speakers ahead of time.
- 63. Finally, a time limit was set for statements by individual delegations and on behalf of groups, and delegations' speaking time slots were strictly observed, a practice also followed by other Main Committees which allows for adhering to the allotted time frame.
- 64. It is worth mentioning that these were issues about which the Sixth Committee had held back for some time, given the unique and important nature of its work, which has an effect on international law. However, with increased flexibility and deliberations and commitment to enhancing the working methods, delegations have been able to agree on taking these previously unattainable steps.
- 65. The Committee employed the e-Delegate platform effectively to distribute draft resolutions, enable co-sponsorship of draft resolutions, provide for inscription on the lists of speakers and facilitate communication among delegates. The Committee's own web site was also fully utilized and offered rich, real-time information thanks to prompt efforts by the secretariat.
- 66. In accordance with paragraph 29 of General Assembly resolution 75/325, in which the Assembly "invites the Chairs of the Main Committees to continue briefing the Ad Hoc Working Group during the seventy-sixth session on any best practices and lessons learned with a view to improving working methods", I, in my capacity as Chair of the Sixth Committee, delivered an oral briefing before the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly during the thematic debate on "Working methods" held on 11 May 2022.

67. Finally, I would be remiss not to commend my co-members of the Bureau for their diligent efforts. In addition, none of our work would have been possible without the commendable support of the Secretary of the Committee and the rest of the Secretariat, including the team in the Department for General Assembly and Conference Management.
