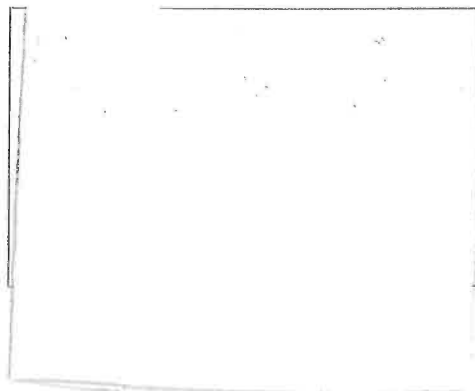

**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
THE DOMINICAN REPUBLIC AND THE ISLAMIC REPUBLIC OF PAKISTAN**

18 November 2022

The Dominican Republic and the Islamic Republic of Pakistan in keeping with the interests and desire between the peoples of two countries, have decided to establish diplomatic relations at the Ambassadorial level, effective from the date of signature of this communiqué.

The two Governments are desirous to enhance friendly relations between the two countries on the basis of the principles of mutual respect for sovereignty and territorial integrity, non-aggression, non-interference in each other's internal affairs, equality, mutual benefit and peaceful coexistence.

The Governments of the Dominican Republic and the Islamic Republic of Pakistan have agreed to exchange Representatives as early as possible and to provide each other with all the necessary assistance for the establishment of diplomatic relations and their performance of function on a reciprocal basis in accordance with the Vienna Convention on Diplomatic Relations of 1961 and international customary practices.

The undersigned, being duly authorized by their respective Governments, signed this communiqué on 18 November 2022 in New York, in two originals, Spanish and English, two text being equally valid.

**COMUNICADO CONJUNTO
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMÁTICAS ENTRE
LA REPÚBLICA DOMINICANA Y LA REPÚBLICA ISLÁMICA DE PAKISTÁN**

18 de noviembre 2022

La República Dominicana y la República Islámica de Pakistán, de acuerdo con los intereses y deseos entre los pueblos de los dos países, han decidido establecer relaciones diplomáticas a nivel de Embajadores, a partir de la fecha de la firma de este comunicado.

Los dos Gobiernos están deseosos de fortalecer las relaciones amistosas entre los dos países sobre la base de los principios de respeto mutuo a la soberanía e integridad territorial, no agresión, no injerencia en los asuntos internos del otro, igualdad, beneficio mutuo y convivencia pacífica.

Los Gobiernos de la República Dominicana y la República Islámica de Pakistán han acordado intercambiar Representantes lo antes posible y prestarse mutuamente toda la asistencia necesaria para el establecimiento de relaciones diplomáticas y el desempeño de sus funciones sobre una base recíproca de conformidad con el Convención de Viena sobre Relaciones Diplomáticas de 1961 y prácticas consuetudinarias internacionales.

En fe de lo anterior, los suscritos representantes, debidamente autorizados por sus respectivos Gobiernos, firman el presente comunicado conjunto en Nueva York, a los dieciocho (18) días del mes de noviembre de dos mil veintidós (2022), en dos originales, español e inglés, siendo igualmente válidos los dos textos.
