JOINT COMMUNIQUÉ ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE KINGDOM OF BAHRAIN AND THE KINGDOM OF TONGA

The Government of the Kingdom of Bahrain and the Government of the Kingdom of Tonga,

Desirous of strengthening the bonds of friendly relations and developing bilateral cooperation between their two countries and peoples in the political, economic, trade and cultural fields and other fields of mutual interests,

Based on the principles of mutual respect for territorial integrity and non-intervention in the internal affairs of each other, as well as norms of the international law and the objectives and principles of the United Nations Charter.

Have decided to establish Diplomatic relations between them, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18th April, 1961, as of the date of the signing of this Joint Communique'.

The Government of the Kingdom of Bahrain and the Government of the Kingdom of Tonga express their assurances that the establishment of diplomatic relations corresponds to the national interests of both countries and will consolidate international peace and cooperation.

In witness thereof, the undersigned representatives, duly authorised by their respective Governments, have signed this Joint Communique in two original copies, each in Arabic and English languages, both texts being equally authentic. In case of divergence, the English text shall prevail.
