Desirous of promoting mutual understanding and strengthening the bonds of friendship and cooperation in areas of mutual interests between their two countries and people;

Reaffirm their commitment to the principles and purposes enshrined of the Charter of the United Nations and of international law, including the sovereign equality of States, territorial integrity, and non-interference in the internal affairs of States;

Convinced that the establishment of diplomatic relations corresponds to the interests of both countries and will further strengthen international peace and security;

Have decided to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communiqué;
