### **Proposed dates of the meetings and segments of the Economic and Social Council in 2024**

The Economic and Social Council, recalling General Assembly resolution [75/290](#) A of 25 June 2021 on the review of the implementation of Assembly resolution [72/305](#) on the strengthening of the Council and the review of the implementation of Assembly resolutions [67/290](#) on the format and organizational aspects of the high-level political forum on sustainable development and [70/299](#) on the follow-up and review of the 2030 Agenda for Sustainable Development at the global level, bearing in mind the importance of timely preparations and planning for the 2024 session of the Council, and noting that a final decision on the working arrangements for the 2024 session of the Council is expected to be adopted at the organizational session of the 2024 session, on 27 July 2023, recommends that the youth forum in 2024 be held for a duration of three days, and also recommends the proposed dates of the meetings and segments of the Council contained in the annex to the present decision for possible approval at the organizational session of its 2024 session.
