The Republic of Trinidad and Tobago and the Republic of Uzbekistan,

Guided by a shared willingness to promote mutual understanding and the strengthening of friendship and cooperation;

Reaffirming their commitment to the principles and purposes of the Charter of the United Nations and of international law, including the sovereign equality of States, territorial integrity, and non-interference in the internal affairs of States;

Convinced that the establishment of diplomatic relations corresponds to the interests of both States and will further strengthen international peace and security;

Have decided to establish diplomatic relations, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the date of signature of this Joint Communiqué.
