PROGRAMME BUDGET FOR THE BIENNIUM 1982-1983

Consolidated statement of administrative and financial implications in respect of conference servicing costs

Statement submitted by the Secretary-General in accordance with
rule 153 of the rules of procedure of the General Assembly

1. In accordance with the established procedure, statements of financial implications in respect of conference servicing have been provided to the Fifth Committee during the current session of the General Assembly on the basis of full costing, i.e., on the assumption that no part of the conference-servicing requirements would be made available from within existing resources and therefore would have to be provided through recruitment of temporary staff.
2. It was indicated at the same time that, towards the close of the session of the General Assembly, a consolidated statement would be prepared, through which net additional resources in conference-servicing requirements would be requested in the light of the calendar of conferences for the year 1983 as finally approved by the General Assembly.
3. Statements of financial implications in respect of the year 1983 issued during the thirty-sixth and thirty-seventh sessions of the General Assembly have contained estimates of conference servicing requirements up to a total amount of \$28,924,500 of which \$20,139,800 relates to Headquarters, \$5,024,300 to Geneva and \$3,760,400 to Vienna.
4. Annex I to the present report contains a recapitulation of all the statements of financial implications involved, showing the respective estimates of full conference servicing costs broken down into interpretation, documentation and other requirements.

5. Any further conference servicing costs which may be contained in statements of financial implications issued after this statement is prepared will be taken into consideration either in the context of the statements themselves or in the second performance report to be submitted to the General Assembly at its thirty-eighth session.

Headquarters

6. The basis for estimating temporary assistance requirements is the available level of permanent resources at the time the service is required. The weekly capacity of the permanent staff in the interpretation sections, with the exception of Arabic, is estimated at 70, ^{1/} so that when the weekly meeting schedule exceeds 70 meetings in any of the five languages, additional free-lance interpreters are required for that specific week. The capacity of the Arabic Section is set at 50 meetings per week. When the weekly meeting schedule exceeds that number, temporary assistance is required.

7. While easier to calculate for interpretation, similar considerations apply to translation, typing and reproduction. The relevant considerations in these processes are the amounts of material that can flow through during a given period. In this connection, it should be pointed out that, to a considerable extent, the volume of that flow is not under the control of the Department of Conference Services; the work-load at a certain time is determined by both the total volume of documentation and the available time to process it. For this reason, peak periods of meetings activity also create the need for additional temporary staff for the documentation processes.

Interpretation

8. The table in annex II shows those weeks outside the General Assembly period during 1983 when more than 70 meetings and/or more than 50 meetings requiring Arabic are scheduled at Headquarters. On that basis, a total of 739 work-weeks of temporary assistance in interpretation will be required as follows:

The estimated cost, including travel and subsistence, is \$1,822,800.

9. An additional team of 20 interpreters (4 Arabic, 4 Chinese, 3 each English, French, Russian and Spanish) will also be required for a period of 10 weeks during the thirty-eighth session of the General Assembly to provide interpretation to meetings of regional groups, informal consultations and sessional working groups, which is estimated at \$431,900.

Documentation

10. While the spring has always been the period of most intense conference activity, that period has gradually lengthened until, as can be seen from annex II, it runs from the beginning of March until the end of June. During this time, the level of meetings activity is forecast at the same level as during the heaviest period of the General Assembly. The volume of documentation handled by the department during the spring and autumn periods is comparable (see table below). During the period of the General Assembly, however, documentation requirements can be met in an orderly and co-ordinated manner. In contrast, during the spring period, the compelling claims of a number of different organs and intergovernmental bodies render the job more complex and less susceptible to proper planning.

The comparable work-load during the period of March to June 1982 amounted to 26,560,400 words. In order to deal with the documentation and summary records anticipated during this period of high volume and short deadlines, 612 translator/reviser work-weeks and 540 typist work-weeks would be needed at an estimated cost of \$1,357,500.

11. Verbatim records will be required for (a) the Disarmament Commission, 9 May-3 June (12 reporters, 2 revisers, 12 typists) and (b) Committee on the Peaceful Uses of Outer Space, 20 June-1 July (12 reporters, 2 revisers, 12 typists) in respect of which the cost is estimated at \$233,500.

Other requirements

12. A total of 230 work-weeks of General Service temporary assistance for such categories of staff as conference and meetings servicing officers will be required at an estimated cost of \$62,500. For these staff, as for conference typists, additional workload, while costed as if supplied by temporary staff, is frequently done by regular staff on night or overtime shifts.

13. A further amount of \$421,200 is also necessary to meet requirements under travel and subsistence in connection with the following regional meetings:

- Tenth Regional Cartographic Conference for Asia and the Pacific (Bangkok)
- Seventh UN Congress on the Prevention of Crime and the Treatment of Offenders (ECLA and ESCAP)
- Regional Preparatory Meetings for the International Conference on the Question of Palestine (ECLA and ESCAP)
- International Youth Year (ECLA and ESCAP)
- Regional Symposia in support of the Struggle of the Namibian People (Latin America)

14. The total requirement for 1983 in respect of temporary assistance for meetings is therefore estimated at \$4,329,400, summarized in the following table:

15. The provision under temporary assistance for meetings is estimated at \$4,329,400. The resources available for 1983 in respect of temporary assistance for meetings, after recasting at the new inflation rates as indicated in the first performance report (A/C.5/37/65) are \$471,900. Thus the balance of requirements for 1983 amounts to \$3,857,500. However, the Secretary-General believes that it would be reasonable to take into consideration the element of over-programming when requesting an appropriation. Accordingly, an appropriation of \$3,550,000 is requested at this time under section 29A.

Requirements for Office of General Services

16. The cost of common services for meetings to be held in New York in 1983 is estimated at \$527,300. It is anticipated that the requirements for general operation and security services could be absorbed within the resources available for 1983. However, an amount of \$114,000 for sound engineering and \$49,000 for messengers are requested on the basis of experience in 1982. In addition, an amount of \$37,000 is requested in connection with the shipment of documents for the meetings away from Headquarters as shown in paragraph 13 above. Accordingly, an additional appropriation of \$200,000 under section 28D is requested to meet projected requirements in 1983.

Geneva

17. The table contained in annex III of the present statement shows an overall picture for Conference Services, Geneva, with respect to 1983. The table contains the latest projection of the 1983 work-load made in the light of various decisions taken during the current session of the General Assembly. It further provides a theoretical breakdown of the estimated total work-load between the established posts and the resultant temporary assistance.

18. As seen from the following table which provides comparison of the yearly workload of 1981, 1982 and 1983, it is estimated that the workload for Conference Services, Geneva, will continue to rise in 1983.

The increase projected under interpretation work-loads relates to the additional meetings scheduled to be serviced by Conference Services, Geneva, as shown in annex I, and also to the inclusion of Arabic language services as indicated in document A/C.5/36/54 and Corr.1 and 2.

19. On the basis of this estimate of work-load in 1983, requirements under temporary assistance will amount to \$7,185,300 as costed in the last column of the table in annex III.

20. A further amount of \$584,900 will also be required to meet requirements in travel and subsistence in connection with meetings to be held away from their headquarters as shown below:

- Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders
- Question of Missing and Disappeared Persons (Fourth Field Trip)
- Question of Palestine (ECA, ECWA regional preparatory meetings and International Conference in Paris)
- International Youth Year (ECA and ECWA)
- Special Committee to Investigate Israeli Practices (Field mission)
- Question of Namibia (Hearing/Seminar/Workshop in Europe and International Conference in Paris)

21. Therefore, the total requirements under temporary assistance for meetings are estimated at \$7,770,200.

22. The resources available for 1983 in respect of temporary assistance for meetings, after recosting at new exchange and inflation rates as indicated in the first performance report (A/C.5/37/65), are \$5,963,500. Thus, the balance of requirements for 1983 amounts to \$1,806,700.

23. As is the case at Headquarters, an element of savings may be available through the technique of over-programming, and consequently, the Secretary-General would request at this time an appropriation of \$1,650,000 under section 29B.

Vienna

24. The conference servicing requirements for Vienna under section 29C relate to conferences other than UNIDO, for which provision is made under section 17. No permanent posts have yet been established under this section due to the recent opening of the Vienna International Centre and the fact that the calendar of conferences for the United Nations in Vienna is still in the developmental stage. Thus, conference services are still provided on the basis of temporary assistance, although, in the interest of economy and sound personnel practice, fixed term contracts of longer term are offered in cases where the workload so justifies.

25. The following table provides comparison of the annual workload for 1981, 1982 and 1983:

26. The increase envisaged in 1983 is due to the inclusion of Arabic language services for the subsidiary organs of the Economic and Social Council and the additional conferences and meetings to be held in Vienna based on the decisions taken during the current session of the General Assembly indicated in annex I to this statement.

27. Based on the estimated workload in 1983 shown above, total requirements under Conference Services, Vienna are estimated at \$7,320,000 3/ indicated below:

28. The amount available for 1983, after recosting at new exchange rates indicated in the first performance report (A/C.5/37/65), is \$2,193,800. Therefore, the balance required amounts to \$5,126,200.

29. In view of the possibility that some of the workload could be performed by regular staff of UNIDO, together with an adjustment for over-programming, the Secretary-General would request an appropriation at this time of \$5 million under section 29C.

Summary

30. In summary, an additional appropriation in the amount of \$10,400,000 (including staff assessment) as summarized below is requested for 1983 in the light of the calendar of conferences as approved by the General Assembly at its thirty-sixth and thirty-seventh sessions:

NOTES

1/ This is calculated by multiplying the number of interpreters (23) by the number of assignments per interpreter per week (7) and dividing by the number of interpreters assigned per meeting (2). From the resulting total of 80.5 a reduction of 20 per cent would be appropriate to cover annual and sick leave, holiday and mission travel. In practice, this calculation is limited to 13 per cent, thereby providing for an element of over-programming.
