#### EXAMINATION OF PETITIONS

#### Eighty-eighth report of the Standing Committee on Petitions

Chairman: M. Daniel Massonet (Belgium)

- 1. The Standing Committee on Petitions, composed of the representatives of Belgium, France, India, Syria, the Union of Soviet Socialist Republics, and the United Kingdom, reports that by 16 July 1954 it will have submitted reports on all petitions listed in part A of the annex to the agenda of the fourteenth session of the Trusteeship Council, with the exception of those petitions which are listed in annexes I and II of the present report.
- 2. The reasons why the Committee has been unable to report upon the thirty-two petitions listed in annex I are indicated in the footnotes to the annex. With four exceptions, the Committee recommends that the examination of the petitions listed in annex I be postponed until the fifteenth session of the Council.
- 3. The four exceptions are:
  - (a) Petition from the Ngoa'Ekele Community (T/PET.5/197 and Add.1)

This petition, concerning the Cameroons under French administration, appears as a separate item on the agenda for the fourteenth session of the Council (item 12), and has not been referred to the Committee for examination.

The Committee observes, however, that the petition was dealt with by the Council at its 556th meeting.

The Secretary, Convention Peoples Party (T/PET.6/329 and Add.1)

The Dagomba District Council (T/PET.6/330)

These petitions, concerning Togoland under British administration, were requests for oral hearings - requests which the Council granted during its thirteenth session - and the petitioners were heard by the Council at its 505th and 506th meetings. The Committee recommends that the three petitions be regarded as having been disposed of.

- 4. The twenty-four petitions listed in annex II to the present report are petitions on which the Committee will be unable to submit reports by 16 July 1954, despite the fact that, with few exceptions, it has met daily often twice daily since 17 May 1954. The Committee accordingly recommends that the examination of the petitions listed in annex II be postponed until the fifteenth session of the Council.
- 5. The Committee recommends that the petition from the Vice-President of the Somali Youth League T/PET.11/423 be added to part A of the annex to the agenda. This petition, which concerns Somaliland under Italian administration, was not included in the agenda since it had been received by the Administering Authority less than two months prior to the opening of the fourteenth session. Observations have been received on the petition, however, and the Committee has reported on it.1/
- 6. The Committee finally recommends that the following petition be added to part B of the annex to the agenda, and that it be regarded as having been disposed of:

Petition from Vice-Presidents of the Territorial Council of Somaliland (T/PET.11/L.12)

This petition, concerning Somaliland under Italian administration, was a request for an oral hearing - a request which the Council granted during its fourteenth session - and the petitioners were heard by the Council at its 530th meeting.

7. This report was adopted by the Committee at its 200th meeting, by 4 votes in favour, none against, with 2 abstentions.
