1. Baha'i International Community

#### Dear Mr. Schreiber:

Thank you very much for your letter of 29 February acknowledging receipt of our letter of 23 January in which we expressed the interest of the Baha<sup>i</sup>i International Community in sending Observers to the International Conference on Human Rights to be held in Teheran, Iran, from 22 April to 13 May 1968.

The application which accompanied our letter documented the fact that we are of recognized standing, are international in our structure, and have a demonstrable interest in the items on the provisional agenda for the Conference. To further support the concern that we have for human rights, and some of the action that we have taken and plan to take to promote throughout the world International Year for Human Rights, we enclose the following documentation:

1. The statement "Human Rights are God-given Rights" issued at the Baha'i Intercontinental Conference, Chicago, Illinois, 5-8 October 1967 endorsing the Universal Declaration of Human Rights as well as United Nations Covenants and Conventions on specific rights, and outlining the plans of the Baha'i Communities of North America in commemoration of Human Rights Year.

2. Three pieces of information - a "United Nations and Human Rights Fact Sheet", "Some Questions for Stimulating Discussion on Human Rights", and "Baha'i Quotes on Human Rights" - which were distributed to all Baha'i Communities in the United States to be used in conducting public seminars on the occasion of Human Rights Day, 1967.

3. Copy of the "Extra-News Bulletin for February, 1968 Public Information Newsletter" distributed by the Public Information Department of the National Baha'i Meadquarters, containing information on International Day for the Elimination of Racial Discrimination and the United Nations Declaration and Convention on the Elimination of All Forms of Racial Discrimination.

4. February 1968 Newsletter from NABOHR (North American Baha'i Office for Human Rights) containing considerable information on the activities of Baha'is in the United States in the promotion of human rights.

5. "North American Baha'i Office for Human Rights - Regional Conference Schedule". This sheet provides information on regional human rights conferences sponsored by Baha'i communities in ten cities throughout the United States and a Leadership Seminar on Human Rights at United Nations Headquarters.

6. Programme of the observance held in Westminster Abbey on Saturday, 9 December 1967, 7.30 p.m., in commemoration of the International Year for Human Rights. The Baha'i Community of the British Isles participated in this observance (pp. 9 and 10).

7. "A Baha'i Declaration of Human Obligations and Rights" presented to the United Nations Human Rights Commission, February 1947, by the National Spiritual Assembly of the Baha'is of the United States.

8. A pamphlet, <u>The Baha'i Faith and Human Rights</u>, published and distributed free by the Baha'i Community of the United Kingdom in support of the International Year for Human Rights.

9. A pamphlet, <u>What is Race</u>?, published by the Baha'i Publishing Trust, Wilmette, Illinois for extensive distribution during the International Year for Human Rights. This brochure contains scientifically accurate facts on race and is intended to help racial harmony by dispelling much prejudicial information.

10. Circular letter mailed 12 February to eighty Baha'i national bodies suggesting a variety of activities in support of the United Nations and of International Year for Human Rights.

11. Four small brochures - <u>Basic Facts of the Baha'i Faith, Unity from</u> <u>Diversity, Man; One Family</u>, and <u>The Baha'i Peace Program</u> - containing basic information on the beliefs of the members of the Baha'i International Community and the interest of this organization in the promotion of world peace and the implementation of full human rights as a basis for one world.

I hope that the enclosed documentation will be helpful to the Preparatory Committee in its task of evaluating our application. If you find that we have submitted too much material<sup>1/2</sup> please feel free to use your judgement in submitting only what you believe necessary.

#### Objectives:

- 1. to uphold and to defend human rights in general
- 2. to uphold and to defend the rights of citizens
- 3. to make all efforts and to take all actions for the upholding of human dignity in the political, economic, social and cultural fields

Activities:

- 1. to invite in the Institution all activists and fighters for the upholding of human dignity
- to guide and to disseminate the Universal Declaration of Human Rights, which had been proclaimed by the General Assembly on 10 December 1948, among the Indonesian people
- 3. to make all efforts that government regulations should be formulated in conformity with the Universal Declaration of Human Rights

- 4. to call upon the central and provincial Governments that their actions be in accordance with the spirit of the Universal Declaration of Human Rights

- to make other endeavours in conformity with the rule of law in Indonesia
