

Revitalization of the work of the General Assembly

Report of the First Committee

Rapporteur: Mr. Heidar Ali Balouji (Islamic Republic of Iran)

- 1. At its 2nd plenary meeting, on 8 September 2023, the General Assembly, on the recommendation of the General Committee, decided to allocate item 120 to all the Main Committees for the purpose of discussing their working methods, as well as considering and taking action on their respective tentative programmes of work.
- 2. The First Committee considered the item at its 10th and 30th meetings, on 12 October and 3 November 2023, respectively.¹
- 3. At the 30th meeting, the Chair made a statement and introduced the provisional programme of work and timetable of the First Committee for 2024.
- 4. At the same meeting, the Committee adopted its provisional programme of work and timetable for 2024, as set out in the annex to the present report.

5. The First Committee recommends to the General Assembly the adoption of the following draft decision:
