Evolution of the agenda of the General Assembly

I. Introduction

1. In its resolution [77/335](#) on 1 September 2023, the General Assembly, *inter alia*, recalled the analysis of the agenda of the Assembly published as an outcome of resolution [58/126](#), and requested the Secretariat to prepare a conference room paper during the seventy-eighth session outlining the evolution of the agenda of the Assembly to facilitate deliberations on the further biennalization, triennalization, clustering and elimination of items or on their labelling as items that remain on the agenda for consideration upon notification in accordance with paragraph 4 (b) of the annex to resolution [58/316](#) of 1 July 2004, for the consideration of Member States (para. 34 (a)). The present document has been developed in response to this request. Information on agenda can be found in documents A/xx/251 (agenda), A/xx/252 (allocation) and A/xx/100 and A/xx/100/Add.1 (annotation), with the session number replacing “xx” in the document symbol.

2. The annex to the present document lists agenda items and sub-items according to the allocation, starting with ones considered directly at the plenary and followed by ones allocated to each of the Main Committees. Items and sub-items that are allocated to multiple bodies are listed where the main proposals are made.

3. Owing to the nature of the provision of resolution [77/335](#), the annex covers all items and sub-items that remain mandated for the seventy-eighth and/or future sessions, as long as the outcomes of their consideration are available from past (i.e., seventy-seventh or earlier) sessions, except those on:

- Organizational matters, namely, agenda items 1 through 8;
- Elections and appointments; and
- “Admission of new Members to the United Nations” and “Use of the veto”, which are meant to be considered only when a certain situation arises.

4. Also owing to the nature of the provision of resolution [77/335](#), the numbers in the “# of resolutions and decisions” column in the annex do not include a decision



to merely take note of a report of a Main Committee or defer consideration to a future session and/or include the (sub-)item in the agenda of a future session.

II. Observations

5. It is hoped that the factual information provided in the present document will facilitate deliberations on the further biennalization, triennalization, clustering and elimination of items or on their labelling as items that remain on the agenda for consideration upon notification in accordance with paragraph 4 (b) of the annex to resolution 58/316, pursuant to the provision of resolution 77/335. For example, the items and sub-items of the following nature may be of interest:

- Either an old document or “None” is shown in the column entitled “Last resolutions or decisions if the ‘# of resolutions and decisions’ column shows zero”.¹
- The number in the “# of delegations speaking in debate” column under “Last session on the agenda” is zero.²

6. The numbers in the “Frequency (every X years)” column may aid deliberations on the further biennalization, triennalization, clustering and elimination of items.

7. Items that remain on the agenda for consideration upon notification in accordance with paragraph 4 (b) of the annex to resolution 58/316³ are identified as such under the plenary. Additionally, the item entitled “The situation in Central America: progress in fashioning a region of peace, freedom, democracy and development” remains on the agenda for consideration upon notification by a Member State, pursuant to decision 60/508 of 31 October 2005.

¹ When “None” is shown in this column, the “Comments” column indicates at which session the item or the sub-item was first included in the agenda.

² The numbers in the “# of delegations speaking in debate” column are taken from the most recent session where the chapeau item was on the agenda, even if some of its sub-items have different frequency.

³ This paragraph reads as follows: The items entitled “Question of Cyprus”, “Armed aggression against the Democratic Republic of the Congo”, “Question of the Falkland Islands (Malvinas)”, “The situation of democracy and human rights in Haiti”, “Armed Israeli aggression against the Iraqi nuclear installations and its grave consequences for the established international system concerning the peaceful uses of nuclear energy, the non-proliferation of nuclear weapons and international peace and security”, “Consequences of the Iraqi occupation of and aggression against Kuwait”, and “Declaration of the Assembly of Heads of State and Government of the Organization of African Unity on the aerial and naval military attack against the Socialist People’s Libyan Arab Jamahiriya by the present United States Administration in April 1986” shall remain on the agenda for consideration upon notification by a Member State.

Effective the sixty-third session, the General Assembly stopped including the last item listed above at the request of its sponsor (see A/BUR/63/SR.1, paras. 18-19).
