

## Sustaining Lives, Nurturing Environment: Commitment to a Safe, Clean, Healthy, and Sustainable World

All human beings depend on the environment in which we live. A safe, clean, healthy and sustainable environment is integral to the full enjoyment of a wide range of human rights, including the rights to life, health, food, water and sanitation. Without a healthy environment, we are unable to fulfil our aspirations. We may not have access to even the minimum standards of human dignity.(i) The 2030 Agenda for Sustainable Development explicitly recognises the links between human rights, development and the environment, including biological diversity and climate. The interrelation between environmental sustainability and the different Sustainable Development Goals is based on reducing environmental damage but also on preserving the role of natural resources and ecosystem services in promoting human wellbeing, economic opportunities, and social and ecological resilience.(ii) The triple planetary crisis of climate change, pollution, and biodiversity loss threatens to reverse decades of human development progress, with disproportionate effects on the rights of marginalized or vulnerable people and communities. In turn, these events act as threat multipliers, amplifying conflicts, tensions, structural inequalities and imperiling the 2030 agenda. This critical connection between human rights and our natural world makes the pursuit of environmental justice an urgent priority. Without a clean and healthy environment, economic and social development cannot be sustained. In a world of colliding crises, we cannot afford to address these challenges sequentially. Now more than ever our efforts must focus on root causes through long-term integrated solutions based on stronger environmental laws and expanded protections for people and planet.(iii)

Rajasthan Samgrah Kalyan Sansthan firmly believe that the well-being of all human beings is intricately linked to the environment in which we live. A secure and sustainable environment is not only vital for the enjoyment of basic human rights but also serves as the foundation for a fulfilling and dignified life. Rajasthan Samgrah Kalyan Sansthan's successful initiatives in the domains of food distribution, hygiene awareness, water and sanitation advocacy, promotion of organic farming, and the distribution of fruitful grafted trees has been contributing towards fulfilling fundamental Human Rights through Environmental Stewardship. While Rajasthan Samgrah Kalyan Sansthan and India are actively working towards a safer and more sustainable environment, the interconnected nature of environmental issues calls for a united global effort. Therefore, we appeal to the United Nations to frame comprehensive rules and regulations that every country and organization should implement to ensure a better environment for all. This global framework should encompass:

Common Environmental Standards: The United Nations can play a pivotal role in formulating universal environmental standards that address issues such as air and water quality, waste management, and sustainable land use. These standards can provide a baseline for countries and organizations to adhere to, ensuring a collective commitment to environmental stewardship.

Collaborative Research and Innovation: Encourage global collaboration in research and innovation for sustainable practices. By sharing knowledge and technological advancements, nations can collectively work towards environmentally friendly solutions, promoting a more sustainable future.

Rajasthan Samgrah Kalyan Sansthan remains steadfast in its commitment to creating a safe, clean, healthy, and sustainable environment. We believe that by addressing interconnected issues such as food security, hygiene, sustainable agriculture, and environmental conservation, we contribute to the well-being of communities and the realization of fundamental human rights.
