## **Letter dated 23 February 2024 from the Chair of the Security Council Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism addressed to the President of the Security Council**

In accordance with the relevant resolutions of the Security Council, I have the honour to attach herewith the work programmes of the Security Council Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism (see annex) and the Counter-Terrorism Committee Executive Directorate (see enclosure) for the period 1 January to 31 December 2024.

The activities of the Committee and its Executive Directorate will proceed pursuant to Security Council resolutions 1373 (2001), 1535 (2004), 1566 (2004), 1624 (2005), 1805 (2008), 1963 (2010), 2129 (2013), 2133 (2014), 2178 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2467 (2019), 2482 (2019), 2617 (2021) and 2713 (2023) and all other relevant resolutions and presidential statements of the Council.

The Committee, with the assistance of its Executive Directorate, will (a) remain focused on monitoring, promoting and facilitating the implementation by Member States of resolutions 1373 (2001), 1624 (2005), 2178 (2014), 2396 (2017), 2462 (2019), 2482 (2019) and 2617 (2021) and other relevant Security Council resolutions; (b) continue to facilitate the delivery of technical assistance to States; (c) continue to identify and assess emerging terrorism issues, trends and developments through its engagement with relevant international, regional and subregional organizations, academia, think tanks, civil society and the private sector, including through the Global Counter-Terrorism Research Network; (d) continue to work with the Office of Counter-Terrorism and other subsidiary bodies of the Council; (e) continue to promote respect for human rights and the integration of the gender perspective in the context of counter-terrorism; and (f) continue to contribute to the implementation of the United Nations Global Counter-Terrorism Strategy.

The Committee continues to welcome the support that it receives from Member States, the United Nations Secretariat, and relevant international, regional and subregional organizations and continues to appreciate the assistance of its Executive Directorate.



The Committee would be grateful if the present letter, together with its annex and enclosure, could be brought to the attention of the members of the Council and issued as a document of the Council.

## Annex

### **Work programme of the Security Council Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism for 2024**

#### **I. Introduction**

1. The overarching objective of the Security Council Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism is to ensure the full implementation of Security Council resolution 1373 (2001). The Committee is further directed to address in its dialogue with Member States their efforts to implement Council resolutions 1624 (2005) and 2178 (2014). The Committee is also requested or encouraged to take up additional work under other subsequent relevant Council resolutions and presidential statements.

2. Security Council resolutions 1373 (2001), 1624 (2005), 1963 (2010), 2129 (2013), 2133 (2014), 2178 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2467 (2019), 2482 (2019) and 2617 (2021) and all other relevant resolutions and presidential statements of the Council and decisions of the Committee constitute the guidance for the work of the Committee and its Executive Directorate.

#### **II. Work programme**

3. The Committee will continue to pursue a strategic and transparent approach to its work, taking into account the interim review by the Executive Directorate of the Executive Directorate's mandate. With the support of the Executive Directorate and the Secretariat, the Committee will also continue to streamline its working methods, as appropriate, in order to achieve the priority objectives set forth below.

##### **A. Monitoring, promoting and facilitating the implementation of Security Council resolutions 1373 (2001), 1624 (2005) and 2178 (2014) and the tasks conferred in resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2482 (2019) and 2617 (2021)**

4. The Committee and its Executive Directorate will collaborate actively with Member States to monitor, promote and facilitate the implementation of resolutions 1373 (2001), 1624 (2005) and 2178 (2014) and to implement the tasks conferred in resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2482 (2019) and 2617 (2021), bearing in mind that the Executive Directorate operates as a special political mission under the policy guidance of the Committee; that the neutral, expert assessment of the implementation of resolutions 1373 (2001), 1624 (2005) and 2178 (2014) and other relevant resolutions is the core function of the Executive Directorate; and that the analysis and recommendations

stemming from those assessments are an invaluable aid to Member States in identifying and addressing gaps in implementation and capacity.

5. The Committee, with the support of the Executive Directorate, will consider assessing, as appropriate, Member States' efforts to tackle all forms of terrorism and violent extremism conducive to terrorism, including those on the basis of xenophobia, racism and other forms of intolerance, or in the name of religion or belief.

6. The Committee will also consider information provided by the Executive Directorate on its work to strengthen its assessment process relating to countering the financing of terrorism, including through targeted and focused follow-up visits as complements to its comprehensive assessments pursuant to paragraph 35 of resolution [2462 \(2019\)](#). The Committee's country assessments visit should follow the framework document for Counter-Terrorism Committee visits to Member States ([S/2020/731](#), annex).

7. The Committee, with the support of the Executive Directorate, will consider assessing as appropriate Member States' efforts to ensure the criminalization and prosecution of terrorism offences in accordance with their obligations under international law and to consider promoting national sentencing policies, practices or guidelines for the treatment of offenders in which the severity of penalties for offenders is proportionate to the gravity of offences in accordance with national legislation, while treating those who are being prosecuted for or have been convicted of terrorism offences humanely and respecting their human rights, in accordance with international law, and to consider measures to reduce recidivism, including, where applicable and pursuant to their applicable domestic laws, the rehabilitation and reintegration of prisoners into society.

8. The Committee will continue its consideration of the report of the Executive Directorate, pursuant to paragraphs 11 and 14 of Security Council resolution [2617 \(2021\)](#).

9. The Committee will continue to take stock of the efforts of Member States to implement resolutions [1373 \(2001\)](#) and [1624 \(2005\)](#) and other relevant resolutions through the use of the two updated assessment tools, namely, the revised overview of implementation assessment and the electronic detailed implementation survey. The Committee will consider information provided by the Executive Directorate regarding its work on the use of the updated assessment tools, taking into account the requirements set forth in resolutions [1963 \(2010\)](#), [2129 \(2013\)](#), [2133 \(2014\)](#), [2178 \(2014\)](#), [2185 \(2014\)](#), [2195 \(2014\)](#), [2220 \(2015\)](#), [2242 \(2015\)](#), [2253 \(2015\)](#), [2309 \(2016\)](#), [2322 \(2016\)](#), [2331 \(2016\)](#), [2341 \(2017\)](#), [2354 \(2017\)](#), [2368 \(2017\)](#), [2370 \(2017\)](#), [2388 \(2017\)](#), [2395 \(2017\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#), [2617 \(2021\)](#) and [2713 \(2023\)](#).

10. The Committee will also continue to identify the challenges and needs of each Member State and region, facilitate the delivery of targeted technical assistance upon request, promote good practices and conduct assessment visits upon consent in accordance with the updated framework document for Counter-Terrorism Committee visits to Member States aimed at monitoring, promoting and facilitating the implementation of Security Council resolutions [1373 \(2001\)](#), [1624 \(2005\)](#), [2178 \(2014\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#) and [2617 \(2021\)](#) and other relevant Council resolutions. In this regard, the Committee, with the support of the Executive Directorate, will determine on an annual basis a list of Member States from which the Executive Directorate should request consent to conduct an assessment visit, taking a risk-based approach that acknowledges existing gaps, emerging issues, trends, events and analysis, while also taking into account prior requests by Member States and consent previously expressed, as well as the fact that a number of Member States have never been visited. The Committee, with the support of the Executive

Directorate, may decide, after the adoption of the list, on changes to its composition, as necessary, emphasizing transparency in planning for visits, including by making available its country visit schedule in advance of such visits, and producing the ensuing reports.

11. The Committee will consider information provided by the Executive Directorate on its cooperation with the United Nations Global Counter-Terrorism Compact entities, other relevant United Nations bodies and relevant regional organizations on the continued participation of representatives of those bodies in the Executive Directorate's assessment work and on their continued contribution to the development of recommendations to build Member States' capacity in priority areas.

12. The Chair of the Committee will invite senior officials from assessed Member States to attend relevant Committee meetings and will invite assessed Member States to coordinate with the Executive Directorate and the Office of Counter-Terrorism on the implementation of the Executive Directorate's recommendations. The Committee will, within 12 months of the submission of the initial assessment report to the Committee, consider information provided by the Executive Directorate on steps taken to implement the recommendations of the assessment, bearing in mind differences in capacity and the availability of resources, as well as the need for technical assistance in the implementation of some recommendations. The Committee will further consider recommendations submitted by the Executive Directorate on the need for additional follow-up activities, as appropriate, to further the implementation of assessment recommendations, including, as appropriate, additional technical assistance.

13. The Committee, noting the shortfalls identified in the global surveys on the implementation by Member States of resolutions [1373 \(2001\)](#) and [1624 \(2005\)](#) with regard to the implementation of resolutions, will consider information provided by the Executive Directorate on making the quantitative and qualitative analysis offered by those tools available to Member States, donors, recipients, the Office of Counter-Terrorism and other United Nations agencies for the purpose of designing technical assistance and capacity-building support.

14. The Committee will report to the Security Council orally, through its Chair, at least once a year on the state of the overall work of the Committee and the Executive Directorate, and, as appropriate, in conjunction with the reports by the Chair of the Security Council Committee pursuant to resolutions [1267 \(1999\)](#), [1989 \(2011\)](#) and [2253 \(2015\)](#) and the Chair of the Security Council Committee established pursuant to resolution [1540 \(2004\)](#), and taking into account its efforts to strengthen coordination with other United Nations bodies, facilitate the provision of consent by Member States for country visits and reports and improve the implementation of recommendations, and how its assessments and analytical work have contributed towards improvements in Member States' counter-terrorism efforts. The Council has underscored its intention to hold informal consultations on the work of the Committee at least once a year.

15. The Committee, with the support of the Executive Directorate, will enhance ongoing cooperation with Security Council counter-terrorism bodies, including the Committee pursuant to resolutions [1267 \(1999\)](#), [1989 \(2011\)](#) and [2253 \(2015\)](#) and the Committee established pursuant to resolution [1540 \(2004\)](#), as well as their respective groups of experts, including through joint meetings, enhanced information-sharing, coordination on visits to countries, coordination on facilitating and monitoring technical assistance, and other cooperative measures to assist Member States in their efforts to comply with their obligations under the relevant resolutions.

16. The Committee will, in a timely manner and on a regular basis or when it so requests, consider information provided by the Executive Directorate through its oral

and/or written briefings on its work, including its visits to Member States, the status of its coordination with relevant United Nations bodies, its engagement with relevant non-United Nations actors, the conduct of assessments, its representation of the Committee at different international and regional meetings and other activities, including during planning stages, and conduct an annual review and forecast of activities to facilitate the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#), [2396 \(2017\)](#) and other relevant resolutions. In this context, the Committee, with the support of the Executive Directorate, will continue to hold periodic meetings, including with a regional or thematic focus, for all Member States, and underscores the importance of the Executive Directorate's work to the Committee.

17. The Committee, assisted by the Executive Directorate, will encourage Member States to consider developing comprehensive and integrated counter-terrorism strategies and effective mechanisms to implement them that include attention to the conditions conducive to terrorism, in accordance with their obligations under international law.

18. The Committee, assisted by the Executive Directorate, will also continue to cooperate with Member States and international, regional and subregional organizations and other relevant partners, upon request, to assess and advise on the development of comprehensive and integrated national and regional counter-terrorism strategies and the mechanisms to implement them, in close cooperation with the Office of Counter-Terrorism and other relevant United Nations agencies and United Nations field offices, including the United Nations Office on Drugs and Crime and, as appropriate, through engagement with the United Nations Development Programme, with a view to ensuring the coherence and complementarity of efforts and to avoid any duplication in the effort to further the implementation of resolution [1373 \(2001\)](#) and other relevant resolutions, and to support the balanced implementation of the United Nations Global Counter-Terrorism Strategy.

19. The Committee, with support of the Executive Directorate, will continue to fully take into account the obligation of Member States to refrain from providing any form of support, active or passive, to entities or persons involved in terrorist acts, including by suppressing the recruitment of members of terrorist groups and eliminating the supply of weapons to terrorists, throughout its activities and stress the importance of full and effective implementation of the relevant resolutions and appropriately addressing the issues related to the lack thereof.

20. The Committee, with the support of the Executive Directorate, will consider further deepening the Executive Directorate's cooperation with the Financial Action Task Force and its global network of Financial Action Task Force-style regional bodies in its work to advance the effective implementation of counter terrorist financing recommendations.

21. The Committee will consider information, assessments and analysis provided by the Executive Directorate on: the promotion of international cooperation; the identification of emerging issues, trends and developments relating to resolutions [1373 \(2001\)](#), [1624 \(2005\)](#), [1963 \(2010\)](#), [2129 \(2013\)](#), [2133 \(2014\)](#), [2178 \(2014\)](#), [2195 \(2014\)](#), [2220 \(2015\)](#), [2242 \(2015\)](#), [2253 \(2015\)](#), [2309 \(2016\)](#), [2322 \(2016\)](#), [2331 \(2016\)](#), [2341 \(2017\)](#), [2354 \(2017\)](#), [2368 \(2017\)](#), [2370 \(2017\)](#), [2388 \(2017\)](#), [2395 \(2017\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#) and [2617 \(2021\)](#); and practical ways for Member States to implement the requirements of those resolutions.

22. In accordance with resolution [2396 \(2017\)](#), the Committee will place special emphasis on the need to counter emerging issues, trends and developments, including the financing, planning, preparation or perpetration of terrorist acts and the recruitment of terrorists, including foreign terrorist fighters. In accordance with resolutions [2195 \(2014\)](#) and [2482 \(2019\)](#), the Committee will also continue to address

the nexus between terrorists and transnational organized crime, which has increased in some cases and in some regions.

23. The Committee, with the support of the Executive Directorate, will continue to work on countering the use of the Internet, other information and communications technologies and other emerging technologies, including innovations in financial technologies, products and services, for terrorist purposes, such as recruitment and incitement to commit terrorist acts, as well as the financing, planning and preparation of their activities, while respecting human rights and fundamental freedoms, taking into account Member States' compliance with applicable obligations under international law, and taking note of the need to preserve global connectivity and the free and secure flow of information facilitating economic development, communication, participation and access to information, and stress the importance of cooperation with civil society, the private sector, and other stakeholders in this endeavour.

24. The Committee, with the support of the Executive Directorate, will consider information provided by the Executive Directorate on its work to prevent and counter the use of information and communications technologies, including the Internet, for terrorist purposes, including by developing counter-terrorist narratives and through technological solutions, all while respecting human rights and fundamental freedoms and in compliance with domestic and international law and taking into consideration of the Executive Directorate's cooperation with civil society and the private sector.

25. The Committee, with the support of the Executive Directorate, will continue to raise awareness of the importance of Member State cooperation with investigations, prosecutions, seizure and confiscation as well as the return, restitution and repatriation of trafficked, illicitly exported or imported, stolen, looted, illicitly excavated or illicitly traded cultural property, through appropriate channels and in accordance with relevant legal frameworks as well as with the United Nations Convention against Transnational Organized Crime and the Protocols thereto and relevant regional, subregional and bilateral agreements.

26. The Committee will consider information and proposals provided by the Executive Directorate on its activities to enhance its dialogue and information-sharing with special envoys, the Department of Political and Peacebuilding Affairs and the Department of Peace Operations, including during the planning stages of missions, as appropriate, in relation to the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#) and other relevant Security Council resolutions and decisions.

## **B. Facilitating the delivery of technical assistance to States**

27. The Committee will continue to pay close attention to strengthening the role of the Executive Directorate in facilitating the delivery of technical assistance to Member States by providing its analysis and recommendations for the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#), taking into account the new requirements of resolutions [1963 \(2010\)](#), [2129 \(2013\)](#), [2133 \(2014\)](#), [2185 \(2014\)](#), [2195 \(2014\)](#), [2220 \(2015\)](#), [2242 \(2015\)](#), [2253 \(2015\)](#), [2309 \(2016\)](#), [2322 \(2016\)](#), [2331 \(2016\)](#), [2341 \(2017\)](#), [2354 \(2017\)](#), [2368 \(2017\)](#), [2370 \(2017\)](#), [2388 \(2017\)](#), [2395 \(2017\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#), [2617 \(2021\)](#) and [2713 \(2023\)](#).

28. The Committee, with the support of the Executive Directorate, will make country assessments, recommendations, surveys and analytical products available throughout the United Nations system, especially to the Office of Counter-Terrorism and United Nations agencies, funds and programmes relevant to counter-terrorism, in order to better align United Nations technical assistance and capacity-building with gaps in implementation and capacity identified by the Executive Directorate, as well as to support the balanced implementation of the United Nations Global Counter-



Terrorism Strategy, except when requested by the assessed Member States to keep selected information confidential. The Committee, through the Executive Directorate, will further enhance the sharing of its findings with Member States and relevant counter-terrorism partners, as appropriate and in consultation with international, regional and subregional organizations, the Global Counterterrorism Forum, academia, think tanks, civil society and the private sector, including through improved web access, outreach, workshops, open briefings and utilization of the Global Counter-Terrorism Research Network, noting the importance of its geographical diversity.

29. The Committee, with the support of the Executive Directorate, will consider, as appropriate, relevant Member States' policy and capacity gaps and needs in effectively using evidence collected by the military, also referred to as "battlefield evidence", to facilitate, as appropriate, the provision by the United Nations Global Counter-Terrorism Coordination Compact entities, including the United Nations Office on Drugs and Crime, of training and assistance to Member States' criminal justice sectors and to help Member States develop and implement comprehensive strategies to provide for the proper collection, preservation, sharing and use of "battlefield evidence", consistent with international law.

30. The Committee will also continue to transmit to the Office of Counter-Terrorism, on an annual basis, a thematic summary assessment of gaps identified and areas requiring more action to implement key countering the financing of terrorism provisions of relevant Security Council resolutions for the purpose of designing targeted technical assistance and capacity-building efforts. The summary assessment is prepared by the Executive Directorate on the basis of its reporting and in consultation with the Analytical Support and Sanctions Monitoring Team pursuant to resolutions [1526 \(2004\)](#) and [2253 \(2015\)](#) concerning ISIL (Da'esh), Al-Qaida and the Taliban and associated individuals and entities and taking into account, as appropriate, mutual evaluation reports of the Financial Action Task Force and Financial Action Task Force-style regional bodies, in compliance with paragraph 35 of resolution [2462 \(2019\)](#).

31. The Committee will continue to partner with the Security Council Committee pursuant to resolutions [1267 \(1999\)](#), [1989 \(2011\)](#) and [2253 \(2015\)](#) and with its Analytical Support and Sanctions Monitoring Team on the implementation of relevant Council resolutions.

32. The Committee, assisted by the Executive Directorate and in close cooperation with the Office of Counter-Terrorism, will identify partners and donors that are willing and able to provide technical assistance to Member States, including to priority Member States, to enhance their capacities in implementing the provisions of the relevant Security Council resolutions.

### **C. Identification and assessment of emerging terrorism issues, trends and developments, and engagement with international and regional partners**

33. The Committee will consider information, assessments and analysis provided by the Executive Directorate through its engagement with relevant experts and practitioners in Member States, relevant international, regional and subregional organizations, academia, think tanks, civil society and the private sector, including through the Global Research Network, to advance the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#) and other relevant counter-terrorism resolutions and to promote the analysis of emerging threats, trends and developments, as well as to identify good practices in support of the Committee's efforts to promote the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#), taking



into account the requirements of resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2482 (2019), 2617 (2021) and 2713 (2023).

34. The Committee, assisted by the Executive Directorate, will consider inviting senior officials from Member States, as well as from relevant international, regional and subregional organizations, and key counter-terrorism partners such as the Global Counterterrorism Forum and relevant civil society organizations, academia, think tanks and the private sector, noting the importance of engaging, as appropriate, with women-, youth- and locally focused entities, to address the Committee's plenary meetings on thematic or regional issues relating to the implementation of resolutions 1373 (2001), 1624 (2005) and 2178 (2014), taking into account the requirements of resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2185 (2014), 2195 (2014), 2199 (2015), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2467 (2019), 2482 (2019) and 2617 (2021).

35. The Committee will request the Executive Directorate, in close cooperation with the Office of Counter-Terrorism and other relevant entities, to hold periodic briefings for the wider membership on thematic or regional aspects of the implementation of resolutions 1373 (2001), 1624 (2005) and 2178 (2014), taking into account the requirements of resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2482 (2019) and 2617 (2021).

36. The Committee will consider a list of events and special meetings on themes and issues of common concern and interest to Member States with a view to maximizing the impact of the resolutions and decisions of the Security Council and sustaining the commitment of the international community to combating terrorism in all its forms and manifestations. The Committee will consider necessary follow-up activities based on proposals made by the Executive Directorate upon the review of the outcomes of such meetings and events.

37. The Committee, with the support of the Executive Directorate, will consider, in close cooperation with the Office of Counter-Terrorism, the important roles that victims and their networks can play, including through the credibility of their voices, in countering terrorism.

38. The Committee, with the support of the Executive Directorate, will raise awareness of the threats posed by terrorists' acquisition and use of unmanned aerial systems, to launch attacks or to traffic drugs and arms, and the need for Member States to address those threats.

39. The Committee, with the support of the Executive Directorate, will integrate into its work the impact of terrorism on children and children's rights, as appropriate, especially in regard to issues related to the families of returning and relocating foreign terrorist fighters.

40. The Committee, with the support of the Executive Directorate, will continue to work on recommendations pursuant to the Delhi Declaration on countering the use of new and emerging technologies for terrorist purposes, promote the non-binding guiding principles on the threats posed by the use of unmanned aircraft systems for terrorist purposes, also referred to as the Abu Dhabi Guiding Principles (S/2023/1035, annex), and continue to develop the non-binding guiding principles on the other two themes of the special meeting of the Committee on countering the use of new and emerging technologies for terrorist purposes, held on 29 October 2022, namely

countering terrorist exploitation of information and communications technologies and emerging technologies and the threats and opportunities related to new payment technologies and fundraising methods, with a view to assisting Member States in countering the threat posed by the use of new and emerging technologies for terrorist purposes, including by compiling good practices on the opportunities offered by the same set of technologies to counter the threat, consistent with international human rights law and international humanitarian law.

41. The Committee will consider information provided by the Executive Directorate concerning its work on the implementation of the relevant provisions of resolutions [1963 \(2010\)](#), [2129 \(2013\)](#), [2133 \(2014\)](#), [2185 \(2014\)](#), [2195 \(2014\)](#), [2220 \(2015\)](#), [2242 \(2015\)](#), [2253 \(2015\)](#), [2309 \(2016\)](#), [2322 \(2016\)](#), [2331 \(2016\)](#), [2341 \(2017\)](#), [2354 \(2017\)](#), [2368 \(2017\)](#), [2370 \(2017\)](#), [2388 \(2017\)](#), [2395 \(2017\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#), [2617 \(2021\)](#) and [2713 \(2023\)](#).

#### **D. Coordination and cooperation between the Committee, the Executive Directorate and the Office of Counter-Terrorism**

42. The Committee will consider continuing the close cooperation between the Executive Directorate and the Office of Counter-Terrorism in the development and implementation of whole-of-United Nations initiatives aimed at supporting Member States' efforts to implement relevant Security Council resolutions, noting that the Council directed the Executive Directorate to continue to support those activities and urged the Office and all other relevant United Nations bodies to take into account the Committee's recommendations and analysis in the implementation of their programmes and mandates.

43. The Chair of the Committee will invite the Office of Counter-Terrorism, at the most senior level, to brief the Committee twice a year on the Office's work, especially on progress in incorporating the recommendations and analysis of the Executive Directorate into the implementation of its programmes and mandates. The Chair of the Committee, with the assistance of the Executive Directorate, will conduct follow-up meetings with the Office on coordination with the Executive Directorate and will invite the Office to participate regularly in meetings on relevant issues.

44. The Committee, with the support of the Executive Directorate, will support the work of the Office of Counter-Terrorism by advising its leadership and assisting in the development of counter-terrorism information shared with the Secretary-General and other senior leaders of the United Nations, as well as by supporting and joining the Office's leadership, as appropriate, in preparations for, participation in and the hosting of workshops and conferences.

#### **E. Maintaining dialogue with States on the implementation of resolution [1624 \(2005\)](#)**

45. The Committee will consider information provided by the Executive Directorate on its ongoing engagement and dialogue with Member States, international and regional organizations and civil society on strategies that include countering the incitement of terrorist acts motivated by violent extremism conducive to terrorism and intolerance and to facilitate technical assistance for their implementation, as called for in resolution [1624 \(2005\)](#) and the United Nations Global Counter-Terrorism Strategy. The Committee will also consider information provided by the Executive Directorate, in accordance with resolution [2395 \(2017\)](#), to support Member States and United Nations entities in adopting measures, pursuant to international law, to address conditions conducive to terrorism and violent extremism as and when conducive to

terrorism, in accordance with the United Nations Global Counter-Terrorism Strategy and in coordination with and with the support of the Office of Counter-Terrorism. The Committee, with the support of the Executive Directorate, will also continue to ensure coordination and complementarity with the work being undertaken, including by the Office, to prevent violent extremism, which can be conducive to terrorism, and by the Executive Directorate on resolutions [1624 \(2005\)](#) and [2178 \(2014\)](#) on countering violent extremism, which can be conducive to terrorism.

46. The Committee, with the support of the Executive Directorate, will continue to gather information and facilitate international cooperation to implement the comprehensive international framework to counter terrorist narratives ([S/2017/375](#), annex). Furthermore, the Committee will consider information provided by the Executive Directorate to identify and compile existing good practices, establish strategic partnerships and propose guidelines and new approaches, subject to the guidance of the Committee, on effectively countering terrorist narratives within an international human rights framework, in accordance with resolution [2354 \(2017\)](#).

## **F. Implementing the United Nations Global Counter-Terrorism Strategy**

47. The Committee, on the basis of regular briefings and information provided by the Executive Directorate on its participation in activities within the framework of the United Nations Global Counter-Terrorism Coordination Compact Task Force, will continue its discussions on issues relating to the implementation of the United Nations Global Counter-Terrorism Strategy, bearing in mind General Assembly resolution [77/298](#) and information provided by the Executive Directorate on its work as an entity under the Global Counter-Terrorism Coordination Compact.

48. The Committee, with the assistance of the Executive Directorate, will, through its visits, assessments and analytical work on emerging issues, trends and developments, support Member States and United Nations entities in taking measures, pursuant to international law, to address conditions conducive to terrorism and violent extremism as and when conducive to terrorism, in accordance with the United Nations Global Counter-Terrorism Strategy, in coordination with and with the support of the Office of Counter-Terrorism.

## **G. Promoting respect for human rights in the context of counter-terrorism**

49. The Committee will consider information submitted by the Executive Directorate regarding the effect of terrorism and counter-terrorism measures on children and children's rights, as appropriate, especially with regard to issues relating to the families of returning and relocating foreign terrorist fighters, as well as progress in the further development of activities in the area of promoting respect for human rights in the context of counter-terrorism in order to ensure that all human rights and rule of law issues relevant to the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#) and other relevant resolutions, as called for by the Security Council in its resolution [2617 \(2021\)](#), are addressed as an important component of the Executive Directorate's country visits, assessments and analysis of emerging issues, trends and developments, as well as its facilitation of technical assistance.

50. The Committee, with the support of the Executive Directorate, will continue to integrate gender as a cross-cutting issue throughout its activities, including in country-specific assessments and reports, recommendations made to Member States, the facilitation of technical assistance to Member States and briefings to the Security

Council, as well as its consultations with women and women's organizations to inform its work and, in collaboration with the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women), will conduct and gather gender-sensitive research and collect data on the drivers of radicalization to terrorism for women and the impact of counter-terrorism strategies on women's human rights and on women's organizations.

### **III. Implementing the revised communications strategy**

51. The Committee, on the basis of the suggestions of the Executive Directorate, will continue to implement the revised communications strategy aimed at promoting the visibility of the role and activities of the Committee and the Executive Directorate, including ways to maximize the impact of a range of products, such as the updated global surveys on the implementation by Member States of resolutions [1373 \(2001\)](#) and [1624 \(2005\)](#). In this regard, the Committee will pay special attention to: (a) advocacy and communication efforts pertaining to the continued implementation of recent resolutions; (b) special meetings and open briefings of the Committee; (c) high-level advocacy visits of the Committee, its Chair and the Executive Director of the Executive Directorate; and (d) efforts to counter violent extremism conducive to terrorism and incitement to violence, as called for by the Security Council in its resolutions [1624 \(2005\)](#) and [2178 \(2014\)](#).

# Work programme of the Counter-Terrorism Committee Executive Directorate for 2024

## I. Introduction

1. The work programme of the Counter-Terrorism Committee Executive Directorate for the period from 1 January to 31 December 2024 has been prepared in accordance with the relevant provisions of the report of the Security Council Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism on its revitalization (S/2004/124, annex) and takes into account the work programme of the Committee for the same period.

2. The work programme also takes into account the tasks conferred by Security Council resolutions 1373 (2001), 1624 (2005), 1963 (2010), 2129 (2013), 2133 (2014), 2178 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2467 (2019), 2482 (2019) and 2617 (2021) and all other relevant resolutions and presidential statements of the Council and decisions of the Committee, which constitute the guidance for the work of the Committee and the Executive Directorate.

## II. Work programme

3. The Executive Directorate will assist the Committee in continuing to pursue a strategic and transparent approach to its work. In this regard, the Executive Directorate will take into account the interim review of its mandate. With the support of the Secretariat, it will also continue to streamline its working methods, as appropriate, in order to achieve the priority objectives set forth below.

### A. Monitoring, promoting and facilitating the implementation of Security Council resolutions 1373 (2001), 1624 (2005) and 2178 (2014) and the tasks conferred in resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2482 (2019) and 2617 (2021)

4. The Executive Directorate will support the Committee in collaborating actively with Member States to monitor, promote and facilitate the implementation of resolutions 1373 (2001), 1624 (2005) and 2178 (2014) and to implement the tasks conferred in resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2482 (2019) and 2617 (2021), bearing in mind that the Executive Directorate operates as a special political mission under the policy guidance of the Committee; that the neutral, expert assessment of the implementation of resolutions 1373 (2001), 1624 (2005) and 2178 (2014) and other relevant resolutions is the core function of the Executive Directorate; and that the analysis and recommendations stemming from those assessments are an invaluable aid to Member States in identifying and addressing gaps in implementation and capacity.

5. The Executive Directorate will provide to the Committee, for its consideration, information on its work to assess, as appropriate, Member States' efforts to tackle all forms of terrorism and violent extremism conducive to terrorism, including those on the basis of xenophobia, racism and other forms of intolerance, or in the name of religion or belief.

6. The Executive Directorate will also provide to the Committee, for its consideration, information on its work to strengthen its assessment process relating to countering the financing of terrorism, including through targeted and focused follow-up visits as complements to its comprehensive assessments pursuant to paragraph 35 of resolution [2462 \(2019\)](#). The Committee's country assessments visit should follow the framework document for Counter-Terrorism Committee visits to Member States ([S/2020/731](#), annex).

7. The Executive Directorate will provide to the Committee, for its consideration, information on its work to assess as appropriate Member States' efforts to ensure the criminalization and prosecution of terrorism offences in accordance with their obligations under international law and to consider promoting national sentencing policies, practices or guidelines for the treatment of offenders in which the severity of penalties for offenders is proportionate to the gravity of offences in accordance with national legislation, while treating those who are being prosecuted for or have been convicted of terrorism offences humanely and respecting their human rights, in accordance with international law, and to consider measures to reduce recidivism, including, where applicable and pursuant to their applicable domestic laws, the rehabilitation and reintegration of prisoners into society.

8. The Executive Directorate will continue to assist the Committee in its consideration of the report submitted by the Executive Directorate, pursuant to paragraphs 11 and 14 of Security Council resolution [2617 \(2021\)](#).

9. The Executive Directorate will support the Committee in continuing to take stock of the efforts of Member States to implement resolutions [1373 \(2001\)](#) and [1624 \(2005\)](#) and other relevant resolutions through the use of the two updated assessment tools, namely, the revised overview of implementation assessment and the electronic detailed implementation survey. The Executive Directorate will provide to the Committee, for its consideration, information regarding its work on the use of the updated assessment tools, taking into account the requirements set forth in resolutions [1963 \(2010\)](#), [2129 \(2013\)](#), [2133 \(2014\)](#), [2178 \(2014\)](#), [2185 \(2014\)](#), [2195 \(2014\)](#), [2220 \(2015\)](#), [2242 \(2015\)](#), [2253 \(2015\)](#), [2309 \(2016\)](#), [2322 \(2016\)](#), [2331 \(2016\)](#), [2341 \(2017\)](#), [2354 \(2017\)](#), [2368 \(2017\)](#), [2370 \(2017\)](#), [2388 \(2017\)](#), [2395 \(2017\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#), [2617 \(2021\)](#) and [2713 \(2023\)](#).

10. The Executive Directorate will support the Committee in continuing to identify the challenges and needs of each Member State and region, facilitate the delivery of targeted technical assistance upon request, promote good practices and conduct assessment visits upon consent in accordance with the updated framework document for Counter-Terrorism Committee visits to Member States. In this regard, the Executive Directorate will support the Committee in determining on an annual basis a list of Member States from which the Executive Directorate should request consent to conduct an assessment visit, taking a risk-based approach that acknowledges existing gaps, emerging issues, trends, events and analysis, while also taking into account prior requests by Member States and consent previously expressed, as well as the fact that a number of Member States have never been visited. The Executive Directorate will support the Committee in deciding, after the adoption of the list, on changes to its composition, as necessary, emphasizing transparency in planning for visits, including by making available its country visit schedule in advance of such visits, and producing the ensuing reports.

11. The Executive Directorate will provide to the Committee, for its consideration, information on its cooperation with the United Nations Global Counter-Terrorism Compact entities, other relevant United Nations bodies and relevant regional organizations, on the continued participation of representatives of those bodies in the Executive Directorate's assessment work and on their continued contribution to the development of recommendations to build Member States' capacity in priority areas.

12. The Executive Directorate will assist the Chair of the Committee in inviting senior officials from assessed Member States to attend relevant Committee meetings and in inviting assessed Member States to coordinate with the Executive Directorate and the Office of Counter-Terrorism on the implementation of the Executive Directorate's recommendations. The Executive Directorate will, within 12 months of the submission of the initial assessment report to the Committee, provide information to the Committee, for its consideration, on steps taken to implement the recommendations of the assessment, bearing in mind differences in capacity and the availability of resources, as well as the need for technical assistance in the implementation of some recommendations. The Executive Directorate will submit to the Committee further recommendations, for consideration, on the need for additional follow-up activities, as appropriate, to further the implementation of assessment recommendations, including, as appropriate, additional technical assistance.

13. The Executive Directorate will provide to the Committee, for its consideration, noting the shortfalls identified in the global implementation surveys on the implementation by Member States of resolutions [1373 \(2001\)](#) and [1624 \(2005\)](#) with regard to the implementation of resolutions, information on making the quantitative and qualitative analysis offered by those tools available to Member States, donors, recipients, the Office of Counter-Terrorism, and other United Nations agencies for the purpose of designing technical assistance and capacity-building support.

14. The Executive Directorate will assist the Committee in reporting to the Security Council orally, through its Chair, at least once a year on the state of the overall work of the Committee and the Executive Directorate, and, as appropriate, in conjunction with the reports by the Chair of the Security Council Committee pursuant to resolutions [1267 \(1999\)](#), [1989 \(2011\)](#) and [2253 \(2015\)](#) and the Chair of the Security Council Committee established pursuant to resolution [1540 \(2004\)](#), and taking into account its efforts to strengthen coordination with other United Nations bodies, facilitate the provision of consent by Member States for country visits and reports and improve the implementation of recommendations, and how its assessments and analytical work have contributed towards improvements in Member States' counter-terrorism efforts. The Council has underscored its intention to hold informal consultations on the work of the Committee at least once a year.

15. The Executive Directorate will support the Committee in enhancing ongoing cooperation with Security Council counter-terrorism bodies, including the Committee pursuant to resolutions [1267 \(1999\)](#), [1989 \(2011\)](#) and [2253 \(2015\)](#) and the Committee established pursuant to resolution [1540 \(2004\)](#), as well as their respective groups of experts, including through joint meetings, enhanced information-sharing, coordination on visits to countries, coordination on facilitating and monitoring technical assistance, and other cooperative measures to assist Member States in their efforts to comply with their obligations under the relevant resolutions.

16. The Executive Directorate will provide information to the Committee, in a timely manner and on a regular basis or when it so requests, for its consideration, through oral and/or written briefings on the work of the Executive Directorate, including its visits to Member States, the status of its coordination with relevant United Nations bodies, its engagement with relevant non-United Nations actors, the conduct of assessments, its representation of the Committee at different international



and regional meetings and other activities, including during planning stages, and conduct an annual review and forecast of activities to facilitate the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#), [2396 \(2017\)](#), and other relevant resolutions. In this context, the Executive Directorate will support the Committee in continuing to hold periodic meetings, including with a regional or thematic focus, for all Member States, and underscores the importance of the Executive Directorate's work to the Committee.

17. The Executive Directorate will assist the Committee in encouraging Member States to consider developing comprehensive and integrated counter-terrorism strategies and effective mechanisms to implement them that include attention to the conditions conducive to terrorism, in accordance with their obligations under international law.

18. The Executive Directorate will also assist the Committee in continuing to cooperate with Member States and international, regional and subregional organizations and other relevant partners, upon request, to assess and advise on the development of comprehensive and integrated national and regional counter-terrorism strategies and the mechanisms to implement them, in close cooperation with the Office of Counter-Terrorism and other relevant United Nations agencies and United Nations field offices, including the United Nations Office on Drugs and Crime and, as appropriate, through engagement with the United Nations Development Programme, with a view to ensuring the coherence and complementarity of efforts and to avoid any duplication in the effort to further the implementation of resolution [1373 \(2001\)](#) and other relevant resolutions, and to support the balanced implementation of the United Nations Global Counter-Terrorism Strategy.

19. The Executive Directorate will support the Committee in continuing to fully take into account the obligation of Member States to refrain from providing any form of support, active or passive, to entities or persons involved in terrorist acts, including by suppressing the recruitment of members of terrorist groups, and eliminating the supply of weapons to terrorists, throughout its activities and stress the importance of full and effective implementation of the relevant resolutions and appropriately addressing the issues related to the lack thereof.

20. The Executive Directorate will provide to the Committee, for its consideration, information on its work to further deepen its cooperation with the Financial Action Task Force and its global network of Financial Action Task Force-style regional bodies to advance the effective implementation of counter terrorist financing recommendations.

21. The Executive Directorate will provide to the Committee, for its consideration, information, assessments and analysis on the promotion of international cooperation; the identification of emerging issues, trends and developments relating to resolutions [1373 \(2001\)](#), [1624 \(2005\)](#), [1963 \(2010\)](#), [2129 \(2013\)](#), [2133 \(2014\)](#), [2178 \(2014\)](#), [2195 \(2014\)](#), [2220 \(2015\)](#), [2242 \(2015\)](#), [2253 \(2015\)](#), [2309 \(2016\)](#), [2322 \(2016\)](#), [2331 \(2016\)](#), [2341 \(2017\)](#), [2354 \(2017\)](#), [2368 \(2017\)](#), [2370 \(2017\)](#), [2388 \(2017\)](#), [2395 \(2017\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#) and [2617 \(2021\)](#); and practical ways for Member States to implement the requirements of those resolutions.

22. In accordance with resolution [2396 \(2017\)](#), the Executive Directorate will support the Committee in placing special emphasis on the need to counter emerging issues, trends and developments, including the financing, planning, preparation or perpetration of terrorist acts and the recruitment of terrorists, including foreign terrorist fighters. In accordance with resolutions [2195 \(2014\)](#) and [2482 \(2019\)](#), the Executive Directorate will assist the Committee in continuing to address the nexus between terrorists and transnational organized crime, which has increased in some cases and in some regions.

23. The Executive Directorate will provide to the Committee, for its consideration, information on its work on countering the use of the Internet, other information and communications technologies and other emerging technologies, including innovations in financial technologies, products and services, for terrorist purposes such as recruitment and incitement to commit terrorist acts, as well as the financing, planning and preparation of their activities, while respecting human rights and fundamental freedoms, taking into account Member States' compliance with applicable obligations under international law, and taking note of the need to preserve global connectivity and the free and secure flow of information facilitating economic development, communication, participation and access to information, and stress the importance of cooperation with civil society, the private sector, and other stakeholders in this endeavour.

24. The Executive Directorate will provide to the Committee, for its consideration, information on its work to prevent and counter the use of information and communications technologies, including the Internet, for terrorist purposes, including by developing counter-terrorist narratives and through technological solutions, all while respecting human rights and fundamental freedoms and in compliance with domestic and international law and taking into consideration of the Executive Directorate's cooperation with civil society and the private sector.

25. The Executive Directorate will provide to the Committee, for its consideration, information on its work to raise awareness of the importance of Member State cooperation with investigations, prosecutions, seizure and confiscation as well as the return, restitution and repatriation of trafficked, illicitly exported or imported, stolen, looted, illicitly excavated or illicitly traded cultural property, through appropriate channels and in accordance with relevant legal frameworks as well as with the United Nations Convention against Transnational Organized Crime and the Protocols thereto and relevant regional, subregional and bilateral agreements.

26. The Executive Directorate will provide to the Committee, for its consideration, information and proposals on its activities to enhance its dialogue and information-sharing with special envoys, the Department of Political and Peacebuilding Affairs and the Department of Peace Operations, including during the planning stages of missions, as appropriate, in relation to the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#) and other relevant Security Council resolutions and decisions.

## **B. Facilitating the delivery of technical assistance to States**

27. The Executive Directorate will continue to pay close attention to strengthening its role in facilitating the delivery of technical assistance to Member States by providing its analysis and recommendations for the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#), taking into account the new requirements of resolutions [1963 \(2010\)](#), [2129 \(2013\)](#), [2133 \(2014\)](#), [2185 \(2014\)](#), [2195 \(2014\)](#), [2220 \(2015\)](#), [2242 \(2015\)](#), [2253 \(2015\)](#), [2309 \(2016\)](#), [2322 \(2016\)](#), [2331 \(2016\)](#), [2341 \(2017\)](#), [2354 \(2017\)](#), [2368 \(2017\)](#), [2370 \(2017\)](#), [2388 \(2017\)](#), [2395 \(2017\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#), [2617 \(2021\)](#) and [2713 \(2023\)](#).

28. The Executive Directorate will support the Committee in making country assessments, recommendations, surveys and analytical products available throughout the United Nations system, especially to the Office of Counter-Terrorism and United Nations agencies, funds and programmes relevant to counter-terrorism, in order to better align United Nations technical assistance and capacity-building with gaps in implementation and capacity identified by the Executive Directorate, as well as to support the balanced implementation of the United Nations Global Counter-Terrorism

Strategy, except when requested by the assessed Member States to keep selected information confidential. The Executive Directorate will assist the Committee in further enhancing the sharing of its findings with Member States and relevant counter-terrorism partners, as appropriate and in consultation with international, regional and subregional organizations, the Global Counterterrorism Forum, academia, think tanks, civil society and the private sector, including through improved web access, outreach, workshops, open briefings and utilization of the Global Counter-Terrorism Research Network, noting the importance of its geographical diversity.

29. The Executive Directorate will provide to the Committee, for its consideration, information on its work to consider, as appropriate, relevant Member States' policy and capacity gaps and needs in effectively using evidence collected by the military, also referred to as "battlefield evidence", to facilitate, as appropriate, the provision by the United Nations Global Counter-Terrorism Coordination Compact entities, including the United Nations Office on Drugs and Crime, of training and assistance to Member States' criminal justice sectors and to help Member States develop and implement comprehensive strategies to provide for the proper collection, preservation, sharing and use of "battlefield evidence", consistent with international law.

30. The Executive Directorate will prepare its annual thematic summary assessment of gaps identified and areas requiring more action to implement key countering the financing of terrorism provisions of relevant Security Council resolutions, to be transmitted to the Office of Counter-Terrorism through the Committee, for the purpose of designing targeted technical assistance and capacity-building efforts. The summary assessment is prepared on the basis of CTED's reporting and in consultation with the Analytical Support and Sanctions Monitoring Team pursuant to resolutions [1526 \(2004\)](#) and [2253 \(2015\)](#) concerning ISIL (Da'esh), Al-Qaida and the Taliban and associated individuals and entities, and taking into account, as appropriate, mutual evaluation reports of the Financial Action Task Force and Financial Action Task Force-style regional bodies, in compliance with paragraph 35 of resolution [2462 \(2019\)](#).

31. The Executive Directorate will assist the Committee in continuing to partner with the Security Council Committee pursuant to resolutions [1267 \(1999\)](#), [1989 \(2011\)](#) and [2253 \(2015\)](#) and with its Analytical Support and Sanctions Monitoring Team on the implementation of relevant Council resolutions.

32. The Executive Directorate will assist the Committee, in close cooperation with the Office of Counter-Terrorism, in identifying partners and donors that are willing and able to provide technical assistance to Member States, including to priority Member States, to enhance their capacities in implementing the provisions of the relevant Security Council resolutions.

### **C. Identification and assessment of emerging terrorism issues, trends and developments, and engagement with international and regional partners**

33. The Executive Directorate will provide to the Committee, for its consideration, information, assessments and analysis through the engagement of the Executive Directorate with relevant experts and practitioners in Member States, relevant international, regional and subregional organizations, academia, think tanks, civil society and the private sector, including through the Global Research Network, to advance the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#) and other relevant counter-terrorism resolutions and to promote the analysis of emerging threats, trends and developments, as well as to identify good practices in support of the Committee's efforts to promote the implementation of resolutions [1373](#)

(2001), 1624 (2005) and 2178 (2014), taking into account the requirements of resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2482 (2019), 2617 (2021) and 2713 (2023).

34. The Executive Directorate will assist the Committee in inviting senior officials from Member States, as well as from relevant international, regional and subregional organizations, and key counter-terrorism partners such as the Global Counterterrorism Forum and relevant civil society organizations, academia, think tanks and the private sector, noting the importance of engaging, as appropriate, with women-, youth- and locally focused entities, to address the Committee's plenary meetings on thematic or regional issues relating to the implementation of resolutions 1373 (2001), 1624 (2005) and 2178 (2014), taking into account the requirements of resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2185 (2014), 2195 (2014), 2199 (2015), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2467 (2019), 2482 (2019) and 2617 (2021).

35. The Executive Directorate will assist the Committee, in close cooperation with the Office of Counter-Terrorism and other relevant entities, in holding periodic briefings for the wider membership on thematic or regional aspects of the implementation of resolutions 1373 (2001), 1624 (2005) and 2178 (2014), taking into account the requirements of resolutions 1963 (2010), 2129 (2013), 2133 (2014), 2185 (2014), 2195 (2014), 2220 (2015), 2242 (2015), 2253 (2015), 2309 (2016), 2322 (2016), 2331 (2016), 2341 (2017), 2354 (2017), 2368 (2017), 2370 (2017), 2388 (2017), 2395 (2017), 2396 (2017), 2462 (2019), 2482 (2019) and 2617 (2021).

36. The Executive Directorate will submit to the Committee, for its consideration, a list of events and special meetings on themes and issues of common concern and interest to Member States with a view to maximizing the impact of the resolutions and decisions of the Security Council and sustaining the commitment of the international community to combating terrorism in all its forms and manifestations. The Executive Directorate will also submit to the Committee, for its consideration, necessary follow-up activities based on proposals made by the Executive Directorate upon the review of the outcomes of such meetings and events.

37. The Executive Directorate will provide to the Committee, for its consideration, information on its work, in close cooperation with the Office of Counter-Terrorism, to consider the important roles that victims and their networks can play, including through the credibility of their voices, in countering terrorism.

38. The Executive Directorate will provide to the Committee, for its consideration, information on its work to raise awareness of the threats posed by terrorist's acquisition and use of unmanned aerial systems, to launch attacks or to traffic drugs and arms, and the need for Member States to address those threats.

39. The Executive Directorate will provide to the Committee, for its consideration, information to integrate into its work the impact of terrorism on children and children's rights, as appropriate, especially in regard to issues related to the families of returning and relocating foreign terrorist fighters.

40. The Executive Directorate will assist the Committee in its work on the recommendations pursuant to the Delhi Declaration on countering the use of new and emerging technologies for terrorist purposes, to promote the non-binding guiding principles on the threats posed by the use of unmanned aircraft systems for terrorist purposes, also referred to as the "Abu Dhabi Guiding Principles" (S/2023/1035, annex), and to continue to develop the non-binding guiding principles on the other

themes of the special meeting of the Committee on countering the use of new and emerging technologies for terrorist purposes, held on 29 October 2022, namely countering terrorist exploitation of information and communications technologies and emerging technologies and the threats and opportunities related to new payment technologies and fundraising methods, with a view to assisting Member States in countering the threat posed by the use of new and emerging technologies for terrorist purposes, including by compiling good practices on the opportunities offered by the same set of technologies to counter the threat, consistent with international human rights law and international humanitarian law.

41. The Executive Directorate will provide to the Committee, for its consideration, information concerning its work on the implementation of the relevant provisions of resolutions [1963 \(2010\)](#), [2129 \(2013\)](#), [2133 \(2014\)](#), [2185 \(2014\)](#), [2195 \(2014\)](#), [2220 \(2015\)](#), [2242 \(2015\)](#), [2253 \(2015\)](#), [2309 \(2016\)](#), [2322 \(2016\)](#), [2331 \(2016\)](#), [2341 \(2017\)](#), [2354 \(2017\)](#), [2368 \(2017\)](#), [2370 \(2017\)](#), [2388 \(2017\)](#), [2395 \(2017\)](#), [2396 \(2017\)](#), [2462 \(2019\)](#), [2482 \(2019\)](#), [2617 \(2021\)](#) and [2713 \(2023\)](#).

#### **D. Coordination and cooperation between the Committee, the Executive Directorate and the Office of Counter-Terrorism**

42. The Executive Directorate will provide to the Committee, for its consideration, information on the close cooperation between the Executive Directorate and the Office of Counter-Terrorism in the development and implementation of whole-of-United Nations initiatives aimed at supporting Member States' efforts to implement relevant Security Council resolutions, noting that the Council directed the Executive Directorate to continue to support those activities and urged the Office and all other relevant United Nations bodies to take into account the Committee's recommendations and analysis in the implementation of their programmes and mandates.

43. The Executive Directorate will support the Chair of the Committee in inviting the Office of Counter-Terrorism, at the most senior level, to brief the Committee twice a year on the Office's work, especially on progress in incorporating the recommendations and analysis of the Executive Directorate into the implementation of its programmes and mandates. The Executive Directorate will assist the Chair of the Committee in conducting follow-up meetings with the Office on coordination with the Executive Directorate and in inviting the Office to participate regularly in meetings on relevant issues.

44. The Executive Directorate will assist the Committee in supporting the work of the Office of Counter-Terrorism by advising its leadership and assisting in the development of counter-terrorism information shared with the Secretary-General and other senior leaders of the United Nations, as well as by supporting and joining the Office's leadership, as appropriate, in preparations for, participation in and the hosting of workshops and conferences.

#### **E. Maintaining dialogue with States on the implementation of resolution [1624 \(2005\)](#)**

45. The Executive Directorate will provide to the Committee, for its consideration, information on its ongoing engagement and dialogue with Member States, international and regional organizations and civil society on strategies that include countering the incitement of terrorist acts motivated by violent extremism conducive to terrorism and intolerance and to facilitate technical assistance for their implementation, as called for in resolution [1624 \(2005\)](#) and the United Nations Global Counter-Terrorism Strategy. The Executive Directorate will also provide to the

Committee, for its consideration, in accordance with resolution [2395 \(2017\)](#), information on its support to Member States and United Nations entities in adopting measures, pursuant to international law, to address conditions conducive to terrorism and violent extremism as and when conducive to terrorism, in accordance with the United Nations Global Counter-Terrorism Strategy and in coordination with and with the support of the Office of Counter-Terrorism. The Executive Directorate will support the Committee in continuing to ensure coordination and complementarity with the work being undertaken, including by the Office, to prevent violent extremism, which can be conducive to terrorism, and by the Executive Directorate on resolutions [1624 \(2005\)](#) and [2178 \(2014\)](#) on countering violent extremism, which can be conducive to terrorism.

46. The Executive Directorate will support the Committee in continuing to gather information and facilitating international cooperation to implement the comprehensive international framework to counter terrorist narratives ([S/2017/375](#), annex). Furthermore, the Executive Directorate will provide to the Committee, for its consideration, information to identify and compile existing good practices, establish strategic partnerships and propose guidelines and new approaches, subject to the guidance of the Committee, on effectively countering terrorist narratives within an international human rights framework, in accordance with resolution [2354 \(2017\)](#).

## **F. Implementing the United Nations Global Counter-Terrorism Strategy**

47. The Executive Directorate will regularly provide to the Committee briefings and information on its participation in activities within the framework of the United Nations Global Counter-Terrorism Coordination Compact Task Force, on the basis of which the Committee will continue its discussions on issues relating to the implementation of the United Nations Global Counter-Terrorism Strategy, bearing in mind General Assembly resolution [77/298](#) and information provided by the Executive Directorate on its work as an entity under the Global Counter-Terrorism Coordination Compact.

48. The Executive Directorate will assist the Committee, through its visits, assessments and analytical work on emerging issues, trends and developments, in supporting Member States and United Nations entities in taking measures, pursuant to international law, to address conditions conducive to terrorism and violent extremism as and when conducive to terrorism, in accordance with the United Nations Global Counter-Terrorism Strategy, in coordination with and with the support of the Office of Counter-Terrorism.

## **G. Promoting respect for human rights in the context of counter-terrorism**

49. The Executive Directorate will provide to the Committee, for its consideration, information regarding the effect of terrorism and counter-terrorism measures on children and children's rights, as appropriate, especially with regard to issues relating to the families of returning and relocating foreign terrorist fighters, as well as progress in the further development of activities in the area of promoting respect for human rights in the context of counter-terrorism in order to ensure that all human rights and rule of law issues relevant to the implementation of resolutions [1373 \(2001\)](#), [1624 \(2005\)](#) and [2178 \(2014\)](#) and other relevant resolutions, as called for by the Security Council in its resolution [2617 \(2021\)](#), are addressed as an important component of

the Executive Directorate's country visits, assessments and analysis of emerging issues, trends and developments, as well as its facilitation of technical assistance.

50. The Executive Directorate will provide to the Committee, for its consideration, information on its work to continue to integrate gender as a cross-cutting issue throughout its activities, including in country-specific assessments and reports, recommendations made to Member States, the facilitation of technical assistance to Member States and briefings to the Security Council, as well as its consultations with women and women's organizations to inform its work and, in collaboration with the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women), will conduct and gather gender-sensitive research and collect data on the drivers of radicalization to terrorism for women and the impact of counter-terrorism strategies on women's human rights and on women's organizations.

### **III. Implementing the revised communications strategy**

51. The Executive Directorate will submit to the Committee, for its consideration, suggestions to continue to implement the revised communications strategy aimed at promoting the visibility of the role and activities of the Committee and the Executive Directorate, including ways to maximize the impact of a range of products, such as the updated global surveys on the implementation by Member States of resolutions [1373 \(2001\)](#) and [1624 \(2005\)](#). In this regard, the Executive Directorate will support the Committee in paying special attention to: (a) advocacy and communication efforts pertaining to the continued implementation of recent resolutions; (b) special meetings and open briefings of the Committee; (c) high-level advocacy visits of the Committee, its Chair and the Executive Director of the Executive Directorate; and (d) efforts to counter violent extremism and incitement to violence, as called for by the Security Council in its resolutions [1624 \(2005\)](#) and [2178 \(2014\)](#).
