REPORT BY THE SECRETARY-GENERAL CONCERNING THE CREDENTIALS OF THE REPRESENTATIVES AND DEPUTY AND ALTERNATE REPRESENTATIVES OF THE MEMBERS OF THE SECURITY COUNCIL ELECTED FOR THE PERIOD 1983-1984

At its 36th meeting, on 19 October 1982, the General Assembly elected Malta, Netherlands, Nicaragua, Pakistan and Zimbabwe non-permanent members of the Security Council for a term of two years, beginning on 1 January 1983.

Pursuant to rule 15 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to report that, with regard to the representation of the members of the Security Council elected for the period 1983-1984, he has received the communications referred to hereunder.

Malta. In a telegram dated 21 December 1982, the Minister of Foreign Affairs of the Republic of Malta stated that Mr. Victor Gauci has been appointed representative of Malta on the Security Council and Mr. Saviour Borg has been appointed deputy representative.

In the opinion of the Secretary-General, this telegram constitutes adequate provisional credentials.

Netherlands. Credentials signed on 22 November 1982 by the Minister for Foreign Affairs of the Kingdom of the Netherlands state that Mr. Hugo Scheltema has been appointed representative of the Netherlands on the Security Council, that Mr. J. H. Meesman, Dr. P. M. Kurpershoek and Mr. R. H. Serry have been appointed deputy representatives and that Mr. J. E. Craanen and Mr. R. E. M. van Lanschot have been appointed alternate representatives.

In the opinion of the Secretary-General, these credentials are in order.

Nicaragua. In a letter dated 21 December 1982, the Foreign Minister of the Republic of Nicaragua stated that Mr. Victor Hugo Tinoco Fonseca, Deputy Foreign Minister, has been appointed representative of Nicaragua on the Security Council, that Mr. Francisco Javier Chamorro Mora has been appointed deputy representative and that Dr. Julio Icaza Gallard, Mrs. Daysi Moncada Bermudez, Mr. Jaime Hermida Castillo and Mr. Orlando Moncada Zapata have been appointed alternate representatives.

Mr. Qazi Shaukat Fareed, Mr. Javid Husain, Mr. Sajjad Ali and Mr. Riaz Mohammad Khan have been appointed alternate representatives.

In a letter dated 21 December 1982, the Permanent Representative of Zimbabwe to the United Nations stated that Mr. Stephen Cletus Chiketa has been appointed deputy representative of Zimbabwe on the Security Council and that Mr. Alban Taka Dete, Mr. Galilee Jess Jani and Mr. Nicholas Dhlamini Kitikiti have been appointed alternate representatives.
