**JOINT COMMUNIQUÉ ON
THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
THE COMMONWEALTH OF THE BAHAMAS
AND THE REPUBLIC OF BENIN**

The Government of the Commonwealth of The Bahamas and the Government of The Republic of Benin;

Willing to strengthen friendly relations and develop mutually beneficial cooperation in various fields;

Guided by the principles and purposes set forth in the Charter of the United Nations, in particular as regards friendly relations among Member States, the promotion of international peace and security, respect for equality, sovereignty, independence, territorial integrity and non-interference in the affairs of States;

Committed to establishing bilateral partnerships for the pursuit of sustainable development and willing to exchange experience and expertise in the field of resilience within this framework;

Have decided to establish diplomatic relations pursuant to the provisions of the 1961 Vienna Convention on Diplomatic Relations, with effect from the date of signature of this Joint Communiqué;

In witness whereof, the undersigned Representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in duplicate, in the English and French languages, all the texts being equally authentic.
