ANNOTATED PROVISIONAL AGENDA

1. <u>Relevant activities carried out or planned within the framework of the United Nations system in</u> relation to women in Latin America and the Caribbean since the seventh session of the Regional <u>Conference</u>

In the context of their mandates, the participating agencies will report on the following:

- (a) priority areas, subjects, approaches and strategies in the period since the last meeting;
- (b) gender mainstreaming in their organizations;
- (c) most important achievements and challenges pending, with special emphasis on institutional aspects and resources.
- 2. Preparations for the eighth session of the Regional Conference, to be held in Lima, Peru, from 8 to 10 February 2000, in relation to the issues of gender equity, human rights, and peace and violence, which were proposed for analysis by the Presiding Officers of the Regional Conference at their twenty-seventh meeting

The ECLAC secretariat will report on preparatory activities relating to the eighth Regional Conference.

In addition, ECLAC will present the general guidelines of the position paper it is preparing for the Conference, concerning the challenge of gender equity and human rights on the threshold of the twenty-first century. This document includes a consolidated analysis of the two issues to be addressed at the Conference, namely, gender equity, and human rights, peace and violence.

The participating organizations will report on the papers they will be presenting as inputs to the eighth Conference and on other supporting activities the governments of the region are carrying out in this area.

The participants will analyse and assess the circumstances surrounding preparatory activities and the main challenges and opportunities arising from the process. Particular attention will be given to an analysis of the participation of civil society.
