**JOINT COMMUNIQUÉ ON THE ESTABLISHMENT OF DIPLOMATIC  
RELATIONS BETWEEN THE FEDERATION OF SAINT CHRISTOPHER (SAINT  
KITTS) AND NEVIS AND THE REPUBLIC OF CABO VERDE**

**The Government of the Federation of Saint Christopher (Saint Kitts) and Nevis and the  
Government of the Republic of Cabo Verde**

Desirous to join efforts to develop bonds of friendship and cooperation in the areas of mutual  
interests between their countries and peoples;

Reaffirm their commitments to the principles and purposes of the United Nations Charter and  
of international law, including the sovereign equality of States, territorial integrity and non-  
interference in the internal affairs of States;

Convinced that the establishment of diplomatic relations corresponds to the interests of both  
countries, will further strengthen international peace and security, as well as the unity and  
specificity of the group of Small Island Developing States (SIDS) around their common  
challenges and vulnerabilities in pursue of sustainable development.

Have decided to establish diplomatic relations between them, in accordance with the  
provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date  
of the signing of this Joint Communiqué.

In witness thereof, the undersigned representatives, being duly authorized by their respective  
Governments, have signed this Joint Communiqué in two original copies in English and  
Portuguese, all texts being equally authentic.

Reafirmam seus compromissos com os princípios e propósitos da Carta das Nações Unidas e do direito internacional, incluindo a igualdade soberana dos Estados, a integridade territorial e a não ingerência nos assuntos internos dos Estados;

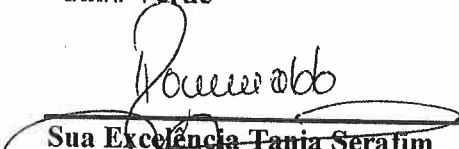
Convencidos de que o estabelecimento de relações diplomáticas corresponde aos interesses de ambos os países, fortalecerá ainda mais a paz e a segurança internacionais, bem como a unidade e a especificidade do grupo dos Pequenos Estados Insulares em Desenvolvimento (SIDS) em torno dos seus desafios e vulnerabilidades comuns em busca do desenvolvimento sustentável;

Decidiram estabelecer relações diplomáticas em conformidade com as disposições da Convenção de Viena sobre Relações Diplomáticas, de 18 de abril de 1961, a partir da data da assinatura deste Comunicado Conjunto.

Em fé do mesmo, os representantes abaixo assinados, devidamente autorizados pelos seus respectivos Governos, assinaram este Comunicado Conjunto em duas versões originais, em português e em inglês, sendo todos os textos igualmente autênticos.

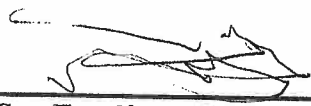
