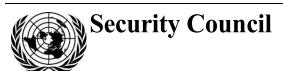

Letter dated 10 June 2024 from the Permanent Representative of the Sudan to the United Nations addressed to the President of the Security Council

I am writing to bring to your kind attention critical information regarding the ongoing war of aggression in the Sudan. Further to our previous correspondence to the Security Council about the support provided by the United Arab Emirates to the Rapid Support Forces' genocidal militia, in particular the letters dated 28 March (S/2024/276), 26 April (S/2024/345) and 6 May 2024 (S/2024/362), I attach herewith images of some weapons and military equipment seized by the Sudanese security authorities on the battlefield in Khartoum and Omdurman (see annex).


The attached photos provide detailed accounts of the types of weapons and equipment seized, including make and serial number. It has been established that all the seized items were sold to the army of the United Arab Emirates and subsequently ended up in the hands of the Rapid Support Forces in the Sudan. This transfer of arms constitutes a flagrant violation of international conventions, relevant Security Council resolutions and bilateral arms sale agreements that prohibit such illegal transfer to third parties.

These weapons have been instrumental in the savage armed operations of the Rapid Support Forces, which have led to grave violations against civilians in the Sudan, including heinous crimes and atrocities committed against women and children. The documentation also includes copies of Emirati and other nationalities' passports seized on the battlefield, evidence that further confirms the extent of Emirati involvement in perpetrating heinous crimes against innocent people in my country.

The Government of the Sudan urges the Security Council to take immediate and decisive action to address this grave violation of international law. We trust that the Council will act swiftly to uphold international peace and security and to protect the rights and lives of innocent Sudanese civilians, whom the Rapid Support Forces continue viciously to kill and attack, as happened recently in El Fasher; in the village of Wad al-Nurah, where more than 200 civilians were killed in cold blood; and in Omdurman and elsewhere in the White Nile villages.

I would be grateful if the present letter and its annex could be brought to the attention of the esteemed members of the Security Council and issued as a document of the Council.










(b) Remnants of Serbian-made rocket-propelled grenade shells, manufactured April 2023, serial No. 69-40.


























