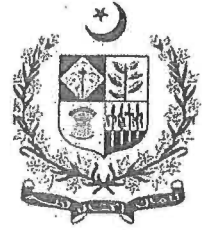

**JOINT COMMUNIQUE
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
SAINT LUCIA
AND
THE ISLAMIC REPUBLIC OF PAKISTAN**

28 May 2024

Saint Lucia and the Islamic Republic of Pakistan in keeping with the interests and desire between the peoples of two countries, have decided to establish diplomatic relations, effective from the date of signature of this communiqué.

The two Governments are desirous to enhance friendly relations between the two countries on the basis of the principles of mutual respect for sovereignty and territorial integrity, non-aggression, non-interference in each other's internal affairs, equality, mutual benefit and peaceful co-existence.

The Governments of Saint Lucia and the Islamic Republic of Pakistan have agreed to exchange Representatives as early as possible and to provide each other with all the necessary assistance for the establishment of diplomatic relations and their performance of function on a reciprocal basis in accordance with the Vienna Convention on Diplomatic Relations of 1961 and international customary practices.

The undersigned, being duly authorized by their respective Governments, signed this communiqué on 28th May 2024 in New York, in English.
