The Saint Vincent and the Grenadines and the Islamic Republic of Pakistan in keeping with the interests and desire between the peoples of two countries, have decided to establish diplomatic relations at the Ambassadorial level, effective from the date of signature of this communiqué.

The two Governments are desirous to enhance friendly relations between the two countries on the basis of the principles of mutual respect for sovereignty and territorial integrity, non-aggression, non-interference in each other's internal affairs, equality, mutual benefit and peaceful co-existence.




